In continuation of earlier NS dt. 13.06.2008 (copy enclosed), this is to state that during discussion with the Chairman it is learnt that the present Board of Jiaganj Azimganj Municipality has taken over the management of said Seva Sadan from the Dept. of Health & Family Welfare with effect from 16.02.2006.

The Municipality has started indoor facility with 20 beds with effect from 31.01.2007. The Municipality has arranged Specialised doctors in different branches of medicines and provide free treatment to the poor and collect user charges at a nominal rate of Rs. 20/- only from the affordable patients.

In order to strengthen the service facility of the Seva Sadan, support for procurement of some essential equipments for neo-natal unit, OT functioning, Surgical & Orthopaedics unit etc. have been sought by the Chairman. The list of Equipment along with tentative cost for an amount of Rs. 52.85 Lakh as submitted by the Chairman is enclosed. This is non-recurring type of one time grant.

The issue of strengthening Seva Sadan services may be considered for by the Department. Additionally, we may approach to the DHFW for assistance.
