**Sub. : Construction of 4 nos. of toilets for each of the 4 Sub-Centres under CBPHC - Chakdah Municipality.**

Enclosed the copy of communication of the Chairman, Chakdah Municipality bearing memo no. 1308(1)/CM dt. 03.11.2008 on the above mentioned subject along with estimated cost as per PWD schedule towards constructions of toilet for each Sub-Centre for total amount of Rs. 3,99,380/- (Rupees Three lakhs ninety nine thousand three hundred eighty) only @ Rs. 99,845/- per toilet. All the SCs are functioning from the existing community centre in ward no. 18, 6, 10 & 13 of Chakdah Municipality.

This is to mention here that the SC must have toilet as basic facility otherwise examination of pregnant women & children often faces difficulty. As we have fund for renovation, the toilet facility may be considered as renovation work of the existing SC located in the community hall.

It is to mention here that provision has been kept for renovation works for Rs. 42.30 lakhs, out of which Rs. 21.15 lakhs in 1<sup>st</sup> year and Rs. 21.15 lakhs in 2<sup>nd</sup> year.
