Sir ,

I would like to draw your kind attention to the following matters on the captioned subject .

That there were some vacancies in the post of sanitary inspector , computer Assistant , Multipurpose helper cum store keeper , clerk and Health Assistant in community based primary health care service of S.U.D.A in the Basirhat Municipality .

That with a view to filling up the vacancies the authority , Basirhat Municipality invited applications for the a fore – said postes vide their office memo no – 2212 dated 16.1.2008.

That I was called for an interview but no written test was held there insteat only viva –voce was Taken .

That later I came to know that the persons who have been appointed are either relatives of the existing Municipal staff or other wise related with the present Municipal authorities of Basirhat .

That the most amazing matter was the authority did neither route the matter through the Employment exchange nor they advertise in any leading news paper .Only notices were displayed in few office notice board .

That the intention of the authority is quite clear , they some how desired to appoint candidates according to their likings in a motivated way .

That the way the appointments were made was a clear violation of the guidelines as contemplated in order no –U.L.B-11 MA / C-



10/35-55/2005 of Municipal Affairs Department, govt of West Bengal .

It was learnt after wards that a complaint was lodged by Smt.Krishna Majumder . Ex Vice chair person & Standing Councillor in her letter dated 19.03.08 to Dr. Chhanda Sarkar , Director S.U.D.A in this instant issue of manuculation which is awaiting decision.

That the merit of the candidates were not judged avoiding the written test , only to give undue opporunities to related candidates . That the authority still has not got approval of the appointments but the employees are working still .

That the payment of the concerned employees were held up for few months .But , of late , I came to know that despite non-approval the authority has paid their salary from the Honorarium of honorary Health Workers which is another example of their irregular work

In the face of above , I most fervently pray to your kind end to look in to the matter , cause and enquiry & take proper action so that Genuine candidates like my self who have been eliminated through the plea of only oral test can get justice .

I have the honour to draw your kind attention to the subject matter captioned above and solicit your immediate intervention for redressal of the irregularities.

The interview committee for the selection of candidates to the posts of (1) Medical Officer, (2) Sanitary Inspector, (3) Computer Assistant, (4) Accounts Asst., (5) Helper-cum-store-keeper, (6) Health Assistant, has been constituted most illegally violating the guidelines framed by the Municipal affairs Dept. Govt. of West Bengal and directed to U.L.B.s vide Memo No.11 M/C-10/35-55/2005 for compliance.

And such illegally constituted interview committee has selected candidates on their own will. Even, it is reported that make-sheet of your representative has been changed, to their own sweet-will.

Perhaps, for all these reasons people of Basirhat are saying that there has been a big amount of under-hand-deal in the process of ~~selecting~~ selecting candidates.

In this circumstances may I request your good-self to investigate into the matter ~~and~~ immediately and not to give approval to the so call panel prepared by the so call interview committee in the public interest until the ~~investigation~~ investigation is over.

Only on the date of interview, that is, on February 7, 2008 my client after giving her interview (oral test) came to know that there will be no written test and she has given 300 marks oral interview.

Subsequently my client tried to know the details about the interview and from reliable source it came to her knowledge that interview was held in arbitrary manner without any set of questions for the examine and/or without following the procedure.

That my client has given several representation to you by informing the above situation and also informed you that the said chairman by using undue advantage of his chair appointed one of his favourite candidate namely Piali Majumder who is so called 1<sup>st</sup> standard candidate on the basis of a fabricated final Marksheet which does not bear the signature of the other members of the Selection Committee.



On June 28, 2008 the earlier Learned Advocate of my client sent a letter to the Chairman, Basirhat Municipality to give the result sheet of the said interview and the guidelines/rules framed for the said interview.

My client came to know about the result even before she received the said fabricated marksheet given by the Chairman and the source from which my client know about the said fraud, was very reliable.

In the facts and circumstances aforesaid I further request you to take immediate lawful step by canceling the so called appointment and also forward a copy of individual score sheet of the Selection Committee and the rules and regulation on the basis of which interview was held. I always expect you will take immediate step within 7 days of receipt of this demand notice otherwise I shall advise my client to take appropriate legal step by filing an application under Article 226 of the Constitution of Indian before the Hon'ble High Court. That there were some vacancies in the post of sanitary inspector , computer Assistant , Multipurpose helper cum store keeper , clerk and Health Assistant in community based primary health care service of S.U.D.A in the Basirhat Municipality .

That with a view to filling up the vacancies the authority , Basirhat Municipality invited applications for the a fore – said postes vide their office memo no – 2212 dated 16.1.2008.

That I was called for an interview but no written test was held there insteat only viva –voce was Taken .

That later I came to know that the persons who have been appointed are either relatives of the existing Municipal staff or other wise related with the present Municipal authorities of Basirhat .

That the most amazing matter was the authority did neither route the matter through the Employment exchange nor they advertise in any leading news paper .Only notices were displayed in few office notice board .

That the intention of the authority is quite clear , they some how desired to appoint candidates according to their likings in a motivated way .

That the way the appointments were made was a clear violation of the guidelines as contemplated in order no –U.L.B-11 MA / C-

10/35-55/2005 of Municipal Affairs Department, govt of West Bengal .

It was learnt after wards that a complaint was lodged by Smt. Krishna Majumder . Ex Vice chair person & Standing Councillor in her letter dated 19.03.08 to Dr. Chhanda Sarkar , Director S.U.D.A in this instant issue of manuculation which is awaiting decision.

That the merit of the candidates were not judged avoiding the written test , only to give unduc opporunities to related candidates .

That the authority still has not got approval of the appoinments but the employees are working still .

That the payment of the concerned employees were held up for few months .But , of late , I came to know that despite non-approval the authority has paid their salary from the Honorarium of honorary Health Workers which is another example of their irregular work

In the face of above , I most fervently pray to your kind end to look in to the matter , cause and enquiry & take proper action so that Genuine candidates like my self who have been eliminated through the plea of only oral test can get justice .
