

Sub. : Proposal of the Administrator, Buniadpur Municipality & SDO, Gangarampur regarding cleaning of garbage & IEC.

Placed herewith communication bearing no. 2296/II-30/B.P.M./2016(Part II) dt. 10.04.2017 of the Administrator, Buniadpur Municipality & SDO, Gangarampur with a request for sanction of Rs. 50.00 lakh for cleaning of garbage, IEC of Health Schemes.

In this context, this is to state that during FY 2016-17, fund for an amount of Rs. 7.68 lakh for the purpose had been released in the following components :

- 1) Ward-wise awareness / community mobilization @ Rs. 1,000/- per ward X No. of wards X 8 days.
- 2) Hiring of labour to sweep, clean drains, ponds etc. to collect solid waste @ 30 labour per ward per day X No. of wards X 8 days X Rs. 150/- per labour per day.
- 3) IEC @ Rs. 20,000/- for "D" category ULBs (Buniadpur is "D" category ULB).

UC for Rs. 7.68 lakhs is still pending from Buniadpur Municipality inspite of issuance of reminder letter.

Component-wise estimation of required fund by Buniadpur Municipality is not given in the proposal.

Under the circumstances stated above, decision w.r.t. proposal of the Administrator, Buniadpur Municipality is sought for.

Notes at pre page may kindly be seen whereas we have received a letter from administrator, Buniadpur Municipality for releasing fund under Special cleanliness drive programme. In this regard, it is to mention here that we have already released Rs. 13,52,22,000/- for this purpose in the F.Y 2016-17 and 2017-18 (for Domkol) out of which we have received Rs. 7,93,38,000/- (2,69,04,000/- + 5,24,34,000/-) from Dept of UD & MA, making a shortfall of Rs. 5,58,84,000/- which is yet to be received from department. In view of that, we may write to department to release of this afore mentioned fund so that it may be replenished to CBPHCS fund where from it was initially released.

Within this time span, we have received a communication bearing no. 3240/II-30/BPM/2016(Pt.-II) dt. 27.04.2017 from Buniadpur Municipality for releasing fund under the same head as mentioned above and considering the urgency, we may follow the same fund release procedure as observed previously.

Now, it is proposed to release fund to Buniadpur Municipality for Rs. 50,00,000/-, out of CBPHCS fund as interim arrangement, which may be replenished as and when fund is available from Department of UD & MA.
