We had informed the Department for undertaking the matter on extension of CBPHCS and HHW Scheme for further period of one year w.e.f. 01.04.2013 with the Health & FW Department vide this office communication no. SUDA-Health/71/08/319 dt. 07.02.2013 (at flag - A). Following to that the Department has requested the Principal Secretary, Dept. of Health & FW for such extension of both the Programmes vide communication no. 236-MA/C-10/3S-45/2007 dt. 13.03.2013 (at flag - B). Health Wing, SUDA is in regular contact with the respective officials of DHFW for obtaining the extension order. It is learnt that the file for the purpose has been sent by the Health Department to the office of Hon'ble Chief Minister for approval. It is gathered that the said file has not yet been returned to the Health Department. As a result, extension of both the Programmes remain still pending. Everyday a number of ULBs are making contact with Health Wing, SUDA for getting approval order for extension, in absence of which Health Workers are facing administrative difficulties.

Under the circumstances stated above, the Department of Municipal Affairs may be requested to take up the matter with the Health & FW Department.

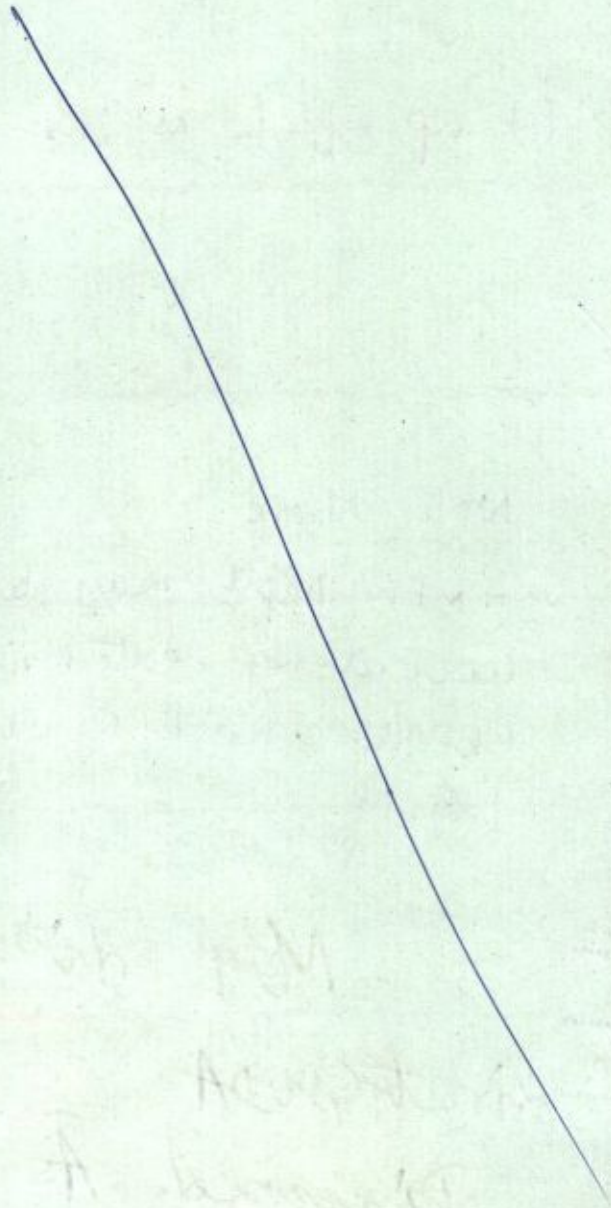
