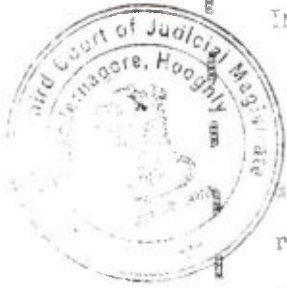

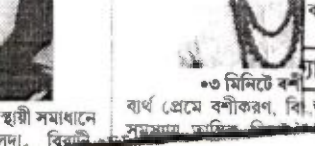

- Maintaining records, registers,
- Assist in conduct of immunization, ANC / PNC clinic, general treatment clinic,
- Level of capacity for motivational work,
- Possession of leadership quality.
