

Sub: Enlistment of Skill Training providers under DAY-NULM

Since inception of NULM programme a number of Skill Training Providers (STPs) were submitted their documents to this office and also to the office of Hon'ble MIC for empanelment time to time. Proposals of enlistment received so far are put up for your kind perusal.

- In first operational guidelines of NULM programme there was an instruction to conduct RFP (request for proposal) for empanelment of new Skill Training Provider (point-5) for Skill Training (flagged-X). Accordingly a selection committee was formed under the chairmanship of Joint Secretary, M.A. Department for selection of Training Institute. Based on the decision of the said committee a two bid tender was floated on July, 2015 for empanelment of skill training providers. All STPs referred by our department were informed to participate in that tender process. In the mid-way of selection the tendering process was cancelled due to Common Norms of Skill Training introduced by Govt. of India.

- Time to time the operational guidelines has been changed. In GOI memo no. K-14014/3/2015-UPA/FTS 12523 dt. 18/02/2016(flagged-Y) there is some amended option for enlistment of STPs. Clause 5.1(i to iv) may kindly be seen.

- In the meeting of the Committee for Selection of Training Institute dt. 14/07/2016 it was decided to float a fresh RFP for empanelment of STP at WBSULM(flagged-Z)

- Further, it is pertinent to mention here that our neighbouring States Orissa, Jharkhand, Assam, Uttar Pradesh were conducted RFPs for selection of NSDC/non NSDC Skill Training Providers(STPs) for EST&P training under DAY-NULM programme.

For selection of new Skill Training Provider the file is submitted for policy decision.

To float a fresh RFP necessary rectification in previous RFP is under process.

Before floating of RFP following points may kindly be perused.

- After cancellation of previous RFP for selection of Skill Training Providers(STPs) it was decided in the 8th meeting of the **Committee for Selection of Training Institute/Resource Organisation /Certification Agencies/Institute** on 14/07/2016 that to float fresh RFP to empanel the STPs at WBSULM. Minutes of the committee is placed in CP side(flagged-X).
- In absence of Advisor, SUDA at the present the committee may be reconstituted or may continue with six members out of seven.
- As per common norms of Skill Training the course fee is fixed as hourly basis. The training category wise rate per hour is fixed by GOI. Thus, cost of training course to be same to all selected STPs. Accordingly, the RFP bidding process may follow only Single Bid (Technical Bid) tendering process.
- Further, if TET & SD Deptt. will not take the responsibility of assessment and certification of fresh candidates of EST&P training then this office has to finalise the certification agency with payment procedure.

As the stated committee is still exists the aforesaid issues may be raised in a meeting to resolve.
