Online MIS is part and parcel of NULM programme. As suggested by MoHUPA a two days hand on training for the IT Coordinator/AFC, APO/CO on Web-based MIS & MPR training was organized by WBSULM in three phases for NULM towns, i.e. i) 18th & 19th November, 2014, ii) 10th -11th and iii) 12th -13th February, 2015. Afterwards, this office has requested MoHUPA for clearance of dummy data and rectification in data base in the dedicated site of NULM i.e. NULM.gov.in.



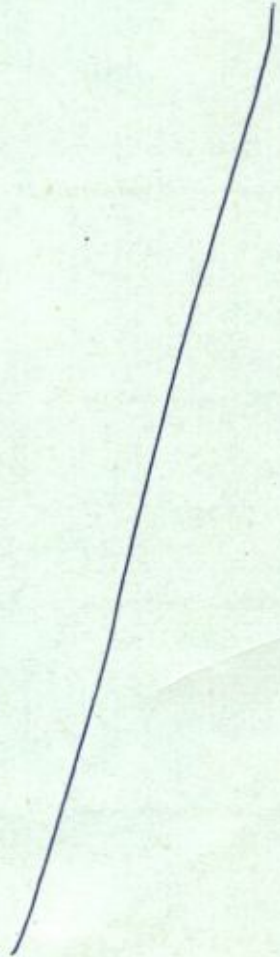
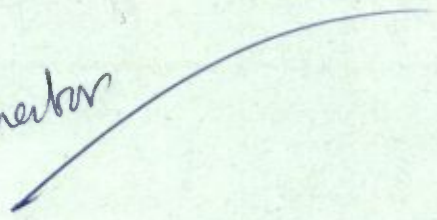
