Sub : Remuneration of one CO has not been disbursed from your end

Madam,

As you are aware of the fact that in the year 1997, all the ULB(s) of West Bengal were directed to appoint TPO & CO vide Memo No. 850/C-10/35-24/97 dated 11.09.1997, issued from Department of Municipal Affairs, Govt. of West Bengal. Through that notification, ULB(s) were directed to appoint one CO for every 4000 BPL households. In response to that, this ULB also appointed CO(s) observing all formalities as per the said notification. At that moment, as this ULB had BPL households around 21000, five CO(s), one for every 4000 BPL households, were appointed at a time vide Memo No. 62(10)/SJSRY/XII-6 dated on 30.08.1999. Since then, these five CO(s) have been in service continuously.

This is also for your kind information that during the year 2006-2008, when 50% of the enhanced remuneration of the CO(s) was met from your end, our ULB used to receive the amount for five CO(s).

Now, it has been seen since the last six months, full remuneration for the CO(s) is being disbursed from your end. But, unfortunately, we have got amount for four CO(s) vide Memo No. SUDA-131/2010/1047 dated 27.05.2010 & Memo No. SUDA-131/2010/1551(95) dated 16.08.2010.

This is not at all clear to us. This ULB has five CO(s) since 1999 of whom appointments were made as per govt. notification vide Memo No. 850/C-10/35-24/97 dated on 11.09.1997, issued from Department of Municipal Affairs, Govt. of West Bengal. But, we are getting remuneration for four CO(s). Therefore, extra fund for another CO's remuneration may kindly be sanctioned and remitted.

No. 850/C-10/35-24/97 Dated, Calcutta, the 11th September, 1997.

In pursuance of the guidelines of the Government of India for implementation of 'Urban Basic Services for the Poor' a Centrally Sponsored Scheme, the Governor is hereby pleased to frame the following revised Recruitment Regulations for Town Project Officer and Community Organiser for proper implementation of the scheme :

RECRUITMENT REGULATIONS FOR TOWN PROJECT OFFICER AND COMMUNITY ORGANISER:

A municipality implementing the scheme of Urban Basic Services for the Poor (UBSP) shall appoint a Town Project Officer (TPO) and Community Organisers (CO). The norm for determining the number of Community Organisers to be appointed may be taken as : One Community Organiser for every 2000 Beneficiary Household (BH). The recruitment regulations for Town Project Officer and Community Organiser are given below :-

RECRUITMENT REGULATIONS :

A. TOWN PROJECT OFFICER (TPO) :

- a) Educational Qualification : A Bachelor Degree in any discipline, preferably in Social Science subjects.
- b) Experience : At least 3 years' experience in organising community development, social development etc. activities in low income neighbourhoods.
- c) Age : Between 25 and 40 years.
- d) Remuneration : Rs.4,000/- (consolidated) for towns having population below 60,000 (1991-Census) and Rs.4,500/- (consolidated) for towns having population above 60,000 (1991-Census).

Alternatively, the posts could also be filled up by deputation of officers from State Government, Government Undertakings and Non-Government Organisations. In case of officers coming on deputation, the following criteria for appointment to the post of Town Project Officer should be fulfilled :

- a) Educational Qualification : A Bachelor Degree in any discipline.
- b) Experience : Aptitude and experience in organising community development work.
- c) Age : Less than 45 years.
- d) Remuneration : Drawing scale of pay not below that enjoyed by Section Officers in the State Government Secretariat.

In case attempts to fill up the posts of Town Project Officers through direct recruitment or deputation fail, the same could be filled up by appointment of superannuated officers of the State Government on contract basis. In case of appointment of such superannuated officers, the remuneration shall be the difference between the last pay drawn by the said officer and his pension. The terms of such appointment shall be 6 months or a 1 year.

B. COMMUNITY ORGANISER :

- a) Educational Qualification : A Bachelor Degree, preferably in Sociology/social works or any other branch of social science.
- b) Experience : Experience is not an essential requirement. However, experience in Urban Community Development work will be preferred.
- c) Age : Between 25 and 35 years.
- d) Remuneration : A consolidated amount of Rs. 2,000/- per month.

Only those having residence in the municipal area concerned will be eligible for consideration. Preference will be given to eligible women candidates. ULD should request the Employment Exchange the 'local' candidates only as per the recruitment guidelines within a given time.

SELECTION PROCEDURE FOR RECRUITMENT :

List of candidates shall be obtained from Local or Regional Employment Exchange. If the Employment Exchange is unable to provide local candidates or could forward their names in insufficient numbers only, then applications may be invited by ULD by means of advertisement in leading newspapers including local papers. ULD should consider all such candidates on merit in the Selection Committee.

For selection of candidates, two selection committees - one for selection of TOWN PROJECT OFFICERS and the other for selection of COMMUNITY ORGANISERS - shall be constituted by the municipality with the following :

FOR TOWN PROJECT OFFICER :

- i) An officer of the Department of Municipal Affairs as nominated by the Secretary of the Department;
- ii) Nominee of Director & Chief Executive, State Urban Development Agency.
- iii) Project Officer, District Urban Development Agency;
- iv) The Councilor-in-charge of UPA Cell of the municipality;
- v) Chairman of the municipality (Convener).

NOTE : Chairperson of the Committee shall be decided by the members from among themselves.

FOR COMMUNITY ORGANISERS :

- i) // Nominee of Director & Chief Executive, State Urban Development Agency.
- ii) // Project Officer, District Urban Development Agency;
- iii) // The Councilor-in-charge of UPA Cell of the municipality;
- iv) // Chairman of the municipality (Chairperson).

In the interest of immediate implementation of the programme the posts of TOWN PROJECT OFFICER and COMMUNITY OFFICERS may be filled up, on ad-hoc basis, pending selection of suitable candidates, in the manner stated below:

FOR TOWN PROJECT OFFICER :

An employee of the municipality drawing salary in a scale of pay not below that of a Section Officer of the Secretariat and otherwise suitable may be appointed on the recommendation of the selection Committee. Such an employee may be allowed a special pay of Rs. 150/- per month.



OF COMMUNITY ORGANISER :

An employee of the municipality drawing salary in the scale of pay not below that of a Lower Division Assistant and otherwise suitable may be appointed on the recommendation of the Selection Committee. Such an employee may be allowed a special pay of Rs. 100/- per month.

The above ad-hoc appointments shall not exceed six months from the date of appointment.

The posts will be programme specific and therefore purely on temporary basis. If the programme is discontinued, sanction to the creation of these posts and appointment thereto shall also stand cancelled. This is in cancellation of previous Notification No. 406/C-10/3S-24/97 dated 7.5.97.

In reference to your letter quoted under reference in the matter noted in the subject, the following facts are stated for your kind perusal:

1. As per the notification of Municipal Affair Department of Govt. of West Bengal under Memo No.850/C-10/35-24/97 dated 11.9.1997, it appears that one Community Organizer is to be appointed for each 4000 BPL households. In response to that notification, five Community Organizers were engaged in 1999, following all proper rules & regulations, as the recorded BPL households were 20763 at that time.

It was reported under this office Memo No.185/SJSRY/XII-6 dated 24.9.2010 (Copy enclosed).

2. Since then, five Community Organizers have been working till today in their respective area within the Municipality boundary (map demarking the CDS enclosed).
3. In fact, we were in a process to register five CDS(s) for five community organizers. Accordingly, we registered three CDS(s) in the year 2000. Then we applied before The Registrar of Societies for the registration of 4th & 5th CDS. In the year 2004, we got registration of the 4th CDS from the said office. But unfortunately, registration of the 5th CDS was not received.
4. Be it mentioned here that in the 1st page of each MIS report this ULB has five Community Organizers but not five CDS(s). During the years 1999 to 2005, following the instruction of SUDA, remuneration of five Community Organizers was given from the fund A & OE of SJSRY allotments.

And during the years 2006 to 2008, 50 % of the enhanced remuneration was disbursed from your end against the name of these five Community Organizers.

Next from the year 2008 to 2010, remuneration of the Community Organizers was again given from A & OE fund of SJSRY allotments. For making the payment of remuneration of five Community Organizers in a continuous process from the allotted fund since 1999, the matter of registration of the 5th CDS was left unattended.

But, from April – 2010, SUDA started to send remuneration through Demand Draft instead of allotting A & OE fund. Then the remuneration of one Community Organizer in respect of 5th CDS was stopped for having no registration of the same.

5. However, the person associated with the 5th CDS has been performing sincerely since joining with the satisfaction of Board of Councillors. The up-to date cumulative achievements of the 5th Community Organizer is as follows :

You may appreciate that the State of West Bengal had successfully implemented SJSRY project and now under implementation of NULM which has been restructured from earlier SJSRY. Contribution of key officials at ULB level like Town Project Officer (TPO) and Community Organizers (CO) engaged in SJSRY was one of the major factor for such success. TPOs and Cos etc were only designated work force at ULB level to implement the scheme and in our state the implementation of SJSRY and its day to day monitoring was done mostly by TPOs and Cos as there were no provisions of Specialist / Experts in SJSRY unlike NULM.

In NULM guideline engagement of different manpowers have been proposed at ULB level. City Project Officers are the pivot point of NULM implementation at city level. In our state Commissioner/ Jt. Commissioner of Municipal Corporation and Executive Officer (in Municipality) have been designated as City Project Officer in addition for their day to day other multi-various jobs. It is need less to mention that Commissioner/ Jt. Commissioner/ Executive officer being the principal officer of Municipality establishment has to look after each & every function of a city. Hence additional manpower support to City Project officer to look after NULM function within the city is very much essential.

Total 25 Town Project Officers who were working in different NULM cities have been re- designated as Asst Project Officer Vide order no763/MA/P/C-10/35-30/2013 dt 17.11.2014 Govt of West Bengal. Proposal for engagement of rest 38 Asst Project officer have been made to State Government in the Municipal Affairs Department after due recommendation from State level Manpower Selection Committee.



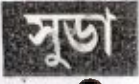
