

**Remuneration of existing TPOs & COs in NULM towns
for the quarter April,2014 - June,2014**

The 1st phase of implementation of NULM programme embracing 62 towns in the state is scheduled to begin from 01.04.2014 onwards. The required institutional support structure, as suggested in the programme guidelines hence needs to be in place in the implementing towns for proper programme delivery within a specified time period. As per NULM guidelines, City Mission Management Unit (CMMU) is to be created in each NULM city/town and to be managed by a City Project Officer (CPO) who will be assisted by one or more Assistant Project Officers (APO)/ COs and a team of functional specialists in the field of social mobilisation, institution & capacity building, micro-finance, livelihood/micro-enterprises etc. While formation of CMMU and engagement of functional specialists are expected to take some time, the groundwork for the programme needs to start right from the date of commencement of NULM implementation since, the State has been loaded with a huge target by Govt. of India in the NULM Annual Action Plan of 2014-15. The 'Social Mobilisation & Institution Development' component of NULM is vitally important in the initial stages of programme implementation. The existing TPOs/COs who are well aware of the prevailing ground realities are expected to play an important role in implementation of this component. Besides, engagement of professionals/ experts in the implementing towns is likely to take some time because of the ensuing General Elections & completion of other formalities during which services of TPOs/COs will be the only resource available to the towns to carry forward the message of NULM to the community and mobilise them into the programme by remaining in constant touch with them.

In view of the key roles that the existing TPOs/ COs are expected to play in the initial stages of NULM implementation, it is suggested that TPO/COs engaged in the NULM towns is retained and monthly remuneration for the period April - June,2014 is released for them from this end at the rate that was paid to them under SJSRY. The entire amount payable in this respect may be paid out of A&OE component of SUDA which will be later on replenished after allotment under NULM is received from Govt. of India. For ready reference, the detailed proposal sent to M.A.Department for approval in respect of several key areas of implementation is placed in file (Flag-'X').

The position of the existing TPOs / COs is shown in the following table. A sum of Rs.6,00,000/- (Rupees six lakh) only towards remuneration of 25 nos. of TPOs and Rs.21,60,000/- (rupees twenty one lakh sixty thousand) only towards remuneration of 144 nos. of COs for the period from April - June,2014 is recommended for release together amounting to Rs.27,60,000/- (rupees twenty seven lakh sixty thousand) only is recommended for release towards remuneration of TPOs & COs.




The National Urban Livelihood Mission (NULM) is about to set in for 62 Urban Local Bodies (ULBs) in place of SJSRY as mentioned in the note of Advisor. The NULM has no provision for TPO as in the SJSRY. However, in terms of guidelines of NULM there would be City Mission Management Unit (CMMU) is to be formed for each ULBs covered under NULM. One City Project Officer would be at the helm of each CMMU who will be assisted by the Assistant Programme Manager and other field functionaries including Community Organisers in commensurate with the objectives & goal of the Mission.

Since the formation of CMMU is yet to turn up owing to some unavoidable reasons, we may contemplate utilising the service of expertise of existing T.P.Os and C.Os without changing the nomenclature of the designation of T.P.O and terms and conditions of the respective contractual appointment in the new programme especially during transitional period.

If agreed, we may release the contractual remuneration to the T.P.Os and C.Os at the present rate for 1st quarter of the next financial year. The total amount is to be released ₹27,60,000/- (**Rupees twenty seven lakhs sixty thousand**) only for existing 25 numbers T.P.Os and 144 numbers C.Os. Detailed calculation in this regard has been given by the Advisor in the forgoing note.

Incidentally, it may be mentioned that fund under NULM is yet to received we may provide the fund from A & O E of SUDA for the ti being pending approval for absorption of existing T.P.Os and C.O commensurate posts.
