

- 1. 10-20 Members (for hills or any other hard to reach area or particularly vulnerable groups like persons with disabilities etc., the number of members under one SHG may be minimum 5) of deprived families (as defined by the State Govt.) coming together with a common aim of involvement in an income generation activity with thrift & credit activities.
- 2. The Group should open a Savings Account with any Public Sector Bank/Scheduled Commercial Bank.
- 3. There should be periodic intra group meetings (which have to be duly recorded) of the members as a proof of cohesion and discipline, at least once in a month.
- 4. Not more than one member from each household (family) may be in the same SHG.
- 5. Each member should be from the same ward/hamlet as far as possible.
- 6. A system of Registration of SHGs is proposed where all SHGs may be registered on a common portal and a unique number may be assigned after registration. Existing SHGs may be registered after collecting data from concerned departments. Fresh registration of new SHGs may be quickly done using the same portal.
- 7. Higher tier SHG federations maybe organized at Gram Panchayat/ward level. Block/Municipal level.
- 8. SHGs practicing the five good practices namely (i) Regular Meetings (ii) Regular Savings (iii) Regular Inter-Lending (iv) Regular Repayment (v) Regular Record Keeping for six months since formation may be considered as eligible for registration under Swasthya Sathi.

# The process are being followed by SUDA for formation, registration and support to SHGs

#### 1. Average Strength of the Group:

SHGs are groups of 10 to 20 women who come together to improve their living conditions by group savings and loans. Normally there is an average of 12 to 15 members in a SHG.

#### 2. Methodology for formation of SHGs:

Under NULM, Self-Help Groups of urban poor will be formed. However, at least 70% of the SHG members should be urban poor to qualify for funding support under NULM. SHGs may consist of 10 to 20 members. These groups need not be registered. Normally, women SHGs will be formed; however male SHGs of handicapped persons will be allowed to be formed.

Our state has defined Urban Poor as the urban BPL population of our state. Therefore, for formation of SHG the ULB should take 70% BPL from Urban BPL population list and rest 30% from the "Khadya Sathi" list for funding support under NULM.

#### 3. Bank Account in the name of the SHGs:

As per the bye laws of the SHG will open a Savings account in their name in a Bank Branch nearby to their resident.

#### 4. Thrift & Credit functions:

As per the bye laws of the SHG the members are deposit their savings amount in the group meeting. The SHGs may use the fund for lending to the members of the SHGs. After 3 months of formation the eligible SHGs are entitled to get a grant of Rs.10000/-per SHGs from NULM programme.

#### 5. Infrastructure/Input or credit support

If the SHGs are maintaining "Panchasutra" and the credit requirements of the members increase during 6 month of formation of SHGs then after grading the eligible Self Help Group may approach to a bank for loan. With a view to provide access to credit at affordable rate of interest to the urban poor, NULM will provide interest subsidy for SHGs accessing bank loan. The interest subsidy will be the difference between the prevailing rate of interest charged by the bank and 7% per annum, on all loans to SHGs of urban poor. An additional 3 percent interest subvention will be provided to all Women SHGs (WSHGs) who repay their loan in time. The Interest subsidy will be subject to timely repayment of the loan (as per the loan repayment schedule) and suitable certification obtained from banks by the ULB. The additional 3% interest subvention amount will be reimbursed to the eligible WSHGs. As per guideline the SHGs and their federations are not getting any infrastructural support from the programme.



# Minutes of the Meeting for fixing eligibility of newly created SHGs for enrolment under Swasthya Sathi held on 12.11.2018 in SHG&SE Department

The meeting started with Principal Secretary, SHG&SE Department in the Chair. Representatives of UD&MA, Cooperation, Forest and Fisheries Departments were present and the representatives from P&RD and MA&ME Departments could not remain present.

The purpose of the meeting (to fix the eligibility criteria of extending the Swasthya Sathi benefits to newly formed SHGs) was explained to the participants. During the discussions it was learnt that large portion of eligible population is still outside the purview of SHGs apart from the existing registered SHGs not being covered under Swasthya Sathi. It was felt that efforts should be made to cover the uncovered SHGs in the pioneering scheme of state government.

To evolve the standard protocol for formation, registration and support of SHGs it was felt that SHG&SE Department may formulate a common policy for the same which could be based on the following commonalities in the existing processes being followed by different departments.

- 1. Average strength of group i.e. 10-15 members.
- 2. Bank account in the name of the SHG.
- 3. Thrift & credit functions.
- 4. Infrastructure/Input or credit support.

The policy would also prescribe the timeline/achievement level of the group for it to be considered eligible for Swasthya Sathi and other benefits.

It was also decided that a committee comprising of representatives from various departments and experts may be formed for evolving the common policy. This committee could also suggest the activities where SHGs could be used by different deptt.

All the departments were requested to inform, in brief, the process being followed by them for formation, registration and support to SHGs.

These reports may be sent by the departments by 24th November, 2018.

The next meeting would be held on 3rd December, 2018 at 4.00 P.M.
