Interest subvention is a financial benefit which is given to the eligible SEP Loan beneficiaries under NULM. As per the SEP guideline the bank branches would submit the interest subvention claim to the ULBs in a prescribed format as guided by RBI. After that the ULBs were releasing interest subvention amount to beneficiaries. But it was observed that in most of the cases the Branches are reluctant to submit claim to the ULBs. As a result the beneficiaries were being deprived of their entitlement.

To resolve the issues, GOI has signed a MOU with the Allahabad Bank. Allahabad Bank has prepared a 'Portal for Affordable Credit and Interest Subvention Access' which is known as 'PAiSA' portal. The portal has been operating for releasing interest subvention from 1st April, 2018. In the first phase all public and private Sector banks were on boarded.

In the second phase the GOI has already been on boarded 3(three) Regional Rural Banks (RRBs) namely Bangiya Gramin Vikash Bank (BGBV), Uttar Bangiya Kshtriya Gramin Bank (UBKGB) and Paschim Banga Gramin Bank (PBGB).

MOHUA organised a VC with RRBs on PAiSA Portal on 26th June, 2019 from 2:30 P.M the BGBV and UBKGB bank attended the VC from NIC Murshidabad, Coochbehar respectively. The PBGB was participated at the training from 'NAGARAYAN'.

The pilot of on boarding of RRBs and release of interest subvention has already started at Jharkhand, Rajasthan and Chhattishgrah. At the beginning of the training these states were sharing their experiences. From the discussion it is observed that the RRBs are enjoying the system to disburse the Interest subvention to the SEP beneficiaries under NULM.

GOI has given a demo user id and password to all participants RRBs for imparting hand holding training on the PAiSA portal.

In the training it was clearly mentioned that the RRBs will get time from 1st to 15th of every month for uploading master data in the portal and from 16th to 25th of every month for uploading claim data in the portal.

All the technicalities of PAiSA portal were clearly described by Mayank Mishra, NMM, NULM and Mr. Sunil Kumar from Allahabad Bank.

The RRBs of our state have received the User id for the PAiSA portal. It is advised to all RRBs to upload the master data and claim data in PAiSA portal from July, 2019.

The RRBs of our state have clarified their own views.
