Sir/ Madam,

Apropos the captioned subject, we have received reports from Barrackpore Municipality; North Barrackpore Municipality and Kolkata Municipal Corporation regarding non co-operation of some branches with the Self Help Groups.

- (1) The earlier Branch Manager of State Bank of India, Anandapuri Branch, Barrackpore apparently was not aware about the process of SHG credit linkage. At the same time, the present Manager is completely reluctant about the linkage of SHGs.
The Manager of Barrackpore Branch formally communicated vide letter no BKP/2019-20/30 dated on 13/05/2019 (copy enclosed) to North Barrackpore Municipality that the loan proposal submitted to CPC (SMECC, Bidhannagar) for sanction of the same but the said office have returned the proposal. Because there are no such operational guideline for disbursement of SHG loan from SME centre for the linked branches. As a result the SHGs are being deprived of any credit linkage.
- (2) The SHGs of Barrackpore Municipality having their saving bank account at the Railway branch of SBI your bank. In this branch the manager has clearly informed the representatives of Municipality that he will not process the SHG loan applications until anandapuri branch disburse loan to SHGs.
- (3) The State Bank of India, Kudghat branch is insisting the SHGs to submit a registration certificate for opening their savings bank account. The SHG is a informal institution of poor women of urban households. The branch is refusing to open the account of SHGs.

Immediate intervention is requested to resolve the issues mentioned above.





In respect to the cited subject we would like to state the following points:

1. United Bank of India Anandapur Branch and Allahabad Bank Park Circus Bank in respect of SEP I Loan, are requiring quotation for the products they are to purchase and will only issue cheque in favour of the vendors who are also providing bills with GST. Now, the Members who had applied for the loans are purchasing their raw products from Burabazar Market who does not provide any GST bills. So, the loans remains not disbursed inspite of repeated persuasion.
2. State Bank of India Kudghat Branch is resistant in opening the savings account of SHGs without registration certificate of all the SHGs.
3. UBI Garden reach and Allahabad garden reach Branch is not willing to open the SHG account as they are having the concept of Rural Groups and are ignorant about Urban SHGs.

We submitted 5 (FIVE) No of SHG Credit linkage Applications to **SBI, Anandapuri Branch** Via 14/SJSRY/NULM/18-19/558 (1) dated 29.08.2018, Via 14/SJSRY/NULM/16-17/901 (1) dated 02.12.2017, 14/SJSRY/NULM/16-17/1049 (1) dated 03.03.2017 but recently the SBI Branch Manager informed us that this branch has no authority for sanctioning of SHG Credit linkage, though the SHG members have fulfilled all conditions as demanded by the bank's staff. Now they are giving aforesaid reasons for not approving the Credit Linkage.

It is stated further that this office has submitted 4 (Four) No of SHG Credit Linkage applications Via 14/SJSRY/NULM/16-17/1057 (1) dated 04.03.2017 to **SBI, Railway Branch** but the Manager of the said branch is also stressing as the Anandapuri Branch version regarding credit linkage though SHG members have fulfilled all conditions as demanded by the bank's staff. For such non cooperation, our NULM Department may not reach the target 19-20 FY.

Now in this condition this office has decided transfer fund of all SBI accounts to the HDFC Bank, Barrackpore Branch. In view of the same kindly guide us regarding such stated transfer of fund.

I request you to take necessary action as soon as possible.
