WHEREAS the Ministry of Housing and Urban Poverty Alleviation, Government of India, has restructured 'Swarna Jayanti Sahari Rojgar Yojana' as 'National Urban Livelihoods Mission', (herein referred as NULM), in order to widen the scope for reducing poverty by enabling urban poor households to access gainful self employment and skilled wages employment opportunity resulting in appreciable improvement in their livelihoods on a sustainable basis, through building strong grass root level institutions of the poor, such as 'Self Help Groups' (SHG) and their higher level federations;

AND WHEREAS the programme envisages implementation of the programme by setting up of dedicated and sensitive support structures at, inter alia, State and City/town levels;

AND WHEREAS as per guidelines of NULM circulated by the Ministry of Housing and Urban Poverty Alleviation, Government of India, the State Government to constitute State Level Mission to identify / constitute a state Level Autonomous Body under the State Government for implementation of all activities/related to NULM in the state and for receiving the fund under the said programme from the Ministry of Housing and Urban Poverty Alleviation, Government of India and also from the State Government and other sources and to designate an officer for this purpose.

NOW, THEREFORE, the Governor is pleased hereby to

- (a) Constitute West Bengal State Urban Livelihoods Mission (herein referred as WBSULM), by replacing 'Swarna Jayanti Sahari Rojgar Yojana' in the Municipal towns having population of 1 lakh or more and the District Headquarters with a population of less than 1 lakh (as per 2011 population).

- (b) Designate the State Urban Development Agency (SUDA), a registered society constituted and presently looked after SJSRY Programme, as the State Level Mission Management Unit (hereinafter referred as SLMMU) for coordinating the implementation and activities of WBSULM;
- (c) The Director, State Urban Development Agency will act as the Mission Director of State Level Mission Management Unit (SLMMU).

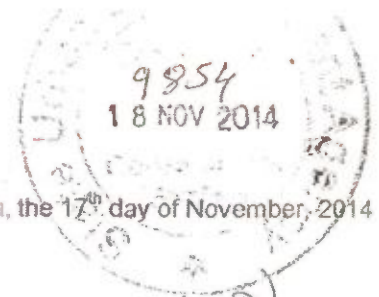

- (a) Contractual monthly remuneration for each post will be Rs. 50,000/- (Rupees fifty thousand only) with each engagement period of maximum two years at a time along with the provision of subsequent renewal after every one year based on satisfactory performance appraisal along with enhancement.
- (b) The upper age limit of the specialists/experts to be engaged in CMMU will be 40 years as on 01.04.2014 until further order.
- (c) Process of engagement of specialists/experts either through direct recruitment or by outsourcing through an agency to be taken up in consultation with the City Level Selection Committee constituted for the purpose. In case of outsourcing, draft Expression of Interest (EoI) to be circulated to all concerned ULBs from the end of SUDA, after the same is approved by the State Government.

E-tendering was made mandatory for tender/auction valued at and above Rs.50 lakh with option to the Government offices to adopt e-tendering procedure for values less than Rs.50 lakh. While detailed e-tendering procedure was prescribed in notification No.3739-F(Y) dt. 03.05.2012, the mandatory provision of e-tendering was included in Note-2 below Rule 47(8) of WBFR, as amended vide notification No.5400-F(Y) dt. 25.06.2012. Help-desks were set up for the Government offices to facilitate adoption of e-tendering procedure vide memo . No. 9701-F(Y) dated 30.11.2012. All these measures while reducing the hassles involved in manual tendering process and cutting down the time involved in finalisation of bids and contracts has brought about much needed financial probity and transparency in Government procurement. 1. Order to be issued by ULB constituting the selection committee after approval of the same in the meeting of BOC.
2. First meeting of City Level Selection Committee must contain :-
 - a) Procedure for selection of expert i.e either written test followed by Viva voce or Viva-voce only. No walk in interview allowed as it does not hold the scope of verifying eligibility before viva-voce.
3. Consecutive meeting to be convened to finalize the dates, procedure to be adopted for application, test/ viva voce and other related activities.
4. Date of meeting to be finalized in consultation with DLB/ SUDA/ MED representative (copy enclosed).
5. The attendance sheet and resolution of CLSC meeting should be there with authentication of Commissioner/ Executive Officer for every CLSC meeting.
6. The selection of news papers alongwith other modes of advertisement (Municipal website, Departmental website) will be decided in CLSC meeting.
7. The duration of receiving application will also be decided in CLSC meeting (minimum 15 days).
8. The detail advertisement must contain

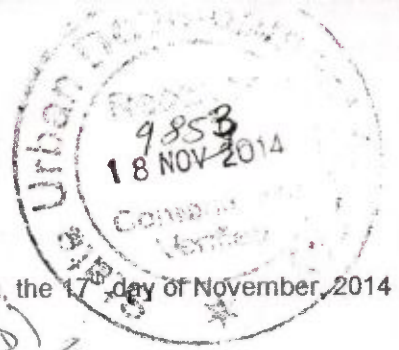





GUIDELINES FOR REGULATING STREET VENDING IN THE URBAN AREAS

MUNICIPAL VENDING COMMITTEE

1. Constitution of Municipal Vending Committee

1.1 Each Urban Local Body, shall constitute a Municipal Vending Committee.

1.2 Each Municipal Vending Committee shall consist of

(a) The Municipal Commissioner or the Commissioner, in case of Municipal Corporations or the *Executive Officer, in case of Municipalities, Notified Area Authorities and Industrial Township constituted under the West Bengal Municipal Act, 1993 (West Bengal Act XXII of 1993), as the case may be*, who shall be the Chairperson; and

(b) Such number of other members will be nominated by the concerned Urban Local Body, representing the Urban Local Body, the Planning Authority, local police, association of street vendors, traders' associations, *resident's* associations, Representatives of lead banks and such other interests as it deems proper and the concerned Urban Local Body will nominate such member by adopting a fair & transparent mechanism.

Provided that the number of members nominated to represent the street vendors shall not be less than 25% of the total number of members and one-third of such members shall be from amongst women :

(c) The maximum no. of such member will be 12 from the ULBs having population less than 2 lakh ; 15 from the ULBs having population upto 5 lakh and 18 from the ULBs having population more than 5 lakh.

Provided further that reasonable representation *may* also be given to persons who are physically challenged.

1.3 The Chairperson or the member nominated, as noted above shall, unless his nomination is terminated earlier by the Urban Local Body, hold office for a term of maximum three years from the date of his nomination.

1.4 The Municipal Vending Committee may associate with itself, any person whose assistance or advice it may desire in carrying out the issues related to Street Vendors

1.5 A person so associated will have a right to take part in the discussions relevant to that purpose, but shall not have a right to vote at a meeting of the committee and shall not be a member for any other purpose.

2. Meeting of the Committee

The Municipal Vending Committee shall meet at least once in every month at a place within the jurisdiction of the Urban Local Body and shall observe procedure in regard to the transaction of

business at its meetings, and in discharge of its functions, *as may be decided by the concerned Urban Local Body.*

3. Functions of the Municipal Vending Committee

3.1 The Municipal Vending Committee, *will submit its recommendations to the Urban Local Body concerned to:*

- (a) grant, renew, suspend or cancel registration certificates to street vendors, in such form and manner, and on such terms and conditions, as may be determined by the concerned Urban Local Bodies;
- (b) specify the terms and conditions for issue, renew, suspension or cancellation of registration in the manner specified.
- (c) to determine the process to collect *fees* for registration or renewal of registration of street vendors as may be determined by the concerned Urban Local Body ;
- (d) determine the manner of collecting fees through banks, counters of Urban Local Body or counters of Municipal Vending Committee, fee for registration, usage of parking space for mobile stalls and availing of civic services, in consultation with Urban Local Body;
- (e) identify and designate vending zones;
- (f) specify timings for vending in vending zones;
- (g) maintain the records of land, street, footpath, embankment, waiting area, parks and other public places designated for vending in such manner as may be specified;
- (h) conduct periodic surveys of vending zones;
- (i) collect and maintain data regarding street vendors;
- (j) determine quantitative norms for different categories of stationary and mobile stalls in the vending zones;
- (k) assess and determine maximum holding capacity of each vending zone;
- (l) identify and declare vending zones as restriction-free-vending zones, restricted-vending zones including day time vending zone & night time vending zone and no-vending zones in the manner specified;
- (m) fix sign boards at each vending zone to indicate kind of vending zone, its boundaries and vending timings.
- (n) monitor activities of street vendors:
- (o) ensure that the quality of products and services provided to the public and public health, hygiene and safety standards as specified by the Urban Local Body are maintained;
- (p) ensure that allotted stalls are utilized by the allottees in accordance with the terms and conditions specified.

(q) determine actions including imposition of fine for violating the terms and conditions for registration;

(2) The Municipal Vending Committee, shall submit its recommendations to the Mayor, in the case of Municipal Corporation, and to the Chairman in the case of ULBs other than Municipal Corporations. Acceptance or rejection of the recommendations made by the Municipal Vending Committee shall be subject to confirmation or modification by the Mayor-in-Council of the Municipal Corporation in the case of Municipal Corporations, and, in the case of Urban Local Bodies other than the Municipal Corporations, by the Board of Councillors of the Municipalities or Notified Area Authorities or by the Authority of the Industrial Townships, as the case may be.

4. REGISTRATION OF STREET VENDORS

4.1 Application for registration

a) Every person who has completed the age of 18 years and intends to do street vending may make an application for registration as street vendor to the Municipal Vending Committee, provided that the persons who have been carrying out business prior to issuance of the guideline, shall immediately after constitution of Municipal Vending Committee for the respective ULB, shall make application for their registration.

b) Every application shall be made in such form and manner and accompanied by such fee as may be determined by the concerned Urban Local Bodies.

4.2 Registration for street vendors

a) An application made under Para-4.1(a) above, shall be examined by the Municipal Vending Committee and the registration to be made within such period, and in such manner, as may be determined by the concerned Urban Local Bodies within four months from the issuance of this guideline as mentioned by the Hon'ble Supreme Court in the order.

b) The Municipal Vending Committee shall not summarily reject the application without giving the applicant an opportunity to rectify deficiencies, if any, and hearing him.

*c) If the Municipal Vending Committee is satisfied that the application is in compliance with the provisions of this guideline, it shall *send its recommendation to the ULB to register the name of the street vendor.**

d) After receiving the recommendation from the Municipal Vending Committee, the ULB may accept the recommendation and grant registration on payment of such fee as may be decided by the Urban Local Body; but not more than Rs. 250/- and subject to such terms and conditions as may be determined by the Urban Local Body in consultation with the Municipal Vending Committee.

e) Any person aggrieved by the decision of the Municipal Vending Committee may, prefer an appeal to the Urban Local Body within such period, and in such manner, as may be decided by the Urban Local Bodies.

f) Once registered, he may continue to do so within the period of registration is over & unless renewed.

g) Physically challenged who were allowed to operate PCOs in terms of the judgement reported in (2009) 17 SCC 231 shall be allowed to continue to run their stalls and sell other goods because running of PCOs is no longer viable. Those who were allowed to run Aarey/ Sarita shall be allowed to continue to operate their stalls.

5. DUTIES OF URBAN LOCAL BODIES

5.1 Duties of Local Authorities

Urban Local Body shall be responsible for:-

- (a) Overall supervision and monitoring of the Scheme for street vendors,
- (b) Monitoring effective functioning of the Municipal Vending Committee;
- (c) Allotting spaces to the street vendors in the manner specified;
- (d) Granting, renewal, suspension or cancellation of license to the registered street vendors in the manner specified;
- (e) Providing, in consultation with the Municipal Vending Committee, in the vending zones and to the street vendors, civic services.

6. BREACHES OF CONDITIONS AND PENALTY

6.1 Cancellation or suspension of registration

a) Where any street vendor who has been registered or his agent or servant commits breach of any of the conditions thereof or any other terms and conditions determined by the concerned Urban Local Bodies for the purpose of regulating street vending or where the Municipal Vending Committee is satisfied that such registration has been secured by the street vendor through misrepresentation or fraud, *the Urban Local Body may, cancel the registration or suspend the same for such period as it thinks fit;*

Provided that no such cancellation or suspension shall be made by the *Urban Local Body* unless an opportunity of hearing has been given to the street vendor *by the Municipal Vending committee.*

6.2 Penalty for contraventions

If any street vendor-

- (a) Indulges in street vending without registration;
- (b) Vends beyond the designated vending zones or specified timings;
- (c) Vends goods or offers services that are detrimental to public health;

- (d) Contravenes the terms and conditions of registration;
 - (e) Contravenes the terms and conditions of allotment of stall or license; or
 - (f) Contravenes any other terms and conditions determined by the concerned Urban Local Bodies.
- for the purpose of regulating street vending he shall be liable to a penalty which shall not be exceeding rupees five hundred, as may be determined, or as the case may be, by the Urban Local Body in consultation with the Municipal Vending Committee.

7. Supervision by the State Government

7.1 In case of the urban local bodies, excepting Kolkata Municipal Corporation, Director of Local Bodies or the District Magistrate or the Sub-divisional Magistrate or the District Municipal Development Officer; and in the case of Kolkata Municipal Corporation, any officer of Department of Municipal Affairs, Government of West Bengal, not below the rank of Joint Secretary, may—

- (a) inspect, or cause to be inspected, any immovable property owned, used or occupied by the Urban local body or any work in progress ;
- (b) inspect or examine any department of the urban local body or any office, service, work or thing under the control of the Urban local body;
- (c) record, in writing, for the consideration of the urban local body, any observation he thinks proper in regard to the proceedings or duties of any of the municipal authorities.

7.2 For the purpose of inspection or examination, in the case of the urban local bodies other than Kolkata Municipal Corporation, the Director of Local Bodies or the District Magistrate or the Sub-divisional Magistrate or the District Municipal Development Officer; and in the case of Kolkata Municipal Corporation the officer of Department of Municipal Affairs, Government of West Bengal, not below the rank of Joint Secretary, may require the Chairman or any officer of the urban local body—

- (a) to produce any book, record, correspondence, plan or other document,
- (b) to furnish any return, plan, estimate, statement, account or statistics, or
- (c) to furnish or obtain any report.

7.3 When a requisition is made as per 7.2, the Mayor/Chairman or any officer of the Urban local body, as the case may be, shall comply with such requisition.

7.4 Power of State Government to call for documents, returns or information from Chairman or any officer of Urban local body

The State Government may, at any time,—

- (a) call for any document in the possession or under the control of the Chairman or any officer of the Urban local body;

(b) require the Mayor/ Chairman or any officer of the Urban local body to furnish any return, plan, estimate, statement, account, report of statistics, or any information whatsoever.

7.5 Power to suspend action

a) The State Government may and after giving the Urban local body a reasonable opportunity of being heard, annul any proceeding or resolution or order which it consider to be not in conformity and may take possible measure necessary to secure such conformity:

Provided that pending the hearing to be given to the urban local body, the State Government may suspend the operation of such proceeding or resolution or order.

b) The State Government, on receiving any information that any urban local body is about to pass an order or instruction in excess of any power, may forthwith prohibit the passing of such order or instruction and such prohibition shall be binding on the Urban local body:

Provided that the State Government shall immediately thereafter give an opportunity to the Urban Local Body to make its representation in the matter upon which the State Government shall give its final order with reasons in writing.

7.6 Directions by the State Government

a) In the discharge of their functions, the urban local bodies shall be guided by this set of guidelines or as may be issued by the State Government time to time.

b) If such duty is not performed within the period so fixed, the State Government may, in the public interest, by order do, or cause to be done by any Officer of the State Government or any authority appointed by it, anything for due performance of such duty notwithstanding anything to the contrary contained in any other law for the time being in force.
