



8. Based on survey of old and inefficient pumps, 46 pumps have been identified for replacement. However only 25 pumps have been replaced so far. Secretary HUA requested the State to expedite replacing of all the identified pumps.

(Action: State Mission Director; Timeline: 30th June, 2019)

9. State is requested to upload balance projects in the portal and also update the status of existing projects. Number of projects indicated in SAAP and actually taken on ground may be properly correlated.

(Action: State Mission Director; Timeline: 31st March, 2019)

# B. Smart Cities Mission (SCM):

1. It is noted that although the New Town Kolkatta was selected as a smart city in May 2016 in round 2, the SPV was established only in October 2018after repeated reminders. A regular PMC has still to be appointed. Meanwhile WBEIDC has been appointed as interim PMC. Government of Inda has released Rs 58 crores towards the SPV account but these funds are yet to be released by the State Government into the account of SPV. Secretary (HUA) requested the State Government to transfer both the GoI share and the State's full share of funds to the Smart City SPV.

(Action: State Mission Director (SCM); Timeline: 15th March 2019)

2. So far the Smart City has identified 45 projects with a cost of Rs 1,532 crore. Due to delays mentioned above, most of the projects are still at the DPR stage. The State Government is requested to speed up finalisation of the DPRs and issue tenders and also prepare an implementation schedule for the city.

(Action: State Mission Director; Timeline: Ongoing)

- 3. The Secretary HUA requested the State to expedite the issue of tenders for the following projects which have been identified:
  - 1. Integrated Command and Control Centre
  - 2. Smart Road Project
  - 3. Smart Water
  - 4. Smart Waste Water and Reuse

5. Secretary HUA suggested that the State Mission Director and his team may visit the various successful initiatives by other states for cross learning. He also suggested that plastics may be shredded and used in road construction. Similarly plastic bags may be replaced by compostable bags.

(Action: State Mission Director; Timeline:Ongoing)

6. The State Government has requested to utilize its full share of allocation of funds of Rs. 911 crores under the Mission; however, the State hasutilized Rs. 410 crores only. It has yet to send proposal for release of 2<sup>nd</sup> installment. The state is also requested to send details of SWM projects for which Rs 200 crore has been released from MoHUA. The State is requested to expedite the works progress and utilize the total funds earmarked.

(Action: State Mission Director; Timeline: 30th June, 2019)

# D. Pradhan Mantri Awas Yojana - Urban (PMAY-U):

1. Against the demand for 10.78 Lakh houses, State has taken only sanctions of 3.43 Lakh (32%) houses including RAY and CLSS. State is requested to complete the actual demand survey by June in order meet out the target of "Houses for all by 2022".

(Action: State Mission Director; Timeline:30<sup>th</sup> June 2019)

2. Out of 3.33 lakh houses sanctioned under the mission, only 1.57 lakh houses have been grounded so far of which only 66,085 houses have been completed till date. Construction of 56,895 houses sanctioned prior to March 2018 are yet to be grounded. State is requested to undertake construction of sanctioned houses and expedite the completion of thegrounded houses.

(Action: State Mission Director; Timeline: Continuous)

3. Around 93% of the sanctioned amount for houses approved upto March 2018 has been released by the Government of India, only 31% houses (62,238) have been completed so far. State is requested to utilise the funds released and complete the houses under construction.

(Action: State Mission Director; Timeline:31st March 2019)

4. The State has still to submit action taken report on Quality Certification from third Party. Release of second and third installment is held up due to its non-submission. State is requested to expedite submission of TIPMA report.

(Action: State Mission Director; Timeline: Continuous)

appointed by the Hon'ble Supreme Court, while performance of Kolkatta which houses maximum number of homeless has been rated as 'Extremely Poor' by the same committee. Secretary HUA underlined the seriousness of Sunpreme Court in the matter and requested the State Government to take urgent action in the matter.

4. The scheme for street Vendor's Act has not yet been notified. Similalry street vendor's survey is yet to be done. The Dispute Redressal Committee has also to be constituted as yet. Secretary (HUA) requested the State Government to expedite the notification of the Act and to carry out a survey.

(Action: State Mission Director; Timeline: 31st March, 2019)

5. Secretary, HUA has interacted with SHG members and seen the different products exhibited by the members during the field visit to Baidyabati municipality. The SHG members have requested Secretary, HUA for providing the "Artisan Card" which will be used in various trade fairs, exhibitions etc. Secretary, HUA directed that the JS(NULM) may coordinate with concerned departments and take the required action immediately.

# **Objectives**

"Swasth SHG Pariwar (SSP)" initiative envisages the linking of all eligible SHG members to the benefits of Ayushman Bharat-Pradhan Mantri Jan Arogya Yojana and Poshan Abhiyan and also proposes to organise health check-up camps for all SHG members.

# <u>Linking of Eligible SHG Members under Ayushman Bharat-Pradhan</u> <u>Mantri Jan Arogya Yojana<sup>1</sup> and Poshan Abhiyan<sup>2</sup></u>

An exercise of identifying persons eligible for AB-PMJAY from the SECC 2011 (Urban) database and collecting additional information (ratio card number and mobile number) was carried out last year by the ULBs<sup>3</sup>.

ULBs should use all those nodal officers and other staff, who were involved in the exercise referred to above in addition to the NULM functionaries, Resource Organisations and community based organizations (ALFs, CLFs and Shehri Sahbhagita Manch) for the 100 days impactful intervention – "Swasth SHG Pariwar".

The following process may be followed in order to link the eligible SHG members with the AB-PMJAY and Poshan Abhiyan:

# 1. Sensitization of ULB and NULM functionaries about AB-PMJAY & Poshan Abhiyan

 States shall organize workshop(s) at the state level of thefunctionaries of NULM, National Health Mission (NHM), Women and Child development and ULB officials to sensitize them about the objectives of SSP.

- ii. Similarly, an orientation at the city level also should be organized and NHM and W&CD officials to fix up their roles and responsibilities in successful implementation of SSP programme.ULBs should prepare an action plan during the this orientation by involving all the stakeholders.
- iii. District Collector/Municipal Commissioner should involve CSC District Level Nodal Officer (CSC-DLNO) to ensure presence of CSC staff at the ALF meetings in order to issue Ayushman Bharat Cards to identified SHG members.
- iv. During the workshops organised by the ULBs, IEC material shall be made available to the participants for further distribution. Further, a request to make available IEC material regarding AB-PMJAY and Poshan Abhiyan shall be made to the officials concerned.
- v. These workshops shall be completed within a maximum of oneweek from the date of issue of this advisory.

# 2. Linking all eligible SHG members with requisite information to Ayushman Bharat & Poshan Abhiyan

The step-wise activities to be undertaken are as follows:

- i. Sharing ward wise SECC data on Urban beneficiaries under Ayushman Bharat with ULBs
  - a. Ward-wise segregated dataof Ayushman Bharat scheme will be available on the <a href="http://pmjay.gov.in/mohua.html">http://pmjay.gov.in/mohua.html</a>.
  - b. Municipal Commissioners/Executive officers are requested to send the Name, Designation, mobile numbers of one nodal officer from ULB who had earlier worked on AB-PMJAY beneficiary validation program in March, 2018and one CMMdesignated for this purpose. The designated nodal officersshall be provided login IDs and Password todownload the 'pdf' files of SECC data to

identify the Ayushman beneficiaries. The nodal officers identified should preferably be same who worked in the earlier round.

- c. The ward-wise 'pdf' files,downloadedby the designated nodal officers, to be distributed to a team of two officials, per ward or a group of contiguous wards one from the ULB and other from the Health Department. The team to be comprised of a Health Inspector/ Junior Engineer/ Sanitary Inspector/ other employee of the ULB and a ANM/ASHA/Coordinator nominated by the Health Department, preferably from among those who had worked on AB-PMJAY beneficiary validation program in March, 2018.
- d. The designated CMM to supervise the task of collection of the validated data of SHG members and updation of the same.
- ii. <u>Facilitation of Ayushman Bharat Scheme depending on nature of beneficiaries</u>:
  - a. Using the beneficiary lists for each ward/locality, ALF level meetings shall be held in coordination with the health functionaries to orient the SHG members about the scheme. The notice for such a meeting must include an instruction to the SHG members to carry their ration card, Aadhar card and mobile number details with them.
  - b. The key objective is to ensure that all eligible SHG members are brought under the Ayushman Bharat yojana. More than one meeting at ALF level and door-to-door visits may be undertaken, if required.
  - c. During the meetings, the beneficiaries, who figure in the validated list, shall be facilitated to get the cards from CSC staff present. The Collector/Municipal Commissioner should direct the CSC nodal officer to ensure presence of CSC persons at the meetings to update records to issue cards as per the prevailing rates.

- d. Besides the downloaded ward wise list, Officials are encouraged to engage volunteers to checkeligibility of the SHG members using the mera.pmjay.gov.in website or the mera PMJAY mobile app.
  - e. With respect to the SHG members whose names are found in the SECC list, but mobile number and ration card numbers are not mentioned, the nodal officer shall collect details of the ration card number and mobile number. Such collection and upload of information must take place within 20 days (as per the instructions contained in the portal (<a href="http://pmjay.gov.in/mohua.html">http://pmjay.gov.in/mohua.html</a>.
  - f. The SHG women, who are urban poor according to the state criteria but don't figure in the SECC data, the requisite information i.e. ration card and mobile details should be collected and kept with the ULBs for further future action.
- iii. Photographs of high resolution of the sensitization workshops, ALF meetings, e-Card facilitation etc. should be uploaded on the NULM portal and shared with the Ministry through CD/Pen-drive also.

# 3. Linking all eligible SHG members with PoshanAbhiyan

Poshan Abhiyan is India's flagship programme to improve nutritional outcome for children, adolescent and pregnant women and lactating mothers.

ULB staff and NULM functionaries have already conducted such drive to identify and link eligible SHG members with Poshan Abhiyan during November 2018 to February 2019 during ShehriS amridhi Utsav (SSU). The idea is to repeat the exercise as per the following protocol:

- i. Rechecking whether all the SHG members linked with Poshan Abhiyan during SSU 2018-19, have received benefits under Poshan Abhiyan?
- To identifyand link eligible SHG members to Poshan Abhiyan involving the NULM functionaries, CLF, ALF, SHG groups, Mahila Arogya Samiti and other voluntary groups.

- iii. At the ALF meetings proposed for linking SHG member to Ayushman Bharat, the SHG members should also be sensitized about the benefits of the Poshan Abhiyan.
- iv. Pregnant women, lactating or nursing mothers should be encouraged to attend Urban Health and Nutrition Day at each Anganwadi Centre.
- v. Photographs of high resolution of the activities performed should be uploaded on the NULM portal and shared with the Ministry through CD/Pen-drive.

# 4. Organizing Health-Check up for all SHG Members

- i. Preventive Health check-up camps shall be organized for health screening of SHG members at designated locations, on specified dates. SHGs must be informed of such camps well in advance.
- ii. The SHG members must also be informed about any pre-requisites such as carrying ID proof, latest prescriptions, records of surgical procedures in the past etc.
- iii. Municipal Commissioners shall be the Nodal Officers responsible for organization of health camps. The nodal officer shall strive to ensure 100 percent coverage of SHG members in these health check-ups.
- iv. ALF/CLF members to be present in all the health camps to facilitate successful operation of the camps.
- v. Photographs of high resolution of the health camps to be shared with the Ministry through CD/pen drive and uploaded on the portal.

# Annexure B

Appropriate fields for entry of data in respect of provision of AB cards, validation of non-validated beneficiaries in NHA portal, number of health camps organized etc. have been incorporated in the MIS portal.

The data entry should be done on daily basis regarding the activities undertaken.

## Dear Madam/Sir,

As you are aware, the Self Help Groups (SHGs) of the urban poor, primarily comprising of women members, are formed under the Deendayal Antyodaya Yojana – National Urban Livelihoods Mission (DAY-NULM). SHGs are further organized into Area Level Federations (ALFs) and City Level Federations (CLFs). This architecture of community-based organizations provides a strong platform for social empowerment, and also facilitates dissemination of government welfare programmes.

- 2. A need has been felt to create a systematic process for participation of these collectives of the urban poor in resolution of gaps in the implementation of the mission and local urban issues concerning them. At the same time, Urban Local Bodies (ULBs) need a mechanism to identify gaps in provision of basic urban services in urban poor settlements, and coverage of government entitlements.
- 3. With these dual objectives, the Ministry of Housing & Urban Affairs had proposed to establish a platform named 'Shehri Sahbhagita Manch' in all cities where DAY-NULM is being implemented. This platform would leverage the community-based organizations formed under DAY-NULM, to create a mechanism for participatory urban governance.
- 4. With a view to facilitate the establishment and functioning of Shehri Sahbhagita Manch, it is suggested to follow the process as indicated below:
  - i. Shehri Sahbhagita Manch to be constituted at the city level comprising of the following members
    - a. Mayor/ Chairperson
    - b. Municipal Commissioner/ Chief Officer/ Executive Officer
    - c. Executive Committee members of City Level Federations (OR at least 15 representatives from ALFs if CLFs are not functional)
    - d. Lead Bank Manager
    - e. Officer in charge of DAY-NULM
    - f. Heads of the following Municipal wings Engineering, Sanitation, Solid Waste Management,
    - g. Heads of the departments at the ULB , viz. Women and Child Welfare, Primary education, Health

ii. The meeting of the Shehri Sahbhagita Manch should be convened at least twice a year.

iii. This platform is intended for raising issues that affect the community at large.

iv. Larger cities may also consider organizing additional meetings at the Zone/Circle/Ward level to aggregate and prioritize the issues for discussion at the Shehri Sahbhagita Manch.

v. CLF/ALF representatives may also share their success stories of issues that have

been successfully resolved at the Shehri Sahbhagita Manch.

- 5. For record Keeping and Accountability in the Manch, the following are suggested:
  - i. The minutes of all Shehri Sahbhagita Manch meetings should be maintained and circulated to all concerned for follow up action.

ii. In every meeting, an action taken report on issues raised in the previous meeting should be presented for discussion.

- iii. The ULBs should create a web page named 'Shehri Sahbhagita Manch', linked to the existing website of the ULB. The CLF/ ALF representatives should be given user ID and password, so that they can raise their issues visible on public domain, for redressal by the line departments. Appropriate mechanism should be in place for periodic follow-up of action taken on the issues raised.
- 6. It would be appreciated that Shehri Sahbhagita Manch which is intended to give a voice to CLFs and ALFs formed under DAY-NULM to contribute to local decision making process, will go a long way to further the spirit of the Constitution (74th Amendment) Act, 1992. I shall, therefore, be grateful if you could take the necessary steps to establish and implement the Shehri Sahbhagita Manch initiative, in all ULBs of your State, under intimation to the Ministry of Housing and Urban Affairs.

Subject: Advisory to States on Adoption of Shelters for Urban Homeless by local Colleges - Shehri Samridhi Utsav, February 2019.

Sir,

I am directed to refer Joint Secretary (NULM)'s DO Letter no. O-17024/187/2018-UPA-I-UD dated October, 2018 (enclosed) regarding celebrating DAY-NULM 'Pakwada' by organizing "Shehri Samridhi Utsav" during the first fortnight of February, 2019.

- 2. As per Clause 13.6, of Shelters for the Urban Homeless (SUH) guidelines, "Every shelter should be linked with a high school or college, so that the students can engage with the residents of the shelters, ensuring quality of the shelters, and learning community service." Accordingly, States are advised to ensure that all shelters established under Shelters for the Urban Homeless (SUH) component of DAY-NULM to be mapped to a degree/intermediate college located nearby. Adoption of shelters by colleges would lead to better implementation and transparency in addition to creating a healthy interactive environment for shelter residents and a good learning experience for college students.
- 3. Indicative list of activities to be taken up by college students may include-
  - Mobilization drive by students to bring identified urban homeless to the shelters
  - ii. Fortnightly visits on rotation by student volunteers
  - iii. Listening and documenting the stories of residents
  - iv. Celebrating festivals with shelter residents
  - v. Outings/walks with elderly residents
  - vi. Prepare reports on the shelter facilities with photographs and stories of residents
- 4. The first round of visits by student to be organized during the Shehri Samriddhi Utsav. States should send a list of colleges mapped to each shelter, by 15th November 2018.
- 5. Students' reports on gaps in management of the scheme and shelter facilities will be submitted to shelter management committees and the Executive Committees of the ULBs. ULBs should ensure that the Executive Committee

deliberates on the issues raised by the students in their meetings which are to be convened as per the Mission guidelines.

Sir,

I am directed to refer Joint Secretary (NULM)'s DO Letter no. O-17024/187/2018-UPA-I-UD dated October, 2018 regarding celebrating DAY-NULM 'Pakwada' by organizing "Shehri Samridhi Utsav" during the first fortnight of February, 2019. As you are aware that there are a number of Government of India Schemes that can benefit the urban poor population. States are advised to ensure that all SHG members under DAY-NULM are linked to these schemes.

As per clause 23 of the SMID guidelines, "In order to bring the beneficiaries of DAY-NULM within the ambit of social insurance and to provide coverage from risks/uncertainties viz: death, accident, disability, hospitalization & retirement, the respective SULMs will ensure facilitation of low-cost insurance products/services including micro-pension to the potential beneficiaries."

- 2. Besides insurance, other schemes for housing, sanitation, financial inclusion, nutrition etc. also have benefits for which DAY-NULM beneficiaries are eligible (See Annexure I for an indicative list of schemes).
- 3. In order to identify those SHG members who are not covered under the relevant schemes, a survey needs to be conducted. The survey for identification of SHG members would be kicked off by 1st November 2018 and the data on identification of SHG members not having access to any of these programs, should be shared by States with MoHUA by 1<sup>st</sup> December 2018. Community Organizers (COs), Resource Organizations (ROs) and Area Level Federations (ALFs) may be engaged to conduct the survey.
- 4. SULMs would then coordinate with the concerned State departments and provide these critical linkages in a time bound manner. All paperwork to include SHG members as beneficiaries in the relevant schemes should be done during the preparatory period, as per the activity schedule indicated below. During the DAY-NULM Pakhwada in February 2019, camps would be organized for distributing benefits to the eligible members.
