- ⑤ Copy of letter <sup>engaging</sup> ~~engaging~~ Smt. Chattopadhyay as C.O. under SJSRY since 2.1.2011 as reported by the Chairman in his letter.
- ⑥ A certificate to the effect that Smt. Chattopadhyay has been working as C.O. from 2.1.11 to till date under SJSRY/NULM.
- ⑦ Copy of certificate of educational qualification submitted and also age proof certificate.
