The position of ALFs registered in the three ULBs is shown in the following table. As per NULM guidelines, revolving support may be provided for these registered ALFs @Rs.50000/- per ALF. Hence, revolving fund (RF) to the tune of Rs.36,00,000/- (rupees thirty six lacs) only may be released to the three ULBs as mentioned against each in the following table. Fund may be released out of SMID component of NULM.

RF may be released to the concerned ULBs with the following stipulations.

- i) Fund is to be disbursed to only registered ALFs for which claim has been made
- ii) Revolving Fund is to be directly credited to savings bank accounts of the ALF

In NULM (National Urban Livelihood) An Area Level Federation (ALF) is an important Sub-Component under Component -I **Building Community Institutions - Self-Help Groups and Their Federations** . NULM envisages mobilisation of urban poor households into a three tiered structure with Self-Help Groups (SHGs) at the grass-root level, Area Level Federations (ALFs) at the slum / ward level and City-level Federations (CLFs) at the city-level .

It is well established that ALF is an association of SHGs consisting of representatives from all member SHGs, with the objective of supporting member-SHGs, (guiding and monitoring the functioning of SHGs., and forming and training new SHGs.) The federation of SHGs is essential to deal with larger issues like bank linkage, Inter-group lending, negotiations with higher level.

so for successful implementation of NULM task of ALF formation to be completed as earliest possible at Every ULBs. As per our record out of target of 2390 ALF to be formed (@ 13 SHG / ALF) only 602 ALF have been formed till date .

In this respect we have decide to ask ULB to submit a propose plan within the fixed time period set by us. So all ULBs are requested to complete the task of ALF formation within three months from now (within June 2016).it has also be said to send draft proposal at the designated ID to SUDA (wbsulm@gmail.com) by end of April, 2016.

Here we also requested to all ULBs to submit a proposal of City Livelihood Centre (CLC) at SUDA by April, 2016 who have not submitted till date. Out of 58 NULM ULBs only 13 ULBs have submitted CLC proposal.




