A 50 bedded shelter unit under the scheme Shelter for Urban Homeless (SUH) under DAY-NULM with an approved project cost of Rs. 114.87 Lakh (excluding DPR preparation cost) was approved by Project Sanction Committee (PSC) in its 8 th meeting in favour of Arambag Municipality.

As per DAY-NULM guidelines the funding pattern of Central & State shares is 60:40. The Central share is Rs. 68.92 Lakh & State share is Rs. 45.95 Lakh. So far to the tune of Rs. 45.95 Lakh (1 st instalment) was released in favour of the Arambag Municipality on 17.03.2017.

Now, the progress of construction work is 70% as per report (copy enclosed) available at this office. Utilization Certificate of 1 st instalment of Rs. 42.25 Lakh was submitted to this office in GFR 19A duly signed by the Chairman, Arambag Municipality (copy enclosed) and authenticated by Executive Engineer, Hogghly Division, MED as per prevailing norms.

Now it is proposed to release an amount of Rs. 45.95 Lakh (Central Rs. 27.57 Lakh and Sate Share Rs. 18.38 Lakh) as 2 nd instalment in favour of the Arambag Municipality for the settlement of the bills.



Sub: Field Visit report of Shelter for Urban Homeless (SUH) under DAY-NULM at **Arambag Municipality**

A field visit has been conducted from State Mission Management Unit under WBSULM, SUDA to Arambag Municipality on 11.01.2019. During this visit, undersigned visited the 50 bedded Shelter for Urban Homeless under DAY-NULM at Arambag Municipality physically. During this visit at SUH, Arambag it appears that the shelter unit is ready to functional. Civil, Electrical and Sanitary & Plumbing works are completed in all respect. Procurement of furniture are under process (i.e. bed, bedding, personal lockers are purchased). During this visit a meeting was held with the Chairman, Arambag Municipality along with concerned municipal engineer, Community Organizer regarding funcationalization of the shelter unit by 31 st January, 2019. During this meeting it was informed to the Chairman that operation & maintenance of SUH and engagement of shelter staff is pending till now. It was also informed that operation & maintenance cost will be provided as per guidelines. After a threadbare discussion Chairman assured about the functionalization of SUH by 31 st January, 2019 and informed that operation & maintenance of SUH will be made by the ULB itself alongwith the engagement of shelter staff. It is informed by the community organizer that Shelter Management Committee has been constituted and homeless persons are identified to rescue into the shelter. The under signed informed to the Chairman of the concerned ULB about the target of functionalization of SUH as per road map and directions of State Level Shelter Management Committee. Few glimpses of filed visit are placed in the CP side.

Sub: Release of fund (final instalment) for construction of Shelter Homeless (SUH) under DAY-NULM in favour of Arambag Municipality.

As per NSP-1 a 50 bedded shelter unit under the scheme Shelter for Urban Homeless (SUH) under DAY-NULM at Arambag Municipality Rs. 114.87 Lakh (excluding DPR preparation cost) was approved by Project Sanction Committee (PSC) in its 8 th meeting. Out of this Rs. 114.87 Lakh, cost of civil construction including S & P and internal electrification is Rs. 101.91 Lakh, Furniture and Utensils Rs. 8.71 Lakh, service connection (WBSEDCL) Rs. 0.5 Lakh, Rs. 0.40 Lakh for fire fighting arrangement, Rs. 3.35 Lakh for contingency (3%).

As per NULM guidelines funding pattern of Central & State shares is 60:40. The Central share is Rs. 68.92 Lakh & State share is Rs. 45.95 Lakh. So far to the tune of Rs. 45.95 Lakh (1 st instalment) and Rs. 45.95 Lakh (2nd instalment) were released in two phases in favour of the Arambag Municipality.

Now, the Municipality has completed the construction of shelter unit in full and it is functional in full phase. Utilization Certificate of 1 st & 2 nd instalment of construction cost to the tune of Rs. 91.85 Lakh was received by this office in GFR 12C duly signed by the Finance Officer & Chairman, Arambag Municipality and authenticated by Executive Engineer, Hooghly Division, MED as per prevailing norms. A requisition of fund of 3 rd or final instalment has been submitted by the concerned ULB.

As per field implementation guidelines of SUH, further installment may be released after receiving of 70% utilization of previous instalments. Here 99% utilization of previous instalments has been received.

Now an amount of Rs. 22.97 Lakh (Central Share Rs. 13.78 Lakh & State Share Rs. 9.19 Lakh) (including 3% contingency) may be released as final instalment of sanctioned project cost in favour of the Arambag Municipality for the settlement of the bills as per prevailing norms.

It may be mentioned that a 50 bedded shelter unit under the scheme Shelter for Urban Homeless (SUH) was sanctioned in favour of Arambag Municipality with an approved project cost of Rs. 114.87 Lakh. Now construction of the shelter unit is completed and it is functional. For this project DPR, the estimate item works were considered without this ornamental grill & Collapsible gate fitting & fixing in each floor verandah/corridor. Now it is felt by the municipality that installation of this ornamental grill & collapsible are necessary for the safety & security of the inmates as the corridor/verandah in each floor is open.

Considering the above fact Chairman, Arambag Municipality sent the proposal (vide letter no.86/Aram dated: 25.09.2019) for installation of ornamental grill at Verandah on each floor & Collapsible gate of SUH at Arambag Municipality (Copy placed in the C.P. side mark as 'x'). It appears from the proposal that plan & estimate ornamental grill for each floor of SUH duly vetted by Executive Engineer, Hoogly Division, MED. The estimated cost for the proposal is Rs. 323313.00 (Rupees Three lakh twenty three thousand three hundred and thirteen only) (including cess, GST & 3% contingency). This estimated amount is required in addition to the approved project cost. The undersigned checked the estimate of this additional work and proposal for this additional work may be approved.

Now this proposal of installation of ornamental grill at Verandah on each floor of SUH & Collapsible gate of SUH may be forwarded to the competent authority for necessary approval.
