Sub: Release of O & M cost of SUH (1 st installment of 1 year from 01.04.2020) and free food cost for the shelter inmates for the temporarily functional shelter under DAY-NULM at Purulia Municipality.

It may be mentioned that a 50 bedded shelter unit was sanctioned in favour of Purulia Municipality by the Project Sanction Committee of SUH. Now it is in tender process. Now Purulia Municipality approached for a temporary shelter with O & M cost till functionalization of Permanent shelter. This proposal has been accepted by the Project Sanction Committee of SUH and approved for O & M cost of SUH at Purulia Municipality since 01.04.2020.

As per this approval now Purulia Municipality sent a <u>requisition</u> amounting Rs. 30000.00 for three months for O & M cost of this temporary shelter. Concerned ULB also sent a <u>requisition</u> amounting Rs. 1,74,00.00 for the <u>fund for free food for two months April & May, 2020</u> for the shelter inmates as per G.O. dated: 28.03.2020 from MoHUA, Gol.

In this regard now fund may be released for O & M cost of shelter at Purulia Municipality as per below:
