- (4) From the available papers, it appears that 26 nos. of candidates were called for computer test & viva-voce test on 21.11.16. Out of 26, 22 candidates appeared in the aforesaid test.
- (5) Out of 22 candidates, Sri Sagar Sharma obtained highest mark (40 Nos.) and CLSL has recommended the name of Sri Sagar Sharma, who got highest mark, for engagement against 1 Post of DA cum DEO at CMU under Day - NULM.
