## THE STREET VENDORS (PROTECTION OF LIVELIHOOD AND REGULATION OF STREET VENDING) ACT, 2014

(No. 7 of 2014)

[4th March, 2014.]

An Act to protect the rights of urban street vendors and to regulate street vending activities and for matters connected therewith or incidental thereto.

BE it enacted by Parliament in the Sixty-fifth Year of the Republic of India as , follows:—

### CHAPTER I

### PRELIMINARY

- 1. (1) This Act may be called the Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014.
  - (2) It extends to the whole of India except the State of Jammu and Kashmir.

Short title, extent, commencement and provisions.

- (3) It shall come into force on such date as the Central Government may, by notification in the Official Gazette, appoint; and different dates may be appointed for different States and any reference in any provision to the commencement of this Act shall be construed in relation to any State as a reference to the coming into force of that provision in that State.
- (4) The provisions of this Act shall not apply to any land, premises and trains owned and controlled by the Railways under the Railway Act, 1989.

24 of 1989.

Definitions.

- 2. (1) In this Act, unless the context otherwise requires,—
  - (a) "appropriate Government" means in respect of matters relating to,-
    - (i) a Union territory without Legislature, the Central Government;
  - (ii) the Union territories with Legislature, the Government of the National Capital Territory of Delhi or, as the case may be, the Government of Union territory of Puducherry;
    - (iii) a State, the State Government;
- (b) "holding capacity" means the maximum number of street vendors who can be accommodated in any vending zone and has been determined as such by the local authority on the recommendations of the Town Vending Committee;
- (c) "local authority" means a Municipal Corporation or a Municipal Council or a Nagar Panchayat, by whatever name called, or the Cantonment Board, or as the case may be, a civil area committee appointed under section 47 of the Cantonment Act, 2006 or such other body entitled to function as a local authority in any city or town to provide civic services and regulate street vending and includes the "planning authority" which regulates the land use in that city or town;

- (d) "mobile vendors" means street vendors who carry out vending activities in designated area by moving from one place to another place vending their goods and services:
- (e) "natural market" means a market where sellers and buyers have traditionally congregated for the sale and purchase of products or services and has been determined as such by the local authority on the recommendations of the Town Vending Committee;
- (f) "notification" means a notification published in the Official Gazette and the term "notify" shall be construed accordingly;
- (g)"planning authority" means an Urban Development Authority or any other authority in any city or town designated by the appropriate Government as responsible for regulating the land use by defining the precise extent of areas for any particular activity in the master plan or development plan or zonal plan or layout plan or any other spatial plan which is legally enforceable under the applicable Town and Country Planning Act or the Urban Development Act or the Municipal Act, as the case may be;
- (h) "prescribed" means prescribed by rules made under this Act by the appropriate Government;
  - (i) "Schedule" means the Schedule annexed to this Act;
- (j) "scheme" means a scheme framed by the appropriate Government under section 38;
- (k) "stationary vendors" means street vendors who carry out vending activities on regular basis at a specific location;
- (1) "street vendor" means a person engaged in vending of articles, goods, wares, food items or merchandise of everyday use or offering services to the general public, in a street, lane, side walk, footpath, pavement, public park or any other public place or private area, from a temporary built up structure or by moving from place to place and

includes hawker, peddler, squatter and all other synonymous terms which may be local or region specific; and the words "street vending" with their grammatical variations and cognate expressions, shall be construed accordingly;

- (m) "Town Vending Committee" means the body constituted by the appropriate Government under section 22;
- (n) "vending zone" means an area or a place or a location designated as such by the local authority, on the recommendations of the Town Vending Committee, for the specific use by street vendors for street vending and includes footpath, side walk, pavement, embankment, portions of a street, waiting area for public or any such place considered suitable for vending activities and providing services to the general public.
- (2) Any reference in this Act to any enactment or any provision thereof, shall, in relation to an area in which such enactment or such provision is not in force be construed as a reference to the corresponding law, if any, in force in that area.

### CHAPTERII

### REGULATION OF STREET VENDING

3. (1) The Town Vending Committee shall, within such period and in such manner as may be specified in the scheme, conduct a survey of all existing street vendors, within the area under its jursidiction, and subsequent survey shall be carried out at least once in every five years.

Survey of street vendors and protection from eviction or relocation.

- (2) The Town Vending Committee shall ensure that all existing street vendors, identified in the survey, are accommondated in the vending zones subject to a norm conforming to two and half per cent. of the population of the ward or zone or town or city, as the case may be, in accordance with the plan for street vending and the holding capacity of the vending zones.
- (3) No street vendor shall be evicted or, as the case may be, relocated till the survey specified under sub-section (1) has been completed and the certificate of vending is issued to all street vendors.
- 4. (1) Every street vendor, identified under the survey carried out under sub-section (1) of section 3, who has completed the age of fourteen years or such age as may be prescribed by the appropriate Government, shall be issued a certificate of vending by the Town Vending Committee, subject to such terms and conditions and within the period specified in the scheme including the restrictions specified in the plan for street vending:

Issue of certificate of vending.

Provided that a person, whether or not included under the survey under sub-section (I) of section 3, who has been issued a certificate of vending before the commencement of this Act, whether known as licence or any other form of permission (whether as a stationary vendor or a mobile vendor or under any other category) shall be deemed to be a street vendor for that category for the period for which he has been issued such certificate of vending.

- (2) Where, in the intervening period between two surveys, any person seeks to vend, the Town Vending Committee may grant a certificate of vending to such person, subject to the scheme, the plan for street vending and the holding capacity of the vending zones.
- (3) Where the number of street vendors identified under sub-section (1) or the number of persons seeking to vend under sub-section (2) are more than the holding capacity of the vending zone and exceeds the number of persons to be accommodated in that vending zone, the Town Vending Committee shall carry out a draw of lots for issuing the certificate of vending for that vending zone and the remaining persons shall be accommodated in any adjoining vending zone to avoid relocation.

Conditions for issue of ... certificate of vending.

- 5. (1) Every street vendor shall give an undertaking to the Town Vending Committee prior to the issue of a certificate of vending under section 4, that—
  - (a) he shall carry on the business of street vending himself or through any of his family member;
    - (b) he has no other means of livelihood:
  - (c) he shall not transfer in any manner whatsoever, including rent, the certificate of vending or the place specified therein to any other person.
- (2) Where a street vendor to whom a certificate of vending is issued dies or suffers from any permanent disability or is ill, one of his family member in following order of priority, may vend in his place, till the validity of the certificate of vending—
  - (a) spouse of the street vendor;
  - (b) dependent child of the street vendor:

Provided that where a dispute arises as to who is entitled to vend in the place of the vendor, the matter shall be decided by the committee under section 20.

Categories of certificate of vending and issue of identity cards.

- **6.** (1) The certificate of vending shall be issued under any of the following categories, namely:—
  - (a) a stationary vendor;
  - (b) a mobile vendor; or
  - (c) any other category as may be specified in the scheme.
- (2) The certificate of vending issued for the categories specified in sub-section (I) shall be in such form, and issued in such manner, as may be specified in the scheme and specify the vending zone where the street vendor shall carry on his vending activities, the days and timings for carrying on such vending activities and the conditions and restrictions subject to which he shall carry on such vending activities.
- (3) Every street vendor who has been issued certificate of vending under sub-section (1) shall be issued identity cards in such form and manner as may be specified in the scheme.

Criteria for issuing certificate of vending. 7. The criteria to be followed by the Town Vending Committee for issuing certificate of vending to a street vendor shall be as specified in the scheme, which may, apart from other things, provide for preference to the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, women, persons with disabilities, minorities or such other categories as may be specified in the scheme.

Vending fees.

**8.** Every street vendor who has been issued certificate of vending shall pay such vending fees as may be specified in the scheme.

Validity and renewal of certificate of vending.

of vending.

**9.** (1) Every certificate of vending shall be valid for such period as may be specified in the scheme.

Cancellation or suspension of certificate (2) Every certificate of vending shall be renewable for such period, in such manner, and on payment of such fees, as may be specified in the scheme.

10. Where a street vendor who has been issued a certificate of vending under this Act commits breach of any of the conditions thereof or any other terms and conditions specified for the purpose of regulating street vending under this Act or any rules or schemes made thereunder, or where the Town Vending Committee is satisfied that such certificate of vending has been secured by the street vendor through misrepresentation or fraud, the Town Vending Committee may, without prejudice to any other fine which may have been incurred by the street vendor under this Act, cancel the certificate of vending or suspend the same in such manner as may be specified in the scheme and for such period as it deems fit:

Provided that no such cancellation or suspension shall be made by the Town Vending Committee unless an opportunity of hearing has been given to the street vendor.

11. (1) Any person who is aggrieved by any decision of the Town Vending Committee with respect to issue of certificate of vending under section 6 or cancellation or suspension of certificate of vending under section 10 may prefer an appeal to the local authority in such form, within such period, and in such manner, as may be prescribed.

Appeal from decision of Town Vending Committee.

(2) No appeal shall be disposed of by the local authority unless the appellant has been given an opportunity of hearing.

### CHAPTER III

### RIGHTS AND OBLIGATIONS OF STREET VENDORS

12. (1) Every street vendor shall have the right to carry on the business of street vending activities in accordance with the terms and conditions mentioned in the certificate of vending.

Rights of street vendor.

- (2) Notwithstanding anything contained in sub-section (1), where any area or space, as the case may be, has been earmarked as no-vending zone, no street vendor shall carry out any vending activities in that zone.
- 13. Every street vendor, who possesses a certificate of vending, shall, in case of his relocation under section 18, be entitled for new site or area, as the case may be, for carrying out his vending activities as may be determined by the local authority, in consultation with the Town Vending Committee.

Right of street vendor for a new site or area on relocation.

14. Where a street vendor occupies space on a time sharing basis, he shall remove his goods and wares every day at the end of the time-sharing period allowed to him.

Duty of street vendors.

15. Every street vendor shall maintain cleanliness and public hygiene in the vending zones and the adjoining areas.

Maintenance of cleanliness and public hygiene.

16. Every street vendor shall maintain civic amenities and public property in the vending zone in good condition and not damage or destroy or cause any damage or destruction to the same.

Maintenance of civic amenities in vending zone in good condition.

17. Every street vendor shall pay such periodic maintenance charges for the civic amenities and facilities provided in the vending zones as may be determined by the local authority.

Payment of maintenance charges.

### CHAPTERIV

### RELOCATION AND EVICTION OF STREET VENDORS

18. (1) The local authority may, on the recommendations of the Town Vending Committee, declare a zone or part of it to be a no-vending zone for any public purpose and relocate the street vendors vending in that area, in such manner as may be specified in the scheme.

Relocation or eviction of street vendors.

- (2) The local authority shall evict such street vendor whose certificate of vending has been cancelled under section 10 or who does not have a certificate of vending and vends without such certificate, in such manner as may be specified in the scheme.
- (3) No street vendor shall be relocated or evicted by the local authority from the place specified in the certificate of vending unless he has been given thirty days' notice for the same in such manner as may be specified in the scheme.
- (4) A street vendor shall be relocated or evicted by the local authority physically in such manner as may be specified in the scheme only after he had failed to vacate the place specified in the certificate of vending, after the expiry of the period specified in the notice.

(5) Every street vendor who fails to relocate or vacate the place specified in the certificate of vending, after the expiry of the period specified in the notice, shall be liable to pay for every day of such default, a penalty which may extend up to two hundred and fifty rupees, as may be determined by the local authority, but shall not be more than the value of goods seized.

Seizure and reclaiming of goods.

19. (1) If the street vendor fails to vacate the place specified in the certificate of vending, after the lapse of the period specified in the notice given under sub-section (3) of section 18, the local authority, in addition to evicting the street vendor under section 18, may, if it deems necessary, seize the goods of such street vendor in such manner as may be specified in the scheme:

Provided that where any such seizure is carried out, a list of goods seized shall be prepared, as specified in the scheme, and a copy thereof, duly signed by the person authorised to seize the goods, shall be issued to the street vendor.

(2) The street vendor whose goods have been seized under sub-section (I) may, reclaim his goods in such manner, and after paying such fees, as may be specified in the scheme:

Provided that in case of non-perishable goods, the local authority shall release the goods within two working days of the claim being made by the street vendor, and in case of perishable goods the local authority shall release the goods on the same day of the claim being made by the street vendor.

### CHAPTER V

### DISPUTE REDRESSAL MECHANISM

Redressal of grievances or resolution of disputes of street vendors. 20. (1) The appropriate Government may constitute one or more committees consisting of a Chairperson who has been a civil judge or a judicial magistrate and two other professionals having such experience as may be prescribed for the purpose of deciding the applications received under sub-section (2):

Provided that no employee of the appropriate Government or the local authority shall be appointed as members of the committee.

- (2) Every street vendor who has a grievance or dispute may make an application in writing to the committee constituted under sub-section (1) in such form and manner as may be prescribed.
- (3) On receipt of grievance or dispute under sub-section (2), the committee referred to in sub-section (1) shall, after verification and enquiry in such manner, as may be prescribed, take steps for redressal of such grievance or resolution of such dispute, within such time and in such manner as may be prescribed.
- (4) Any person who is aggrieved by the decision of the committee may prefer an appeal to the local authority in such form, within such time and in such manner as may be prescribed.
- (5) The local authority shall dispose of the appeal received under sub-section (4) within such time and in such manner as may be prescribed:

Provided that the local authority shall, before disposing of the appeal, give an opportunity of being heard to the aggrieved person.

### CHAPTER VI

### PLAN FOR STREET VENDING

Plan for street vending.

21. (1) Every local authority shall, in consultation with the planning authority and on the recommendations of the Town Vending Committee, once in every five years, prepare a plan to promote the vocation of street vendors covering the matters contained in the First Schedule.

(2) The plan for street vending prepared by the local authority shall be submitted to the appropriate Government for approval and that Government shall, before notifying the plan, determine the norms applicable to the street vendors.

### CHAPTER VII

### Town Vending Committee

22. (1) The appropriate Government may, by rules made in this behalf, provide for the term and the manner of constituting a Town Vending Committee in each local authority:

Town Vending Committee.

Provided that the appropriate Government may, if considers necessary, provide for constitution of more than one Town Vending Committee, or a Town Vending Committee for each zone or ward, in each local authority.

- (2) Each Town Vending Committee shall consist of:-
- (a) Municipal Commissioner or Chief Executive Officer, as the case may be, who shall be the Chairperson; and
- (b) such number of other members as may be prescribed, to be norminated by the appropriate Government, representing the local authority, medical officer of the local authority, the planning authority, traffic police, police, association of street vendors, market associations, traders associations, non-governmental organisations, community based organisations, resident welfare associations, banks and such other interests as it deems proper;
- (c) the number of members nominated to represent the non-governmental organisations and the community based organisations shall not be less than ten per cent.;
- (d) the number of members representing the street vendors shall not be less than forty per cent. who shall be elected by the street vendors themselves in such manner as may be prescribed:

Provided that one-third of members representing the street vendors shall be from amongst women vendors:

Provided further that due representation shall be given to the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, minorities and persons with disabilities from amongst the members representing street vendors.

- (3) The Chairperson and the members nominated under sub-section (2) shall receive such allowances as may be prescribed by the appropriate Government.
- 23. (1) The Town Vending Committee shall meet at such times and places within the jurisdiction of the local authority and shall observe such rules of procedure in regard to the transaction of business at its meetings, and discharge such functions, as may be prescribed.

Meetings of Town Vending Committee.

- (2) Every decision of the Town Vending Committee shall be notified along with the reasons for taking such decision.
- 24. (1) The Town Vending Committee may associate with itself in such manner and for such purposes, as may be prescribed, any person whose assistance or advice it may desire, in carrying out any of the provisions of this Act.
- (2) A person associated under sub-section (1) shall be paid such allowances as may be prescribed.
- 25. The local authority shall provide the Town Vending Committee with appropriate office space and such employees as may be prescribed.

Temporary association of persons with Town Vending Committee for particular purposes.

Office space and other employees for Town Vending Committee. Publication of street: vendor's charter and data-base and carrying out of social audit.

- **26.** (*I*) Every Town Vending Committee shall publish the street vendor's charter specifying therein the time within which the certificate of vending shall be issued to a street vendor and the time within which such certificate of vending shall be renewed and other activities to be performed within the time limit specified therein.
- (2) Every Town Vending Committee shall maintain up to date records of registered street vendors and street vendors to whom certificate of vending has been issued containing name of such street vendor, stall allotted to him, nature of business carried out by him, category of street vending and such other particulars which may be relevant to the street vendors, in such manner as may be prescribed.
- (3) Every Town Vending Committee shall carry out social audit of its activities under the Act or the rules or the schemes made thereunder in such form and manner as may be specified in the scheme.

### CHAPTER VIII

### PREVENTION OF HARASSMENT OF STREET VENDORS

Prevention of harassment by police and other authorities. 27. Notwithstanding anything contained in any other law for the time being in force, no street vendor who carries on the street vending activities in accordance with the terms and conditions of his certificate of vending shall be prevented from exercising such rights by any person or police or any other authority exercising powers under any other law for the time being in force.

### CHAPTER IX

### PENAL PROVISIONS

Penalty for contraventions

- 28. If any street vendor-
  - (a) indulges in vending activities without a certificate of vending;
  - (b) contravenes the terms of certificate of vending; or
- (c) contravenes any other terms and conditions specified for the purpose of regulating street vending under this Act or any rules or schemes made thereunder,

he shall be liable to a penalty for each such offence which may extend up to rupees two thousand as may be determined by the local authority.

### CHAPTER X

### MISCELLANEOUS

Provisions of this Act, not to be construed as conferring ownership rights, etc.

- 29. (1) Nothing contained in this Act shall be construed as conferring upon a street vendor any temporary, permanent or perpetual right of carrying out vending activities in the vending zones allotted to him or in respect of any place on which he carries on such vending activity.
- (2) Nothing contained in sub-section (1) shall apply to any stationery vendor, if a temporary leasehold or ownership right has been conferred on him by a lease deed or otherwise, in respect of a place at specific location where he carries on such vending activity in accordance with the provisions of any law for the time being in force for carrying out such vending activity.

Returns.

30. Every Town Vending Committee shall furnish, from time to time, to the appropriate Government and the local authority such returns as may be prescribed.

Promotional measures.

31. The appropriate Government may, in consultation with the Town Vending Committee, local authority, planning authority and street vendors associations or unions, undertake promotional measures of making available credit, insurance and other welfare schemes of social security for the street vendors.

32. The appropriate Government may, to the extent of availability of financial and other resources,—

Research, training and awareness.

- (a) organise capacity building programmes to enable the street vendors to exercise the rights contemplated under this Act;
- (b) undertake research, education and training programmes to advance knowledge and understanding of the role of the informal sector in the economy, in general and the street vendors, in particular and to raise awareness among the public through Town Vending Committee.
- 33. The provisions of this Act shall have effect notwithstanding anything inconsistent therein contained in any other law for the time being in force or in any instrument having effect by virtue of any law other than this Act.

Act to have overriding effect.

34. The appropriate Government may, by general or special order in writing, delegate such of its powers and functions under this Act (excluding the power to frame scheme under section 38 and power to make rules under section 36), as it may deem necessary, to the local authority or the Town Vending Committee or any other officer, subject to such conditions, if any, as may be specified in that order.

Powers to delegate.

35.(1) On the recommendations made by the appropriate Government or otherwise, if the Central Government is satisfied that it is necessary or expedient so to do, it may, by notification, amend the Schedules and thereupon the First Schedule or the Second Schedule, as the case may be, shall be deemed to have been amended accordingly.

Power to amend Schedules

- (2) A copy of every notification issued under sub-section (1), shall be laid before each House of Parliament as soon as may be after it is issued.
- **36.** (1) The appropriate Government shall, within one year from the date of commencement of this Act, by notification, make rules for carrying out the provisions of this Act.

Power to make rules.

- (2) In particular and without prejudice to the generality of the foregoing power, such rules may provide for all or any of the following matters, namely:—
  - (a) the age for street vending under sub-section (1) of section 4;
  - (b) the form, period and manner of filing appeal with the local authority under sub-section (I) of section 11;
  - (c) the persons and the experience such person shall have under sub-section (1) of section 20:
  - (d) the form and the manner of making application under sub-section (2) of section 20;
  - (e) the manner of verification and enquiry on receipt of grievance or dispute, the time within which and the manner in which steps for redressal of grievances and resolution of disputes may be taken under sub-section (3) of section 20;
  - (f) the form, the time within which and the manner in which an appeal may be filed under sub-section (4) of section 20;
  - (g) the time within which and the manner in which an appeal shall be disposed of under sub-section (5) of section 20;
  - (h) the term of, and the manner of constituting, the Town Vending Committee under sub-section (1) of section 22;
  - (i) the number of other members of the Town Vending Committee under clause (b) of sub-section (2) of section 22;
  - (j) the manner of elections among street vendors under clause (d) of sub-section (2) of section 22;
  - (k) the allowances to Chairperson and members under sub-section (3) of section 22;

- (1) the time and place for meeting, procedure for transaction of business at meetings and functions to be discharged by the Town Vending Committee under section 23;
- (m) the manner and the purpose for which a person may be associated under sub-section (1) of section 24;
- (n) the allowances to be paid to an associated person under sub-section (2) of section 24;
  - (o) the other employees of Town Vending Committee under section 25;
- (p) the manner of maintaining up to date record of all street vendors under sub-section (2) of section 26;
  - (q) the returns to be furnished under section 30;
- (r) the manner of publishing summary of scheme under sub-section (2) of section 38.
- (3) Every rule and scheme made by the Central Government under this Act shall be laid, as soon as may be after it is made, before each House of Parliament, while it is in session, for a total period of thirty days which may be comprised in one session or in two or more successive sessions, and if, before the expiry of the session immediately following the session or the successive sessions aforesaid, both Houses agree in making any modification in the rule or scheme or both Houses agree that the rule or scheme should not be made, the rule or scheme shall thereafter have effect only in such modified form or be of no effect, as the case may be; so, however, that any such modification or annulment shall be without prejudice to the validity of anything previously done under that rule or scheme.
- (4) Every rule or scheme made by the State Government under this Act shall, as soon as may be after it is made, be laid before each House of the State Legislature where there are two Houses, and where there is one House of the State Legislature, before that House.

Power to make byelaws.

- 37. Subject to the provisions of this Act or any rule or scheme made thereunder, the local authority may make bye-laws to provide for all or any of the following matters, namely:—
  - (a) the regulation and manner of vending in restriction-free-vending zones, restricted-vending zones and designated vending zones;
  - (b) determination of monthly maintenance charges for the civic amenities and facilities in the vending zones under section 17;
    - (c) determination of penalty under sub-section (5) of section 18 and section 28;
    - (d) the regulation of the collection of taxes and fees in the vending zones;
    - (e) the regulation of traffic in the vending zones;
  - (f) the regulation of the quality of products and services provided to the public in vending zones and maintenance of public health, hygiene and safety standards;
    - (g) the regulation of civic services in the vending zones; and
    - (h) the regulation of such other matters in the vending zones as may be necessary.

Scheme for street vendors.

- **38.** (1) For the purposes of this Act, the appropriate Government shall frame a scheme, within six months from the date of commencement of this Act, after due consultations with the local authority and the Town Vending Committee, by notification, which may specify all or any of the matters provided in the Second Schedule.
- (2) A summary of the scheme notified by the appropriate Government under subsection (1) shall be published by the local authority in at least two local news papers in such manner as may be prescribed.

**39.** (1) If any difficulty arises in giving effect to the provisions of this Act, the Central Government may, by order published in the Official Gazette, make such provisions, not inconsistent with the provisions of this Act, as appear to it to be necessary or expedient for removing the difficulty:

Power to remove.
difficulties.

Provided that no order shall be made under this section after expiry of three years from the commencement of this Act.

(2) Every order made under this section shall, as soon as may be after it is made, be laid before each House of Parliament.

### THE FIRST SCHEDULE

(See section 21)

### PLAN FOR STREET VENDING

### (1) The plan for street vending shall,—

- (a) ensure that all existing street vendors identified in the survey, subject to a norm conforming to two and half per cent. of the population of the ward, zone, town or city, as the case may be, are accommodated in the plan for street vending:
- (b) ensure the right of commuters to move freely and use the roads without any impediment;
- (c) ensure that the provision of space or area for street vending is reasonable and consistent with existing natural markets;
- (d) take into account the civic facilities for appropriate use of identified spaces or areas as vending zones;
- (e) promote convenient, efficient and cost effective distribution of goods and provision of services;
- (f) such other matters as may be specified in the scheme to give effect to the plan for street vending.
- (2) The plan for street vending shall contain all of the following matters, namely:—
  - (a) determination of spatial planning norms for street vending;
  - (b) earmarking of space or area for vending zones;
- (c) determination of vending zones as restriction-free-vending zones, restrictedvending zones and no-vending zones;
- (d) making of spatial plans conducive and adequate for the prevalent number of street vendors in that city or town and also for the future growth, by adopting such norms as may be necessary;
- (e) consequential changes needed in the existing master plan, development plan, zonal plan, layout plan and any other plan for accommodating street vendors in the designated vending zones.
- (3) Declaration of no-vending zone shall be carried out by the plan for street vending, subject to the following principles, namely:—
  - (a) any existing market, or a natural market as identified under the survey shall not be declared as a no-vending zone;
  - (b) declaration of no-vending zone shall be done in a manner which displaces the minimum percentage of street vendors;
  - (c) overcrowding of any place shall not be a basis for declaring any area as a no-vending zone provided that restrictions may be placed on issuing certificate of vending in such areas to persons not identified as street vendors in the survey;
  - (d) sanitary concerns shall not be the basis for declaring any area as a no-vending zone unless such concerns can be solely attributed to street vendors and cannot be resolved through appropriate civic action by the local authority;
  - (e) till such time as the survey has not been carried out and the plan for street vending has not been formulated, no zone shall be declared as a no-vending zone.

### THE SECOND SCHEDULE

(See section 38)

Matters to be provided in the Scheme for Street Vendors framed by the appropriate Government:—

- (a) the manner of conducting survey;
- (b) the period within which certificate of vending shall be issued to the street vendors identified under the survey;
- (c) the terms and conditions subject to which certificate of vending may be issued to a street vendor including to those persons who wish to carry on street vending during the intervening period of two surveys;
- (d) the form and the manner in which the certificate of vending may be issued to a street vendor;
  - (e) the form and manner of issuing identity cards to street vendors;
  - (f) the criteria for issuing certificate of vending to street vendors;
- (g) the vending fees to be paid on the basis of category of street vending, which may be different for different cities;
- (h) the manner of collecting, through banks, counters of local authority and counters of Town Vending Committee, vending fees, maintenance charges and penalties for registration, use of parking space for mobile stalls and availing of civic services;
  - (i) the period of validity of certificate of vending;
- (j) the period for which and the manner in which a certificate of vending may be renewed and the fees for such renewal;
  - (k) the manner in which the certificate of vending may be suspended or cancelled;
- (l) the categories of street vendors other than stationery vendors and mobile vendors;
- (m) the other categories of persons for preference for issue of certificate of vending;
- (n) the public purpose for which a street vendor may be relocated and the manner of relocating street vendor;
  - (o) the manner of evicting a street vendor;
  - (p) the manner of giving notice for eviction of a street vendor;
  - (q) the manner of evicting a street vendor physically on failure to evict;
- (r) the manner of seizure of goods by the local authority, including preparation and issue of list of goods seized;
- (s) the manner of reclaiming seized goods by the street vendor and the fees for the same;
- (t) the form and the manner for carrying out social audit of the activities of Town Vending Committee;
- (u) the conditions under which private places may be designated as restriction-free-vending zones, restricted-vending zones and no-vending zones;

- (v) the terms and conditions for street vending including norms to be observed for up keeping public health and hygiene;
- (w) the designation of State Nodal Officer for co-ordination of all matters relating to street vending at the state level;
- (x) the manner of maintenance of proper records and other documents by the Town Vending Committee, local authority, planning authority and State Nodal Officer in respect of street vendors;
  - (y) the manner of carrying out vending activities on time-sharing basis;
- (z) the principles for determination of vending zones as restriction-free-vending zones, restricted-vending zones and no-vending zones;
- (za) the principles for determining holding capacity of vending zones and the manner of undertaking comprehensive census and survey;
  - (zb) principles of relocation subject to the following:-
  - (i) relocation should be avoided as far as possible, unless there is clear and urgent need for the land in question;
  - (ii) affected vendors or their representatives shall be involved in planning and implementation of the rehabilitation project;
  - (iii) affected vendors shall be relocated so as to improve their livelihoods and standards of living or at least to restore them, in real terms to pre-evicted levels;
  - (iv) livelihood opportunities created by new infrastructure development projects shall accommodate the displaced vendors so that they can make use of the livelihood opportunities created by the new infrastructure;
  - $(\nu)$  loss of assets shall be avoided and in case of any loss, it shall be compensated;
  - (vi) any transfer of title or other interest in land shall not affect the rights of street vendors on such land, and any relocation consequent upon such a transfer shall be done in accordance with the provisions of this Act;
  - (vii) state mechinery shall take comprehensive measures to check and control the practice of forced evictions;
  - (viii) natural markets where street vendors have conducted business for over fifty years shall be declared as heritage markets, and the street vendors in such markets shall not be relocated;
- (zc) any other matter which may be included in the scheme for carrying out the purposes of this Act.

The Section 36 of the Act provides for framing of Rules within one year of commencement of the Act. Further, Section 38 (1) of the Act, read with Extraordinary gazette (Removal of Difficulty) dated 1st December 2015, prescribes the appropriate government to frame the Scheme within six months from the commencement of said Rules.

- 2. You would appreciate that a number of references have been sent by MoHUPA for framing of subordinate legislation by your State/UT at the earliest. The last such letter dated 02.09,2016 was sent from Economic Advisor and was addressed to Chief Secretary.
- As intimated earlier, the Committee on Subordinate Legislation of Rajya Sabha is closely monitoring the progress and it has taken a serious view on nonadherence to the prescribed timelines. Earlier extension granted by the Committee expired on 30th September 2016. Now, it has granted an extension of only one month i.e. up to 7th November 2016 for completion of the subordinate legislation under the Act.
- 4. In view of the above, I would request you once again to ensure immediate action for finalization and notification of the Rules / Scheme under the said Act by 7th November, 2016 and apprise this Ministry.



# Operational Guidelines for the Support to Urban Street Vendors



Ministry of Housing & Urban Poverty Alleviation Government of India These are operational guidelines for Component 5: "Support to Urban Street Vendors" of the National Urban Livelihoods Mission (NULM) only. To be read along with the Mission Document / Main Guidelines of NULM, and may make reference to operational guidelines of other components of NULM.

#### **Support to Urban Street Vendors**

#### 1. Context of the Component

- 1.1 Street vendors constitute an important segment at the bottom of the pyramid of the informal economy in cities. Street vending provides a source of self-employment, and acts as a measure of urban poverty alleviation. Street vending also has a prominent place in the urban supply chain, and provides inexpensive and convenient access to goods and services to all segments of the population including the poor. Street vending is therefore an integral part of the economic growth process in urban areas.
- 1.2 Low levels of education and skills, and limited access to formal credit and micro enterprise support constrain street vendors' ability to access emerging market opportunities. On account of being unorganised and self-employed, street vendors and their families often lack in any linkage to social security, welfare and assistance schemes and initiatives of the Government. This makes street vendors and their families vulnerable in difficult times, or when they may require assistance for unforeseen expenses.
- 1.3 In this context, the National Urban Livelihoods Mission (NULM) seeks to address the concerns of urban street vendors by facilitating access to suitable spaces for vending, institutional credit, improved skills and social security linkages. The Support to Urban Street Vendors Component of NULM sets out the strategy and operational guidelines with regard to this component.

#### 2. Objectives

- 2.1 The objective of the componentis to address the vulnerabilities of the urban street vendors through amulti-prongedapproach. This includes:
- (i) Survey of street vendors and issue of Identity Cards
- (ii) Development ofcity street vending plans
- (iii) Infrastructuredevelopment of vending zones in the city
- (iv) Training and Skill Development
- (v) Financial Inclusion
- (vi) Access to credit
- (vii) Linkages to social security schemes

#### 3. Role of State Government, Local Authority and Planning Authority

- 3.1 The State Government shall have overall responsibility for:
- (i) Providing overall direction.
- (ii) Establishing mechanisms for sanction of project proposals.
- (iii) Establishing mechanisms for Monitoring and supervision of implementation.
- (iv) Establishing mechanisms for progress reporting.
- 3.2 The State Urban Livelihood Mission(SULM) will be the nodal agency responsible for overall implementation of the component. At the city level, the responsibility for implementation will rest with the Urban Local Body.
- 3.3 The implementation would also require coordination between several authorities including Urban Local Bodies, Development Authorities and Town Planning Agencies, Land & Revenue Departments and District Collector offices. This coordination will be ensured by the State Government and the ULB.
- 3.4 The ULB will consult and coordinate with the planning authority, which could be an Urban Development Authority or any other authority in a city or town responsible for regulating land use in the city. The role of the town planning authority

in the implementation of the scheme will include preparation and notification of provending land use plans, and for providing land and development approval for vendors' markets.

3.5 Other agencies such as the Revenue Department, the Police Department and Public Health and Engineering Department (or Water Board) may be required to provide support and assistance to the local authority to facilitate the implementation of the component.

#### 4. Sub Components

#### Sub-Component 1: Survey and Issue of Identity Cards

- 4.1 Under this sub-component, financial support will be provided to the ULBs for conduct of survey for identification and enlisting of street vendors. The survey should preferably be conducted on a whole city basis. Alternatively, the ULB may also choose to complete the survey in a phased manner, covering one area (ward/zone/specified part of city) at a time. In this case, the area identified should be sufficiently large to accommodate mobility of vendors within the area.
- 4.2 The survey must cover all street vendors in the area being surveyed. ULB will develop methodology for conducting the survey. At a minimum, the survey must include:
  - Name
  - · Name of parents
  - · Permanent Address
  - Present Address
  - Identity proof (if any)
  - Telephone number (if any)
  - · Place of vending
  - Type of vending activity
  - Time/Duration of engagement as a vendor
  - · Details of family members

 If identified as beneficiary/poor for any of the government schemes like Food Security Act, TPDS, SJSRY etc. Details thereof

During the survey, the original documents pertaining to present/permanent address proof, especially in the case of migratory population may also be verified so that the Identity Cards issued to the surveyed street vendors can act as sufficient documentation for opening of their bank accounts, getting loans from banks, accessing social security benefits, etc.

- 4.3 The ULB will issue Identity Cards to all the surveyed/identified street vendors. A data base of all street vendors will be maintained by the ULB. Since the vendors are mobile, the software should be able to track (based on either present/permanent address or any other criteria) whether the vendor has already been covered and issued an Identity Card.
- 4.4 The State or ULB may engage an agency through an RFP following a transparent process of selection to carry out survey of street vendors. In case the ULB issues the RFP, the shortlisted proposals must be sent to the Sanctioning Committee of SULM for consideration and approval. The ULB may also propose alternative methods of survey, such as through community participation or with the support of NGOs or government or research agencies. Such proposals too will need approval of the Sanctioning Committee of SULM.

#### Sub-Component 2: Preparation of City Street Vending Plan

- 4.5 Under this sub-component, financial support will be provided to the ULB for preparation of City Street Vending Plan which will contain the following:
  - (i) profile of street vending trades and activities;
  - (ii) spatial distribution of street vending activities;
  - (iii) earmarking of space or area for vending zones;
  - (iv) determination of vending zones as restriction- free-vending zones, restricted-vending zones and no-vending zones;

- estimates of holding capacity of vending zones, which is the maximum number of street vendors who can be accommodated in any vending zone;
- (vi) understanding of key challenges, constraints and issues relating to street vending; and
- (vii) Possible solutions and potential street vending areas.

The Street Vending Plan will also take into account the natural markets where sellers and buyers naturally congregate for the sale and purchase of products and services. The Plan will be developed after consultations with Street Vendor's representatives and other relevant stakeholders.

- 4.6 While preparing the Street Vending Plan, the ULB, in coordination with the city police, traffic police, planning authority and other local agencies, should also devise and promote vendor friendly policies, solutions and strategies to accommodate and facilitate street vending in a manner that is conducive to street vendors and the public at large. This may include policies for traffic management and regulation on market days or at certain times of the day, and arrangements for lighting, water, sanitation and waste disposal in street vendor market areas. The ULB may coordinate with planning authorities to develop pro-vending norms and stipulation of vending spaces in new or refurbished roads, markets, office and residential complexes and other public spaces and public infrastructure. This will ensure greater acceptability of Street Vending Plans among the stakeholders.
- 4.7 The ULB should make every effort to minimise disruption to existing markets while developing the city street vending plan. Accordingly, the plan may be developed in such a manner that no relocation or eviction of street vendors takes place. Re-location of street vendors, if required, must be based on consultation with the affected vendors.
- 4.8 Based on the survey findings, the City Street Vending plan may also include a digitised or non-digitised map of vending activities, vending trades and existing markets at ward or zone level.

4.9 For preparing the City Street Vending Plan, the SULM/ ULB may engage consultants/ agency hired through a selection process as defined in 4.4 above and the work may be awarded after approval by the Sanctioning Committee of SULM. City Street Vending Plans will be submitted to the SULM for approval, and will be considered final once approved by SULM. SULM will also ensure that these plans are integrated into development plans of the city as per requirement of the law and procedures.

#### Sub-component 3: Infrastructure Improvement

- 4.10 Under this sub-component, financial support will be provided to the ULBs for improvement of infrastructure and provision of basic services in the existing markets of street vendors. The ULBs will prepare a Detailed Implementation Plan (DIP) for such infrastructure improvement projects which may include improved civic facilities such as paving, water supply, toilets, waste disposal facility, lighting, common storage space, specialized carts for specific types of trades, temporary sheds and/or parking facilities. The infrastructure requirements for vendors markets will be assessed based on consultations with street vendors and their associations, local agencies and other stakeholders and will be facilitated by the ULB.
- 4.11 The DIP for infrastructure improvement must be prepared only after the street vendor survey for the area where the project is located, has been completed. In exceptional cases where the survey is not initiated and the ULB feels that there is an immediate need for a project, which will benefit a large number of street vendors, then the survey for that area along with its cost may be included in the DIP. The ULB must ensure that prior to commencing work on the project, the street vendors who will benefit, have been issued the Identity Card as well as the Street Vending Certificate as per the prevailing policy, Act or guidelines of the state. The list of beneficiaries of the project should be placed in the public domain and displayed on the notice board of the ULB and posted on the website of the ULB/State before taking up the project.
- 4.12 While preparing the DIP, provision for providing specialized carts to the street vendors for specific types of trades such as food vending etc. may be included with a

view to improve the hygiene and optimal utilization of space. These carts may be funded through individual loans covered under the SEP component of NULM.

#### 4.13 DIPs should contain:

- (i) Project rationale, details of beneficiaries and stakeholders, how it will contribute to improved street vending in the surrounding area, and how it fits within the overall City Street Vending Plan
- (ii) Land ownership details
- (iii) Relocation plan, if any must be supported by a letter of consent from the affected street vendors and/or their association
- (iv) Specific infrastructure improvement project details with costs, including operations and maintenance plan
- (v) Detailed and complete list of beneficiaries who will benefit from the project in case the survey is not complete and will be conducted as part of the DIP, the list of beneficiaries will have to be provided upon completion of the survey and prior to commencement of infrastructure improvement. SULM may release the second installment of funds for the project, contingent on the list of benficiaries.
- (vi) Safety concerns, if any, relating to fire hazard or other hazards.
- 4.14 The ULB may also develop DIP for creation of "food streets", "farmers markets", "night market" and other such specialised/theme based markets subject to the provisions stipulated above. In markets where food will be prepared in the market, the ULB should take into account issues of food safety and fire hazard in addition to other elements of infrastructure improvement that will be required.
- 4.15 For preparation of DIPs, the ULB may hire consultants using a process similar to 4.4 above. DIPs must be submitted to the Sanctioning Committee of SULM for approval.

#### Subcomponent 4: Training and Skill Development

- 4.16 The ULB will conduct one to two days training programmes for all street vendors taking one area at a time. The aim of this program will be to orient the street vendors on aspects such as their rights and responsibilities, specific policies or laws related to street vendors, food safety, maintenance of hygiene, waste disposal, etc.
- 4.17 Modules for training, IEC material and workshops may be developed/organised by the SULM/ULB in partnership with any resource agency identified by them. Delivery of training may be outsourced to a training institute, a specialized agency such as Food Safety and Standards Authority of India or a reputed NGO.
- 4.18 Street vendors who undergo a training programme/workshop will be paid a daily amount as stipend for number of days attended, and calculated based upon opportunity cost of livelihood. This daily stipend should not be less than the minimum wage applicable in the State for urban areas. The training cost should also include trainer fee, food, and travel cost, subject to a maximum of Rs. 750 per person per day. Cost of conducting such specialised training programmes for the street vendors will be met from the Employment through Skill Training and Placement (EST&P) component of NULM.
- 4.19 Reports of training conducted and feedback from participants of the training programme will be submitted by the ULB on a monthly basis.

#### Sub-component 6: Financial Inclusion

4.20 Street vendors are often unable to access organised banking services as they lack identity documents, proof of address, tenure or legal rights over their place or business and evidence of their trades and professions. It is envisaged that the Identity Cards issued to street vendors under this scheme will help promote access to banking services. SULM and ULBs will liaise with banks and other financial institutions to facilitate access to banking and financial services based on documents issued to street vendors by the ULBs.

- 4.21 The SULM at state level will include financial inclusion of urban street vendors as a separate agenda in State Level Bankers Committee (SLBC) and District Consultative Committee (DCC) meetings. The aim of inclusion will be to ensure that all street vendors have bank accounts and are included in financial literacy programmes organized by the banks.
- **4.22 Financial Literacy:** The ULB will organise sessions on financial literacy for identified street vendors with support of resource organisation and field staff. In these sessions the street vendors will be made aware about the savings, credit, insurance etc., along with the modalities and operational requirements for accessing the same. The banks and financial Institutions may be encouraged to communicate with the street vendors through City Livelihoods Centre (CLC), camps etc. The ULB will do the necessary coordination with the Lead District Manager (LDM) of the Lead Bank and Financial Literacy & Credit Counseling Centers (FLCCs) of the banks to organise financial literacy sessions and camps.
- 4.23 Opening of Basic Savings Bank Deposit Account: This includes opening of Basic Savings Bank Deposit Accounts for all the identified street vendors. The SULM in discussion and coordination with respective SLBC convenor bank, ULB, DCC and LDM will ensure the following:
  - Provide the Lead District Manager of the Lead Bank and DCC with the list of identified street vendors to be covered at city level
  - Operational formalities such as availability of forms at all the branches/ extension counter of the banks, CLCs, &ULB office.
  - Organise camps within the respective jurisdiction of banks for opening up of accounts with support of ULB field staff and Resource Organisation.
  - Engagement of Business correspondents (BC)/Business Facilitators by banks as per the requirement of the city for better outreach.

#### Sub-component 7: Access to Credit

Access to credit to fulfil the working capital requirement of the street vendors includes facilitating access to loans to the street vendors from banks. It will also

focus on facilitating access to credit cards to identified individual street vendors to meet their working capital requirements.

- 4.24 Access to Credit: The Self Employment Programme-Individual Enterprises (SEP-I) component of NULM provides financial assistance to urban poor in the form of Interest subsidy on bank loans for setting up individual enterprises. In accordance with SEP guidelines, loans can be made available to the identified urban poor street vendors at 7% rate of interest. The modalities and procedure for availing loans for poor street vendors will be similar as detailed out in SEP-I component.
- 4.25 It is envisaged that other street vendors interested in availing loans for their enterprise, will be facilitated for loan linkages with banks by the ULB. The ULB will identify such street vendors and will thereafter take their intent for loan requirement and route their application for further processing by banks.
- 4.26 Credit Card for Urban Street Vendors: The ULB will also facilitate credit cards for eligible urban street vendors to meet their working capital and miscellaneous credit needs. The ULB will identify the prospective street vendors and will facilitate linkages with banks for issuance of credit cards. The focus is to initially facilitate issuance of existing credit cards of banks such as General Credit Card (GCC) or any other variant of credit card for micro enterprise development to the urban street vendors.
- 4.27 The Ministry of HUPA will also explore the possibility of devising an exclusive Credit Card Scheme for Urban Street Vendors in consultation with Department of Financial Services, Reserve Bank of India and other banks.

#### Sub-component 8: Linkage with Social Security Schemes

4.28 In order to bring the street vendors within the ambit of social insurance and to provide coverage from risks/ uncertainties ULBs will facilitate enrolment of street vendors in insurance schemes of Government of India such as Rashtriya Swasthya Bima Yojana (RSBY) for health insurance, Aam Aadmi Bima Yojna (erstwhile Janashree Bima Yojna) for Life Insurance or any state specific insurance schemes. However, the enrolment in any insurance scheme by ULB should be as per the free will of the street vendors.

4.29 The ULB will also promote awareness and facilitate enrolment of street vendors in other social security, welfare and social assistance schemes of state and central government.

#### 5. Sanctioning Committee at the State Urban Livelihoods Mission

There would be a Sanctioning Committee under the chairmanship of Principal Secretary/Secretary in-charge of NULM at the State level with representatives of other concerned departments in the State for consideration and approval of proposals submitted by ULBs/SULM under this component of NULM. A representative of the Ministry of HUPA shall be a member of this Sanctioning Committee.

#### 6. Monitoring and Evaluation

- 6.1 The SMMU at the State level and CMMU at the ULB level will closely monitor progress of activities / targets under this component, undertake reporting and evaluation. The SULM and the ULB/executing agencies shall report timely progress in formats prescribed by the Mission Directorate from time-to-time, indicating the cumulative achievement monthly and up to the end of the quarter and key issues in implementation.
- 6.2 In addition, under NULM, a comprehensive and robust IT-enabled NULM MIS will be established for tracking targets and achievements. States and ULBs will be required to submit their progress reports online and may also use this tool to monitor progress on the ground. In the spirit of proactive disclosure of information and ensuring transparency under NULM, key progress reports under SUSV will also be made available in the public domain in a timely manner.

#### 7. Funding Pattern

Up to 5% of the total NULM allocation of the State can be spent on implementation of this component of NULM (excluding any cost incurred on training and access to credit which will be met from EST&P and SEP components respectively). Funding

pattern of Central and State share will be in the ratio of 75:25. In case of north eastern states (Arunachal Pradesh, Assam, Manipur, Meghalaya, Tripura, Mizoram, Nagaland, Sikkim) and special category states (Jammu and Kashmir, Himachal Pradesh and Uttarakhand) this will be in the ratio of 90:10.

I am directed to inform you that Hon'ble Supreme Court in the matter of Maharashtra Ekta Hawkers Union and another vs. Municipal Corporation, Greater Mumbai and others has passed an order on the issues related to the street vendors in urban areas. As per the said order of Hon'ble Supreme Court, following actions to be taken:-

- The task of constitution of Municipal Vending Committee shall be completed within 2 months from issuance of this order.
- (II) The process of Registration of street vendors to be completed within 4 months from issuance of this order.

In view of above, I am directed to enclose the following guidelines and to request you to implement the orders of Hon'ble Supreme Court within the stipulated time line mentioned above and to send the report of compliance to the Municipal Affairs Department and Director, State Urban Development Agency, West Bengal at an early date.

These directions will remain valid until further order.

# **GUIDELINES FOR REGULATING STREET VENDING IN THE URBAN AREAS**

#### MUNICIPAL VENDING COMMITTEE

# 1. Constitution of Municipal Vending Committee

- 1.1 Each Urban Local Body, shall constitute a Municipal Vending Committee.
- 1.2 Each Municipal Vending Committee shall consist of
  - (a) The Municipal Commissioner or the Commissioner, in case of Municipal Corporations or the Executive Officer, in case of Municipalities, Notified Area Authorities and Industrial Township constituted under the West Bengal Municipal Act, 1993 (West Bengal Act XXII of 1993), as the case may be, who shall be the Chairperson; and
  - (b) Such number of other members will be nominated by the concerned Urban Local Body, representing the Urban Local Body, the Planning Authority, local police, association of street vendors, traders' associations, resident's associations, Representatives of lead banks and such other interests as it deems proper and the concerned Urban Local Body will nominate such member by adopting a fair & transparent mechanism.

Provided that the number of members nominated to represent the street vendors shall not be less than 25% of the total number of members and one-third of such members shall be from amongst women:

(c) The maximum no. of such member will be 12 from the ULBs having population less than 2 lakh; 15 from the ULBs having population upto 5 lakh and 18 from the ULBs having population more than 5 lakh.

Provided further that reasonable representation may also be given to persons who are physically challenged.

- 1.3 The Chairperson or the member nominated, as noted above shall, unless his nomination is terminated earlier by the Urban Local Body, hold office for a term of maximum three years from the date of his nomination.
- 1.4 The Municipal Vending Committee may associate with itself, any person whose assistance or advice it may desire in carrying out the issues related to Street Vendors
- 1.5 A person so associated will have a right to take part in the discussions relevant to that purpose, but shall not have a right to vote at a meeting of the committee and shall not be a member for any other purpose.

#### 2. Meeting of the Committee

The Municipal Vending Committee shall meet at least once in every month at a place within the jurisdiction of the Urban Local Body and shall observe procedure in regard to the transaction of

business at its meetings, and in discharge of its functions, as may be decided by the concerned Urban Local Body.

#### 3. Functions if the Municipal Vending Committee

- 3.1 The Municipal Vending Committee, will submit its recommendations to the Urban Local Body concerned to:
- (a) grant, renew, suspend or cancel registration certificates to street vendors, in such form and manner, and on such terms and conditions, as may be determined by the concerned Urban Local Bodies;
- (b) specify the terms and conditions for issue, renew, suspension or cancellation of registration in the manner specified.
- (c) to determine the process to collect *fees* for registration or renewal of registration of street vendors as may be determined by the concerned Urban Local Body;
- (d) determine the manner of collecting fees through banks, counters of Urban Local Body or counters of Municipal Vending Committee, fee for registration, usage of parking space for mobile stalls and availing of civic services, in consultation with Urban Local Body;
- (e) identify and designate vending zones;
- (f) specify timings for vending in vending zones;
- (g) maintain the records of land, street, footpath, embankment, waiting area, parks and other public places designated for vending in such manner as may be specified;
- (h) conduct periodic surveys of vending zones;
- (i) collect and maintain data regarding street vendors;
- (j) determine quantitative norms for different categories of stationary and mobile stalls in the vending zones;
- (k) assess and determine maximum holding capacity of each vending zone;
- (I) identify and declare vending zones as restriction-free-vending zones, restricted-vending zones including day time vending zone & night time vending zone and no-vending zones in the manner specified;
- (m) fix sign boards at each vending zone to indicate kind of vending zone, its boundaries and vending timings.
- (n) monitor activities of street vendors:
- (o) ensure that the quality of products and services provided to the public and public health, hygiene and safety standards as specified by the Urban Local Body are maintained;
- (p) ensure that allotted stalls are utilized by the allottees in accordance with the terms and conditions specified.

- (q) determine actions including imposition of fine for violating the terms and conditions tor registration;
- (2) The Municipal Vending Committee, shall submit its recommendations to the Mayor, in the case of Municipal Corporation, and to the Chairman in the case of ULBs other than Municipal Corporations. Acceptance or rejection of the recommendations made by the Municipal Vending Committee shall be subject to confirmation or modification by the Mayor-in-Council of the Municipal Corporation in the case of Municipal Corporations, and, in the case of Urban Local Bodies other than the Municipal Corporations, by the Board of Councillors of the Municipalities or Notified Area Authorities or by the Authority of the Industrial Townships, as the case may be.

#### 4. REGISTRATION OF STREET VENDORS

#### 4.1 Application for registration

- a) Every person who has completed the age of 18 years and intends to do street vending may make an application for registration as street vendor to the Municipal Vending Committee, provided that the persons who have been carrying out business prior to issuance of the guideline, shall immediately after constitution of Municipal Vending Committee for the respective ULB, shall make application for their registration.
- b) Every application shall be made in such form and manner and accompanied by such fee as may be determined by the concerned Urban Local Bodies.

#### 4.2 Registration for street vendors

- a) An application made under Para-4.1(a) above, shall be examined by the Municipal Vending Committee and the registration to made within such period, and in such manner, as may be determined by the concerned Urban Local Bodies within four months from the issuance of this guideline as mentioned by the Hon'ble Supreme Court in the order.
- b) The Municipal Vending Committee shall not summarily reject the application without giving the applicant an opportunity to rectify deficiencies, if any, and hearing him.
- c) If the Municipal Vending Committee is satisfied that the application is in compliance with the provisions of this guideline, it shall send its recommendation to the ULB to register the name of the street vendor.
- d) After receiving the recommendation from the Municipal Vending Committee, the ULB may accept the recommendation and grant registration on payment of such fee as may be decided by the Urban Local Body; but not more than Rs. 250/- and subject to such terms and conditions as may be determined by the Urban Local Body in consultation with the Municipal Vending Committee.

- e) Any person aggrieved by the decision of the Municipal Vending Committee may, prefer an appeal to the Urban Local Body within such period, and in such manner, as may be decided by the Urban Local Bodies.
- f) Once registered, he may continue to do so within the period of registration is over & unless renewed.
- g) Physically challenged who were allowed to operate PCOs in terms of the judgement reported in (2009) 17 SCC 231 shall be allowed to continue to run their stalls and sell other goods because running of PCOs is no longer viable. Those who were allowed to run Aarey/ Sarita shall be allowed to continue to operate their stalls.

#### 5. DUTIES OF URBAN LOCAL BODIES

#### 5.1 Duties of Local Authorities

Urban Local Body shall be responsible for:-

- (a) Overall supervision and monitoring of the Scheme for street vendors,
- (b) Monitoring effective functioning of the Municipal Vending Committee;
- (c) Allotting spaces to the street vendors in the manner specified;
- (d) Granting, renewal, suspension or cancellation of license to the registered street vendors in the manner specified;
- (e) Providing, in consultation with the Municipal Vending Committee, in the vending zones and to the street vendors, civic services.

#### 6. BREACHES OF CONDITIONS AND PENALTY

#### 6.1 Cancellation or suspension of registration

a) Where any street vendor who has been registered or his agent or servant commits breach of any of the conditions thereof or any other terms and conditions determined by the concerned Urban Local Bodies for the purpose of regulating street vending or where the Municipal Vending Committee is satisfied that such registration has been secured by the street vendor through misrepresentation or fraud, the Urban Local Body may, cancel the registration or suspend the same for such period as it thinks fit;

Provided that no such cancellation or suspension shall be made by the *Urban Local Body* unless an opportunity of hearing has been given to the street vendor by the Municipal Vending committee.

#### 6.2 Penalty for contraventions

If any street vendor-

- (a) Indulges in street vending without registration;
- (b) Vends beyond the designated vending zones or specified timings;
- (c) Vends goods or offers services that are detrimental to public health;

- (d) Contravenes the terms and conditions of registration;
- (e) Contravenes the terms and conditions of allotment of stall or license; or
- (f) Contravenes any other terms and conditions determined by the concerned Urban Local Bodies. for the purpose of regulating street vending he shall be liable to a penalty which shall not be exceeding rupees five hundred, as may be determined, or as the case may be, by the Urban Local Body in consultation with the Municipal Vending Committee.

#### 7. Supervision by the State Government

- 7.1 In case of the urban local bodies, excepting Kolkata Municipal Corporation, Director of Local Bodies or the District Magistrate or the Sub-divisional Magistrate or the District Municipal Development Officer; and in the case of Kolkata Municipal Corporation, any officer of Department of Municipal Affairs, Government of West Bengal, not below the rank of Joint Secretary, may—
- (a) inspect, or cause to be inspected, any immovable property owned, used or occupied by the Urban local body or any work in progress;
- (b) inspect or examine any department of the urban local body or any office, service, work or thing under the control of the Urban local body;
- (c) record, in writing, for the consideration of the urban local body, any observation he thinks proper in regard to the proceedings or duties of any of the municipal authorities.
- 7.2 For the purpose of inspection or examination, in the case of the urban local bodies other than Kolkata Municipal Corporation, the Director of Local Bodies or the District Magistrate or the Subdivisional Magistrate or the District Municipal Development Officer; and in the case of Kolkata Municipal Corporation the officer of Department of Municipal Affairs, Government of West Bengal, not below the rank of Joint Secretary, may require the Chairman or any officer of the urban local body—
- (a) to produce any book, record, correspondence, plan or other document,
- (b) to furnish any return, plan, estimate, statement, account or statistics, or
- (c) to furnish or obtain any report.
- 7.3 When a requisition is made as per 7.2, the Mayor/Chairman or any officer of the Urban local body, as the case may be, shall comply with such requisition.
- 7.4 Power of State Government to call for documents, returns or information from Chairman or any officer of Urban local body

The State Government may, at any time, -

(a) call for any document in the possession or under the control of the Chairman or any officer of the Urban local body;

(b) require the Mayor/ Chairman or any officer of the Urban local body to furnish any return, plan, estimate, statement, account, report of statistics, or any information whatsoever.

#### 7.5 Power to suspend action

a) The State Government may and after giving the Urban local body a reasonable opportunity of being heard, annul any proceeding or resolution or order which it consider to be not in conformity and may take possible measure necessary to secure such conformity:

Provided that pending the hearing to be given to the urban local body, the State Government may suspend the operation of such proceeding or resolution or order.

b) The State Government, on receiving any information that any urban local body is about to pass an order or instruction in excess of any power, may forthwith prohibit the passing of such order or instruction and such prohibition shall be binding on the Urban local body:

Provided that the State Government shall immediately thereafter give an opportunity to the Urban Local Body to make its representation in the matter upon which the State Government shall give its final order with reasons in writing.

#### 7.6 Directions by the State Government

- a) In the discharge of their functions, the urban local bodies shall be guided by this set of guidelines or as may be issued by the State Government time to time.
- b) If such duty is not performed within the period so fixed, the State Government may, in the public interest, by order do, or cause to be done by any Officer of the State Government or any authority appointed by it, anything for due performance of such duty notwithstanding anything to the contrary contained in any other law for the time being in force.

# Urban Street Vendor Policy in West Bengal

- On the basis of National Policy on Urban Street Vendor 2009 as circulated by Ministry of Housing & Urban Poverty Alleviation a policy on "The West Bengal Street Vendor" was prepared by Department of Municipal Affairs, Government of West Bengal in 2010.
- Ministry of Housing & Urban Poverty Alleviation had circulated Model Street Vendors (Protection of Livelihood and Regulation of Street Vending) Bill, 2009 and advised the State Government to frame a policy and an Act for the purpose.
- ➤ A case was filed before Hon'ble Supreme Court by the Street Vendors for their rights and Hon'ble Supreme Court endorsed the Model Bill prepared by the Ministry of Housing & Urban Poverty Alleviation and directed that within the 30<sup>th</sup> June,2011 the appropriate Government is to legislate and bring out the law to regulate hawking and hawkers' fundamental right.

- ➤ Accordingly a Model Bill "The West Bengal Urban Street Vendors (Protection of Livelihood and Regulation of Street Vending) Bill, 2011 has been prepared and sent to Law Department for necessary vetting.
- ➢ Meanwhile a High-Powered Committee on Street Vendors has been constituted by the State Government with Ministerin-Charge, Labour Department as Chairman and Ministers of Municipal Affairs & Urban Development Department, Commerce & Industries Department, Panchayat & Rural Development Department and Mayor, Kolkata as members, in order to look into the various issues on hawkers', has been constituted vide this Department Notification No.98/MA/O/C-4/1A-10/2011 dated 23.02.2012.

- > The High Powered Committee shall consider the followings:
- o Identification of hawkers/ vendors : particular issues under reference are duration, dallas and places
- Issues relating to placement of unidentified hawkers/ vendors
   warranted action for the same.
- o Issues related to expeditious action on issuance of trade license by the Urban Local Bodies.
- o Matters relating to immovable or fixed structure for the street vendors: actions warranted thereon.
- o Issues in the context of entertaining movable or improvised structure for the Street Vendors.
- o Matters related to expeditious actions by the licensing authority on all renewal mechanism.

- o Issues related to demarcation of vending zone : distinction between hawking/ vending zone and no hawking/ vending zone i.e. green zone.
- o Issues connected with identification of green zone in the surroundings of the premises like hospitals, schools, cultural building campus Rabindra Sadan and such.
- o Issues related to activation of police authorities for certification of hawkers based on jurisdiction.

A meeting on the proposed Central Law on Street Vending was held on 12th March, 2012 at Nirman Bhavan, New Delhi under the Chairmanship of - Secretary, Ministry of HUPA, Govt. of India. As directed, the undersigned attended the meeting and position relating to Urban Street Vendors issues in West Bengal were discussed (copy of report submitted in GoI meeting is placed under Flag -'A'). During the discussion in the meeting it was learnt that the Govt. of India has recently issued letters to the State Govt. i.e. D.O. No. E-14015/1/2011-USD dated 29th February, 2012 from the Hon'ble Minister of HUPA, Govt. of India, addressed to the Hon'ble Chief Minister of West Bengal and other States, followed by D.O. No. E-14015/1/2011-USD dated 29.2.2012 from the Secretary, Ministry of HUPA, Govt. of India, addressed to the Chief Secretary of Govt. of West Bengal and others, seeking views/ comments/observations on the draft bill titled 'The Street Vendors (Protection of Livelihood and Regulation of Street Vending) Bill, 2012 already circulated by the GoI to all the States. It was further requested in the above mentioned letter of Secretary, Ministry of HUPA, GoI, to send the views/comments/observations of the State by 10.3.2012. It was informed to the GoI officials present in the meeting that Govt. of West Bengal in the Department of Municipal Affairs vide Notification No. 98/MA/O/C-4/1A-10/2011 dated 23rd February, 2012 has constituted a High Power Committee on Street Vendors/Hawkers under the Chairmanship of Hon'ble Minister, Labour Department and a model bill "The West Bengal Urban Street Vendors (Protection of Livelihood and Regulation of Street Vending) Bill, 2011" has been prepared and sent to Law Department for necessary vetting. However it was requested in the meeting that the State should send their views/ comments/observations within the next 2-3 days along with indication whether the State will opt for the proposed Central Act or go by its own Act, with necessary amendments.

In view of the above, necessary action may be taken from Municipal Affairs Department for sending the above views/comments/observations as requested by Govt. of India. The photocopies of abovementioned D.O. letters and draft Central Bill (as received in the meeting) are placed under Flag – B, C & D for kind perusal.

Dear Shri Okram Ibobi Singh ji,

You may kindly recall that the Government of India had comprehensively revised the National Policy on Urban Street Vendors in 2009. The revised policy proposed promoting a congenial environment for the urban street vendors to carry out their activities smoothly and providing a mechanism for regulation of such activities in cons on ance with public interest. The revised Policy also underscored the need for a legis lative framework to enable street vendors to pursue an honest living without harassment from any quarter. Accordingly, Model Street Vendors (Protection of Livelihood and Regulation of Street Vending) Bill, 2009 was also circulated along with the revised policy to all States/UTs, requesting them to take a cue from it while legis lating on the subject.

- I would like you to refer to the letter of Hon'ble Prime Minister dated 4th August, 2009 soliciting your personal intervention in implementing the revised Policy and enacting law based on the Model Bill, which envisaged registration of the street vendors, demarcation of the vending zones in city/zonal/local plans and convergent delivery of schemes for their benefit. You may also recall that I had also written to you in this regard on 17<sup>th</sup> June 2009, 1<sup>st</sup> December 2010 and 11<sup>th</sup> April 2011. Secretary (HUPA) has also been following up the matter from time to time at the official level.
- The progress on State legislation front, however, has not been quite encouraging. Though many States are working on creating a legal framework, however, it is very slow and uneven. My Ministry has been receiving continuous representations from elected representatives, civil society members, individual street vendors and their organizations to bring a Central legislation which would be quickly and uniformly applicable to all the States and UTs. Owing to these facts, the Ministry started working on to evolve an effective and practical Central legislation for protection of the livelihood rights and social security of street vendors in consultation with the State Governments and all other stakeholders.
- The Ministry recently organized a one day National Consultation on Central Law  $\dot{o}$  3 Street Vending. You may refer to my earlier letter of even number dated  $30^{\rm th}$ November, 2011 requesting you to depute your Minister for that consultation. The Consultation was attended by a large number of participants including State Ministers, Members of National Advisory Council, State Secretaries, Urban Local Bodies, representatives from Central Ministries, / experts, NGOs, a large number of representatives from the Street Vendors Associations and street vendors themselves. All present underscored the need for a Central Law on the same.

- 5. Based on the inputs received, my Ministry has drafted a Bill titled 'The Street Vendors (Protection of Livelihood and Regulation of Street Vending) Bill, 2012, which we propose to take to the Cabinet in the near future. A copy of the draft Bill is enclosed for your perusal.
- 6. As may be evident from a quick perusal of the draft Bill, this Central Law is a framework law which prescribes registration of street vendors, constitution of town vending committees, rights and obligations of street vendors, establishment of dispute redressal mechanism and preparation of a scheme at the State level and plan at the local level for promoting and regulating the street vending. The Bill gives all the freedom to the States and Local Bodies in the matters of preparation of the scheme and plans and other matters connected with the administration and implementation of the provisions of the Bill.
- 7. I seek your personal attention on the matter and shall be grateful, if you could get the Bill examined and send us the views/comments/observations of your State at the earliest convenience for us to be able to take your concerns, if any, on board.
- 8. I have also advised Secretary (HUPA) to write separately to your Chief Secretary in this regard.

    - in relation to the lands owned or controlled by the Central Government, the Central Government;

- (g) "peripatetic vendors" means street vendors who carry out vending activities on foot to sell their goods and services;
- (h) "planning authority" means an Urban Development Authority or any other authority in any city or town designated by the appropriate Government as responsible for regulating the land use by defining the precise extent of areas for any particular activity in the master plan or development plan or zonal plan or layout plan or any other spatial plan which is legally enforceable under the applicable Town and Country Planning Act or the Urban Development Act or the Municipal Act;

#### (1) The plan shall,-

- (a) ensure that urban street vending activities do not lead to overcrowding and unsanitary conditions of public spaces and streets and not impede the movement of the general public;
  - (b) take into account existing natural markets;
- (c) take into account the civic facilities for appropriate use of identified spaces as vending zones;
- (d) promote convenient, efficient and cost effective distribution of goods and provision of services;
- (e) such other matters as may be specified in the scheme to give effect to the street vending plan.
- (2) The plan shall contain all of the following matters, namely:-
  - (a) determination of spatial planning norms for street vending;
  - (b) earmarking of space for vending zones;
  - (c) determination of vending zones as restriction- free-vending zones, restricted-vending zones and no-vending zones;
  - (d) making of spatial plans conducive and adequate for the prevalent number of street vendors in that city or town and also for the future growth, by adopting such norms as may be necessary;
  - (e) consequential changes needed in the existing master plan, development plan, zonal plan, layout, plan and any other plan for accommodating street vendors in the designated vending zones.

## Second Schedule [See section 22]

Matters to be provided in the Scheme for Street Vendors framed by the appropriate Government

- (a) the manner of registration of street vendors and the period within which such registration is to be made;

- (k) the designation of State Nodal Officer for co-ordination of all matters relating to street vending at the state level;
- (l) the manner of maintenance of proper records and other documents by the Town Vending Committee, local authority, planning authority and State Nodal Officer in respect of street vendors;
- (m) the manner of giving notice to, and eviction of, street vendors; impounding, destruction or seizure of stalls, goods and equipments and relocation of, evicted street vendors;
- (n) any other matter which may be considered by the appropriate Government as proper for including in the scheme.

## Third Schedule [See section 29]

#### Duties of Local Authority

- (a) overall supervision and monitoring of the scheme for street vendors;
- (b) monitoring effective functioning of the Town Vending Committee;
- (c) deciding appeals in respect of registration of street vendors in the manner specified in the scheme;
- (d) providing, in consultation with the Town Vending Committee civic services;
- (e) determining in consultation with the Town Vending Committee, the manner of collecting, through banks, counters of local authority and counters of Town Vending Committee, fee for registration, use of parking space for mobile stalls and availing of civic services:
- (f) undertake in consultation with the Town Vending Committee, comprehensive digitalized photo census and survey of the existing number of street vendors with the assistance of such experts and in such manner as may be specified in the scheme, for the purpose of accommodating street vendors within the holding capacity of the vending zones.
