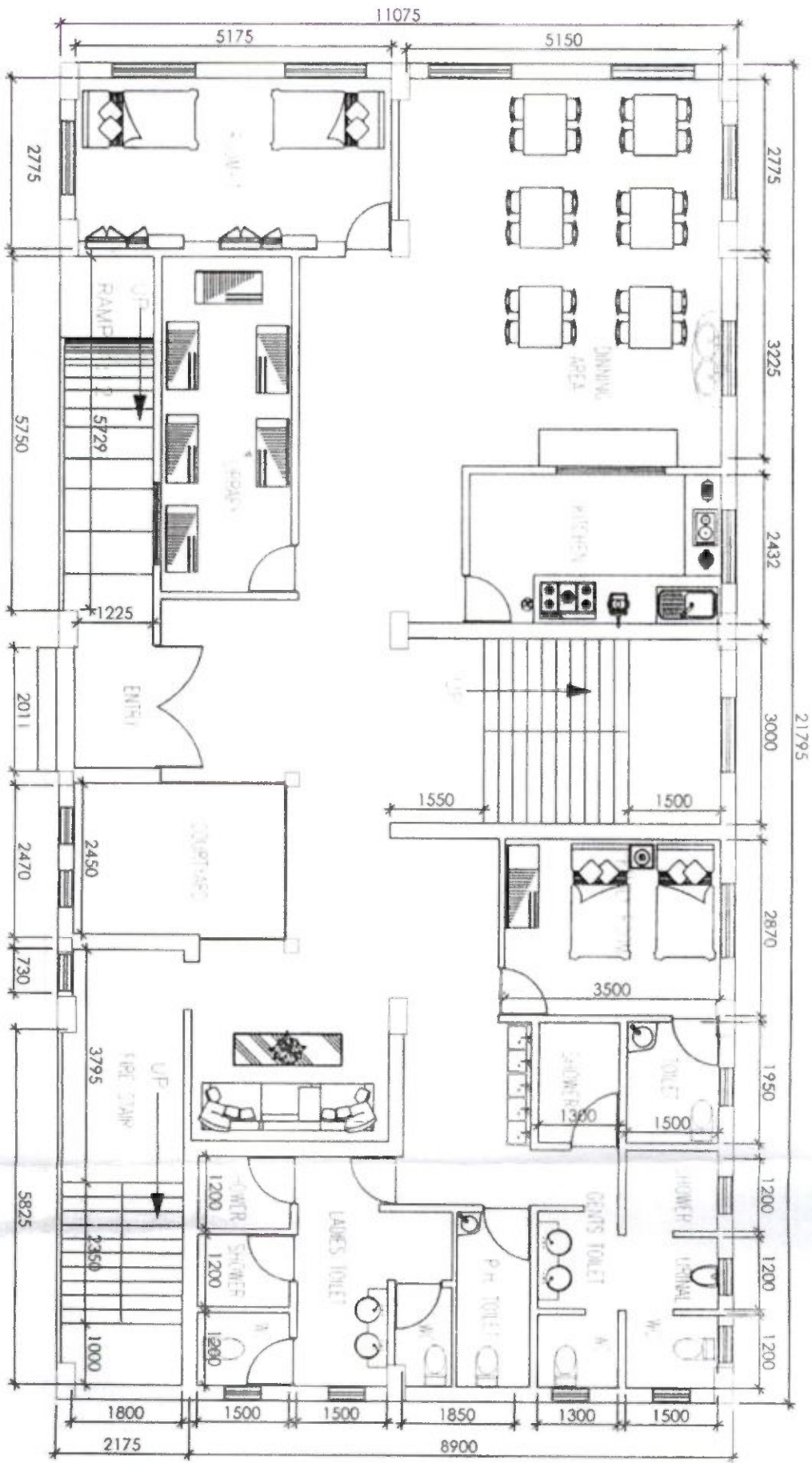

**Subject: Third party systematic survey for identification of urban homeless- regarding.**

Sir/Madam,

I am directed to refer to the report submitted by the Committee constituted as per orders dated 11.11.2016 of Hon'ble Supreme Court which has referred to the number of homeless persons in various States/UTs as per census survey 2011 and the availability of capacity of shelters. Further, in connection with the survey and identification of urban homeless the Committee has sought directions from Hon'ble Court on the following:

"The Committee has directed the States visited by them to conduct a survey for obtaining the number of urban homeless in the State as a whole and city-wise and the survey is to be conducted by a third party. It has been seen that the states have conducted their own survey which is not authentic as different figures have been given at different stages and even some States have gone to the extent of reducing the number of urban homeless to absolve themselves from constructing new shelters. So direction are sought that the States are directed to conduct an independent survey to be validated with SECC which is under public domain and the Committee is impressed by the factors to be taken into consideration for carrying out the survey which has been designed by the State of Telengana."


2. This Ministry, in its Para- wise comments submitted to Hon'ble Supreme Court on the report of the Committee has also agreed for conducting a survey by a third party.

3. It is to inform that Hon'ble Supreme Court vide its order dated 08.11.2017 (copy enclosed) passed during hearing of the W.P. (C) 55 of 2003 with W.P. (C) 572 of 2003 has observed that there was a huge mis-match of figures regarding the number of urban homeless between the final report submitted by the Committee on Shelters, constituted as per the directions Hon'ble Supreme Court and the figures quoted by some States in their affidavits filed before Hon'ble Supreme Court.

4. In view of the above, it is requested that a third party systematic survey for identification of urban homeless at the ULBs level may be carried out on a urgent basis and the same may be completed by 31st March, 2018 positively so that actual number of identification of urban homeless figures in the State/UT could be validated. A report on the outcome of the third party survey of urban homeless in your State/UT (ULB- wise) may kindly also be furnished to this Ministry.

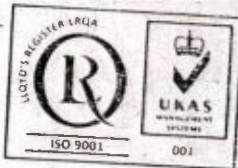

All Urban Local Bodies have already been requested to identify the land for construction of dwelling house for rehabilitation of the homeless people at the earliest. As and when the land will be available to the Urban Local Bodies, dwelling units will be constructed under this scheme 'Banglar Bari'. Already administrative approval has been given for construction of dwelling units within three urban local bodies.

It may further be stated that considering the urgency of necessity it will be considered to provide shelter to the homeless people in the State run unoccupied housing estates, hostels for working people etc.

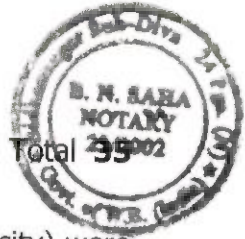

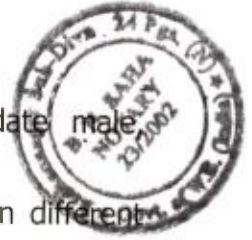
shelters (new construction & each 50 bedded capacity) were sanctioned so far under NULM. **74** more shelters under NULM will be functional within 2022. Financial year wise target for completion of the projects is detailed below:

- i. Functional shelters till now - 6
- ii. Further 4 shelters will be functional within 2017-18
- iii. IN 2018-19 -25 shelters will be functional
- iv. IN 2019-20- 20 shelters will be functional
- v. IN 2020-21- 26 shelters will be functional

These 74 nos. new shelters will be constructed under National Urban Livelihoods Mission (NULM) based on the availability of suitable land for model building.
