NULM took the chair and initiated discussion.

The Hon'ble Chairman wanted to know the latest position of SHGs functioning within this Municipality. As there was no upto date written report, prepared by the concerned cell, he advised to prepare a detailed report on the date of meeting to enlighten the discussion on the related issues of the concerned Scheme and this will help the Committee to take decision.

However the Executive Officer informed that-

1. *In the last meeting the Joint Director of SUDA stated the necessary steps will have to be taken for making expenditure in respect of fund, lying in different ULBs and submit utilization certificate for getting the fund from the Government of India.*
2. *He added that following action plans have been taken in consultation with the Chairman-in-Council that –*
 - i. *Immediate actions will have to be taken to complete the maintenance of record as per prescribed proforma issued by the SUDA.*
 - ii. *As per guideline of SUDA the Persons for Trainer will have to be selected from the RCV. As the existence of RCV are not in the NULM, the Joint Director of SUDA mentioned that the knowing and capable Persons will be selected from the different SHGs, so that they act as Trainer for training of the President (Dalaneetri), Secretary (Sampadika) and Treasurer (Koshadakshya).*

- iii. 41 (forty one) Trainers selected for training of above three categories of Persons of each 356 groups.
 - iv. The Training of the above 41 Persons will participate in the training of TOT (Training of Trainers) on 7th February 2017, which will be held in the meeting hall of the this Municipality.
 - v. Thereafter 35 batches of training will be held in the respect ward. Total Training will be completed within February 2017.
 - vi. In the Month of March 2017 awareness camp in each ward will be organized.
 - vii. Action plan along with the requirement of fund for training will be prepared and submitted to the Chairman within 7 days for finalization of the programme schedule.
 - viii. In respect of expenditure under ESTP, the bills of the Training Institute, who have been engaged for Computer Training will be made observing the financial rule.
 - ix. Unspent amount under SEP will not be spent during this financial year until and unless project under SEP – I and SEP – G received and passed by the Task force, constituted observing the Government Norms.
3. Approval of functioning of City Livelihood Centre obtained from SUDA. All steps as noted below completed.
- i. Site selection, repair and renovation of the building completed.
 - ii. Toll free number has already been received from the BSNL.
 - iii. Registration of service provider is on process.
 - iv. Manpower have already been engaged.
 - v. A meeting will be held on 30.01.2017 in the SUDA to discuss the related issues. As per their instruction the left out portion of work will be completed.
 - vi. The date of inauguration and functioning of the said CLC will be declared by the WBSULM.
4. Permission for construction of Shelter for Urban Homeless approved by the Mission Director WBSULM. The construction of the said building is under process.

After detailed discussion following decisions have been taken.

- a. The Executive Officer will take necessary steps on the following issues.
 - i. Prepare action plan for the residual period of the financial year for utilise the fund available in the account.
 - ii. Prepare action plan for formation of SHGs in the different Wards. In that case Number of BPL beneficiaries will be communicated to the concerned Member of the Resource Organization, so that all families under BPL and Urban Poor are included under this scheme.
- b. For publicity following actions will have to be taken.
 - i. The proposal of prepare calendar by the Chairman-n-Council, looking after the NULM accepted. The Hon'ble Chairman, Santipur Municipality mentioned that necessary action will have to be taken to prepare a draft of calendar after collection of different data and related photos, especially on different objectives.

- e. Before organizing meeting of the Task Force, the discussion with concerned Manager of the Respective Bank will have to be made.
- f. To minimise the problems relating to opening of Bank Account in different bank and other related issues, the Managers and other Personals of the NULM will attend the Banks.
- g. The Managers are not the Member of the Executive Committee. The Hon'ble Chairman mentioned that the presence of the two Managers will be helpful to through discussion and for taking decisions. He also instructed to co-opt the two Managers in the Executive Committee, formed as per Government Notification No – 415/MA/P/C-10/3S-30/2013, dated – 19.6.2015 held on 20th January 2017 .
