This Committee also be responsible for the planning, implementation and management of facilities created under SUH with the participation of municipal authorities, community representatives, civil society organizations, lying departments and elected representatives.

Feedback reveals that the Executive Committee has not been meeting regularly at the ULBs. It may be noted that regular meetings of Executive Committee is one of the SPARK parameters on which States are ranked for this programme.
