13.5 DAY-NULM will be set up as an independent society supported by a 'National Mission Management Unit (NMMU)'. This unit will function under the overall supervision of the Mission Director. The NMMU will support implementation of the National Urban Livelihoods Mission. The Mission Director will be supported by two Directors, 4 Under Secretaries, 5 Section Officers and 6 Assistants, other subordinate staff and a technical support team with at least 10 technical experts.

13.6 The NMMU's tasks will be to facilitate the setting up of SMMUs and CMMUs with adequate staffing, provide support in preparing the Perspective Plans (State Urban Poverty Reduction Strategy) and City Livelihood Development Plans, preparation of guidelines under DAY-NULM, oversee the implementation of DAY-NULM, facilitation of the creation of shelters for urban homeless and liaise with other Missions/ Ministries/Departments/ Industry associations to explore areas for convergent action at the national, state and city levels.

State Mission Management Unit (SMMU)

13.7 The implementation of Deendayal Antyodaya Yojana-National Urban Livelihoods Mission at the State level will be managed by a two-tier structure – A Governing Council and an Executive Committee. At the state-level, DAY-NULM will also have a Governing Council chaired by the Chief Minister of the State and an Executive Committee chaired by the Chief Secretary of the State.

13.10 The projects under SUH would be formulated, constructed and operated by the municipal bodies or other agencies including the private organisations identified by the State Government or local bodies. Sanction of suitable and viable projects under SUH after appraisal of each project will be done at the level of State EC.

13.11 The State Urban Livelihoods Mission will be set up as a society and will be supported by a State Mission Management Unit (SMMU) to oversee the implementation of the Mission and other poverty alleviation programmes in the State. The National and the State Missions will have a symbiotic relationship. They will have mutual access to the knowledge and services in the area of urban livelihoods and poverty alleviation.

13.12 The SMMU will be headed by a State Mission Director (SMD) who will be assisted by at least 4 Project Officers in charge of skills and livelihood, micro-enterprises, capacity building and finance & administration. The State Mission will have functional autonomy under the overall charge of the Secretary/Principal Secretary concerned for implementing the Mission in the State.

13.13 As per the requirements, the State Unit would include experts in the areas of social mobilisation, institution development, capacity building and training, micro finance development, livelihoods promotion, skill training and placement in remunerative jobs, gender, communication, MIS, monitoring and evaluation, human resource, finance, administration, etc.

13.14 The SMMU will have a dedicated MIS Cell to undertake online monitoring. The SMMU will coordinate with programme management units for Housing for All and RAY to ensure convergence of programmes.

13.15 The SMMU will have the responsibility to ensure collaboration among various line Departments of the State Government to facilitate convergence of activities to derive optimal benefits from DAY-NULM and other programmes. It will use the services of national, regional

Minutes of the 1st State Level Executive Committee meeting of West Bengal State Urban Livelihoods Mission(SLEC) under National Urban Livelihood Mission (NULM) constituted vide Notification no. 477/MA/P/C-10/3S-30/2013 dated 27th June,2014 of M.A.Deptt., GoWB.

Time & venue: 4-30 PM on 30th December, 2015 at Chief Secretary's Conference Hall, Nabanna

Chaired by: Shri Basudeb Banerjee, Chief Secretary to the Govt. of West Bengal

Members present: Sheet attached

At the outset, Chief Secretary to the Govt. of West Bengal and Chairman of the Committee stressed upon the importance and role of National Urban Livelihood Mission in alleviation of urban poverty, including its component of Shelter for Urban Homeless. Thereafter, agenda-wise discussion was held.

1. Mission Director, WBSULM and Director, SUDA made a brief presentation on overview of NULM programme. There are 7 main components under NULM which are Social Mobilisation & Institution Development (SM&ID), Capacity Building & Training, (CB&T), Employment through Skill Training & Placement (EST&P), Self Employment Programme (SEP), Support to Urban Street Vendors (SUSV), Shelter for urban Homeless (SUH), Innovative and Special Project (I&SP). He also stated the component wise details in the meeting.

The Committee emphasized on the importance of components of Employment through Skill Training & Placement, Self Employment Programme & Shelter for Urban Homeless. The Committee was of the view that special focus needs to be given on these components.

2. Mission Director, WBSULM informed the members that necessary institutional arrangements like constitution of Governing Council, Executive Committee, State Mission Directorate, State Level Monitoring Committee, City Level Executive Committee, City Level Task Force etc. have been made. Mission Director, WBSULM also apprised the members about the physical and financial progress made under NULM during 2015-16. He informed the house that during 2015-16, a total of 1429 SHGs and 417 ALFs have been formed in the State, 55 nos. of Resource Organisation have been engaged and skill training has been imparted to 21715 urban poor. On the financial status he informed the house that during financial year 2014-15 a sum of Rs.15.28cr was utilized and during financial year 2015-16, a sum of Rs.17.64cr has been utilized till 30th November,2015. He also informed the house that up to 30th November, 2015, 3215 SHGs and 642 Area Level Federations have been formed in the State and Revolving Fund has been released for 2358 SHGs under Social Mobilization & Institution Building (SMID) component of NULM. He further informed the house that during the NULM period, skill training has been imparted to 53769 urban poor under the Employment through Skill Training & Placement (EST&P) component of NULM and 1267 loan cases have been sponsored to various bank branches.

He also informed that during the financial year 2015-16 approval for 10 Shelter for Urban Homeless under 10 Urban Local Bodies namely Hadia, Durgapur, Nabadwip, Cooch Behar, Jalpaiguri, Berhampore, Barrackpore, Chandernagore, Bongaon & Haliashar have been sanctioned by State Level Project Sanctioning Committee. In the financial year 2014-15 3 Shelter for Urban Homeless under 2 Urban Local Bodies namely Krishnagar (1 no.) and Howrah (2 nos.) have been sanctioned. Presently construction of Shelter for Urban Homeless is going on in 5 Urban Local Bodies namely Krishnagar, Nabadwip, Cooch Behar, Jalpaiguri & Haldia. Tendering process is going on for construction of shelter in other 7 Urban Local Bodies.

3. The members appreciated the progress made under 'Shelter for Urban Homeless (SUH)' component. The house however was of the opinion that there was an emergent need for more such shelters. Mission Director, WBSULM and Director, SUDA informed the house that recent amendments in the programme guidelines by Ministry of Housing & Urban Poverty Alleviation, Gol, would enable the urban local bodies to submit more such proposals for sanction in the near future.

Secretary, Women Development, Child Development and Social Welfare informed the house that 44 nos. of shelters for urban homeless are running in 3 Municipal Corporations namely Kolkata (34 nos.), Howrah (6 nos.) and Asansol (4 nos.) under budgetary support of West Bengal State Government.

4. Members unanimously agreed to include General Manager, State Bank India and representative of CII as members of the Executive Committee

Agenda No.1:

Overview of NULM

National Urban Livelihoods Mission (NULM) is the new flagship Urban Poverty Alleviation Programme of Ministry of Housing and Urban Poverty Alleviation (MoHUPA),GoI that has been launched in the State from 1st April 2014.

- **Coverage:** Initially 63 cities/towns were covered in the State comprising of all district towns and towns with population of one Lac and above as per Census of India 2011. Subsequently, the number has been reduced to 58 towns following merger of some ULBs.
- **There are seven Components in NULM:**
 1. Social Mobilisation & Institution Development (SM&ID)
 2. Capacity Building & Training (CB&T)
 3. Employment through Skill Training & Placement (EST&P)
 4. Self Employment Programme (SEP)
 5. Support to Urban Street Vendors (SUSV)
 6. Shelter for urban Homeless (SUH)
 7. Innovative and Special Project (ISP)
- **Funding pattern:** 75% (Central) : 25%(State)
 - A. **Component-wise salient features:**
 1. **Social Mobilisation & Institution Development (SM&ID):**
 - Building Community Institutions – formation of SHGs [10-20 members], Area Level Federation (ALF) [10-20 SHGs] and at least one City Level Federation (CLF) in each city
 - Universal Financial Inclusion- bank A/C, Insurance, Pensions for all SHG members
 - Revolving Fund Support to SHGs and their Federations – Rs. 10000/ per SHG and Rs.50000/- per ALF

- Engagement of Resource Organizations (ROs) – for facilitating SHG formation, financial inclusion, ALF and CLF formation, Bank linkage, nurturing of SHGs up to 24 months. Rs. 10000/- per SHG to be paid to ROs for the task
- Establishment of City Livelihood Centre (CLCs) – for livelihood related services to urban poor
- Registration of ALF and CLF –ALF to be formed with 13-14 SHGs and CLF with all ALF of a city/town. Both to be registered under W.B Societies Registration Act

B. Capacity Building & Training (CB&T):

- To engage experts and other personnel for implementation of NULM
- To provide capacity building training to Chairman, Councillors and others for implementation of NULM
- ILGUS and ATI has been empanelled as Training Institute for Capacity Building training under NULM

C. Employment through Skill Training & Placement (EST&P)

- To provide skill development training for enhancing capacity for self-employment and access to wage employment.
- Training to be provided as per market need
- Training course curriculum and modules to be designed as per market requirement (In accordance with National Occupational Standards)
- Training to be duly certified by independent Certification Agencies (Certification proposed to be done through Technical Education & Training Department)
- Placement to be ensured for minimum 60% of successful trainees by skill training providers
- Tracking of trainees for minimum 6 months period
- Cost per trainee Rs. 15,000 including assessment and certification charges

D. Self Employment Programme (SEP):

- Individual and Group Enterprises to be linked with banks for financial support
- Interest-subsidy linked loans for individual enterprises and group enterprises
- Maximum eligible project cost for individual enterprises Rs.2.00 lacs & for group enterprises Rs10 lacs
- Individual and group enterprises to get loans @ 7% subject to timely repayment. Difference between interest charged by bank and seven percent to be provided as Subsidy

- Additional 3% interest subvention available for all women SHGs subject to timely loan repayment
- Provision for SHG- bank credit linkage as per SLBC approved norms
- Formation of Task Force Committee at City Level to monitor & supervise SEP loans
- Issuance of Credit cards to facilitate working capital requirements of individual entrepreneurs

E. Support to Urban Street Vendors (SUSV):

- Survey of street vendors and issue of Identity Cards
- Development of city street vending plan
- Infrastructure development of vending zones in the city
- Training and Skill Development
- Financial Inclusion
- Access to credit
- Linkages to social security scheme.

F. Shelter for urban Homeless (SUH):

- For every 1 lakh urban population permanent – 24x7 - all weather community shelters. Each shelter to cater to 50
- All necessary infrastructural facilities to be put in place – kitchen, water, sanitation, electricity, recreation, etc.
- A minimum space of 50 sq. feet per person to be provided
- Linkages with social security and other entitlements to be ensured
- Shelter Management Committee's to be set up to run and manage the shelters
- Shelters to be run on a PPCP mode - associating with agencies identified by the State including SHGs, NGOs, CBOs, Pvt. Sector Enterprises etc., for construction and management
- Construction cost of each shelter (for 50 persons): Rs. 1.20 Crore
- Rs. 6,00,000/annum for Operation and Maintenance

G. Innovative and Special Project (ISP):

- Focus on promotion of novel initiatives for catalyzing sustainable approaches to urban livelihoods through Public, Private, Community Partnership (PPCP)
- To be implemented directly by National Mission Directorate
- No State share required for implementation of the component

Agenda-3: Shelter for urban Homeless (SUH)

- All necessary information desired by Hon'ble Supreme Court in connection with Writ Petition (Civil) no.55 of 2003 has been furnished to Govt. of India for filing an affidavit. Govt. of India also requested to convene meeting of Governing Council (GC) and Executive Committee (EC) at the State level to review implementation of NULM with special focus on SUH scheme
- The target numbers of construction of shelters in the Mission period is 75 out of which thirteen (13) shelters were approved so far. The target for 2015-16 was fixed at fifteen (15) units
- All the NULM cities have been informed about the proposed target of construction of at least one shelter in each town and requested to identify suitable land

- A sum of Rs. 432.51 Lakhs from NULM account has so far been released for construction of shelters. A copy of status of the shelters sanctioned so far is enclosed herewith.
- For field level execution while the respective ULBs are the implementing agencies, the ME Directorate acts as the Technical Support Agency.
- Proposal for 4 more shelter units are in the pipeline in Asansol MC, Habra, Bhatpara and Midnapore and will be considered in the forthcoming meeting of the Project Sanction Committee for approval.
- In addition to construction of new shelters under NULM, it has also been decided that the O&M cost at the existing rate will be borne by the MA Department from NULM allotment in respect of 37 shelters now under operation under control of the Social Welfare Department.





The Hon'ble Supreme Court is monitoring the progress of Scheme of Shelter for Urban Homeless (SUH) in the matter of WP (Civil) No. 55 of 2003, ER Kumar & Anr vs. Union of India, and WP (Civil) 572 of 2003. During the last hearing on 18.09.2015, the Hon'ble Court has observed that "the number of shelters required is actually quite large but the progress is inadequate". An affidavit has been filed by the Ministry of Housing and Urban Poverty Alleviation, Government of India on 11th September, 2015.

The affidavit indicates that some progress has been made in the National Urban Livelihood Mission (NULM) and Shelter for Urban Homeless (SUH). Some figures have also been given in the form of a chart which is on page 8 of the affidavit. We find from a perusal of the chart that some of the States/Union Territories have not been included therein. It is not clear why.
