

- A. Ministry of Law & Justice, Govt. of India has published in The Gazette of India "The Street Vendors (protection of Livelihood and Regulation of Street Vending) Act, 2014.
- B. We have received a Draft Scheme, Rules, Plan and Bye-Law on Street Vending by All India Institute of Local Self Govt. (AIILSG), Mumbai forwarded by MoHUPA, Govt. of India containing the detail of Draft Rule, Scheme, Plan or Bye-Law to be framed as per provision of "The Street Vendor (Protection of Livelihood & Regulation of Street Vending) Act, 2014.
- C. During recent Eastern Zonal Workshop held at Kolkata on 14.02.2015 issue of preparation for Rule, Schemes, Plan etc. was pressed up.
During NULM video conference taken by Joint Secretary, MoHUPA on 04.03.2015 issues related to identification of street vendor, their registration, benefit activity etc. has been stressed upon.
- D. Salient points of the Act are :-
1. State Govt. will make rule incorporating terms and manners for constituting Town Vending Committee in each Local Authority (as-22) headed by Municipal Commissioner or Chief Executive Officer.
 2. Town Vending Committee will arrange for survey of existing street vendors (Sec-3) A.
 3. All street vendor so surveyed will be given a certificate by Town Vending Committee (Sec-4).
 4. Town Vending Committee can recommend an area as No-Vending Zone and relocate the vendors for public purpose (Sec-18).
 5. Street vendors will enjoy the right to carry on business with terms and condition as per certificate (Sec-12).
 6. Town Vending Committee will undertake promotional measures for availability of credit, insurance, social welfare schemes to street vendors (Sec-31).

- 7. State Govt. may arrange for (a) Capacity Building (b) Skill Training etc. to Street Vendors (Sec-32)
- 8. State Govt. to make rule within one year from date of commencement of this act. Rule will contain different issues as envisaged in Sec-36..
- 9. Local Authority may make Bye-Law.
- 10. State Govt. shall make a scheme within 6 months.

- ✓ 1. Guideline regarding Street Vending Policy in Urban Areas issued by M.A.Deptt.
- ✓ 2. Constitution of Municipal Vending Committee has been notified vide M.A.Deptt. order No.237(128)/MA/O/C-4/1A-10/21 P.T.1 dt.18.06.2014.

Under above circumstances, following issues may be taken for consideration :-

- (1) Preparation of Rules, Scheme, Plans and Bye-Laws on Street Vending
- (2) Registration and Certification for Street Vendor.
- (3) Providing benefits to street vendor as mandated by the Act etc.
