PREFACE

PRADHAN MANTRI AWAS YOJANA (PMAY) AIMS AT PROVIDING HOUSING FOR ALL(HFA) BY 2022 WHEN THE NATION COMPLETE 75 YEARS OF ITS INDEPENDENCE

The Urban homeless persons of the cities contribute to the economy of the Nation as cheap labour in the informal sector, yet they live with no shelter or social security. The Urban homeless people are facing many challenges like no access to elementary Public Service such as health, education, food, water and sanitation. Pradhan Mantri Awas Yojana (PMAY) aims at providing a pucca house to every family with water connection, toilet facilities, 24 X 7 electricity supply etc.

The Mission seeks to address the housing requirement of urban poor including slum dwellers through "In Situ" Slum Redevelopment, Affordable Housing through credit linked subsidy, Affordable Housing in partnership and subsidy for beneficiary one component only.

Total beneficiaries of the scheme are 308 nos. from 35 nos. slum and 9 nos. of Non-Slum projected for the year 2018-19.

Total cost of the project for 2018-19 is Rs. 1246.78 lakhs as per relevant department & P.W.D. schedule of rates.

Introductory Note by Chairperson

New Barrackpore is a very small ULB situated in the vicinity of Kolkata. It is at a distance of about



17 km from proper Kolkata. Its total area is 6.89 sq.km. Its eastern boundary is marked by a canal, named as Fatesha. The northern side is demarcated by Sodepur Road and aforesaid Noai canal. North DumDum Municipality lies on its south. Madhyamgram Municipality is situated at the north-east part of the ULB. New Barrackpore Municipality lies in Ghola tehsil of North 24 Paraganas district situated in 22.76 degree North latitude and 88.37 degree East longitude. It is 2 Kms. from tehsil headquarters and 4 k.m. from district

headquarters (Barasat) near Noai Canal. Linkages of rail have added to the importance of this ULB. Railway lines connecting Bongaon, Hasnabad with Sealdah, Dalhousie, Canning and Naihati have passed through the heart of this Municipality where there is a full-fledged busy railway station. A PWD Road connected with innumerable Municipal Roads and lanes is linked with the Sodepur Road and Jessore Road. DumDum Airport (now Netaji Subhas Chandra Bose International Airport) is at a stone's throw from its southern boundary.

In the year 2006 Municipality had conducted the Quick Slum Survey for identifying and listing the existing slums within the jurisdiction of the ULB. According to QSS there are about 35 slums within the area of the ULB. During 2010 the first phase of USHA survey was conducted in this ULB. After 3 years the Slum boundary validation was conducted for preparation of SFPCoA and then 9 non-notified slums were identified. GIS Maps were prepared in all the slum areas and MIS Validation was conducted with the support of RAY fund. The process was conducted by Data Soft Technology, an agency appointed by the New Barrackpore Municipality. On the year 2014-15 the USHA survey was conducted in the newly identified households that were identified during the process of MIS Validation.

In the year 2015-16, a demand survey was conducted in all the slum areas of the ULB to assess the actual demand for housing and potential beneficiaries. The information about the eligible beneficiaries from this survey and other available data is contained in Housing for All Plan of Action (HFAPoA) in prescribed formats along with interventions selected out of the four verticals of the Mission.

On the basis of applications, ULBs will prepare an integrated city wide housing project for such individual beneficiaries in accordance with the City Development Plan (CDP) or other such plans of the city to ensure construction of proposed houses are as per planning norms of the city and scheme is implemented in an integrated manner which will be sent to SLSMC for approval. Individual applicants for assistance shall not be considered.

1.4. Housing and Physical Infrastructure profile

The ULB had already implemented BSUP project.

BSUP had of two parts-

- (i) Housing facility to the slum dwellers.
- (ii) Other Infrastructural Development initiatives in the slum settlement.

This municipality has duly availed itself of the opportunity extended to the urban poor under this project.

Housing facility:-

Construction of 1052 low cost houses for the equal number of BPL families living at different wards was taken up in the first phase for completion before the end of the financial year 2011-12. Each of the schemed houses consists of two airy bed rooms, one kitchen and one attached toilet.

- Infrastructural Development:-

Before coming to the varied infrastructure developments taken up under this project for providing basic amenities to the poor living at slums, a light needs to be thrown on the similar drive taken by this ULB under KUSP Programme. Some infrastructural developments in respect of water supply, drainage system, roads, and sanitation were successfully made with KUSP fund prior to the commencement of BSUP project.

BSUP project had given a scope for taking up various initiatives for overall developments of the slums under this ULB. The multifarious infrastructural development works that have been taken up under this project relate to the following-

- Development of roads.
- Development of drains.
- Provision of street light.
- Construction of community bath & toilet.
- Provision of water supply pipe line.
- Provisions for water stand post.
- Improvement of solid waste management.

1.5.2. Summary of Findings of Demand Survey

According to USHA & SECC, 2011 data USHA demand survey was conducted in slum and non-slum households. The Demand Survey has identified the requirement of housing in 43 slums areas. There are 1421 nos. of housing requirement in untenable and non-PPP slums. In the non-slum areas there is a housing requirement of 661 nos. of houses. As per decision of the Board of councillors (BoC) these houses will be developed under the component of Beneficiary led contribution. Moreover, as per the projection in CDP, (2014-15 to 2018-19) the number of increased urban poor will be 1038 in the next 5 financial years. These housing stock requirement is divided into the projection of last 5 financial years of HFAPoA to meet the housing stock requirement of the urban poor. These housing stock requirements will be developed under beneficiary led contribution (BLC).

1.5.3. Broad infrastructure status in slum areas

From USHA survey we have received the broad infrastructure status of the slum. Under KUSP and BSUP programme some infrastructure development work has already been completed in slum areas. 22.2% of the slum areas are fully connected to city wide storm water drainage system, 55.5% slum areas are partially connected to city wide storm water drainage system and rest 22.2 % slum areas of this ULB is not connected to this drainage system. In New Barrackpore town no slum is connected to city wide sewerage system because this system has not yet started in this town.

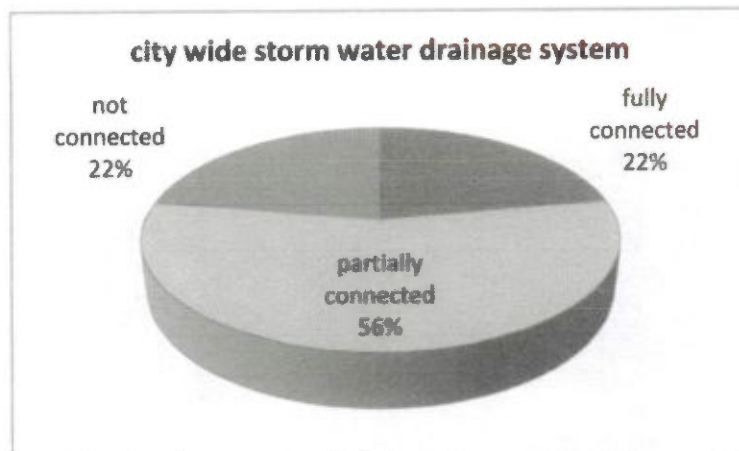


Figure 1.1. Pie diagram showing the scenario of city wide storm water drainage system within the slum.

Now, if we look at the services that are provided to the slum dwellers by the ULB, we would find that from all the slums the garbage is being disposed by the Municipal contractor and garbage from the slums is being disposed once in every 2 days by them. The open drains in the slums are being cleared by the concerned department of the ULB once in 15 days in majority of the slums.

The approaching roads in 53.7% of the slums are non-motorable, though all of them are pucca. Hence it is clear that though the approaching road of most of the slums is Pucca but as they are really narrow they are non-motorable in nature.

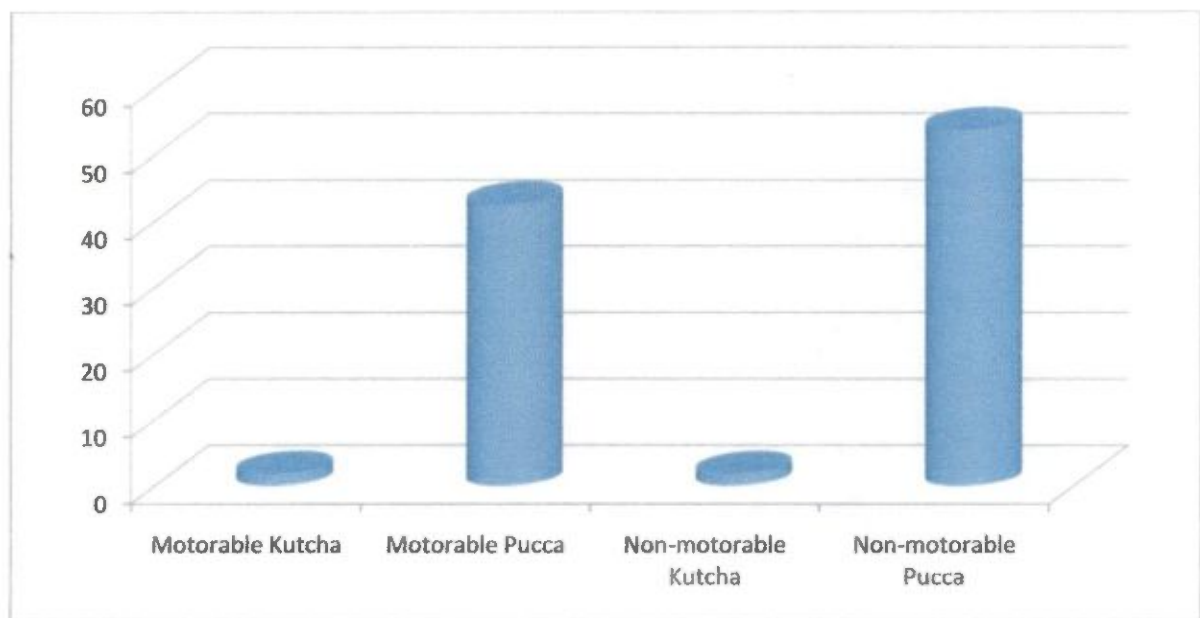


Figure 1.2. Bar diagram showing the scenario of slums by type of approach road

Out of 44 no. of slums, about 42 no. of slums have streetlight facility whereas the rest of them do not have streetlight within the slum till now.

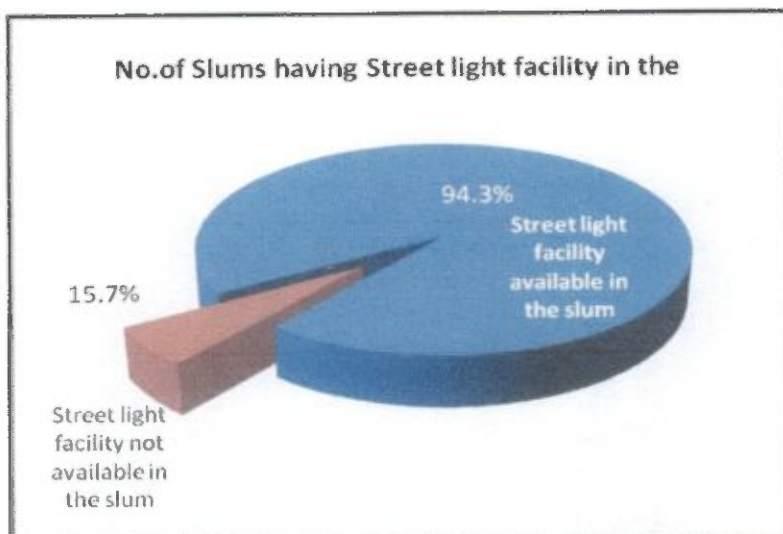


Figure 1.3. Pie diagram showing the no. of slums having street light facility

In the slum areas of New Barrackpore 88.9% of the internal roads are non-motorable pucca whereas only 5.5% roads are non-motorable kutcha with urgent requirement of construction. Only 3.7% slums are covered by motorable Pucca Roads. In 1.85 % motorable but kutcha roads are available.

Arrangement of garbage disposal is done by municipal contractors once in 15 days. Frequency of clearance of open drain takes place once in 15 days.

1.6. Tenability Analysis

In New Barrackpore all the slums are untenable slum with no scope of In-situ" Slum Redevelopment using land as Resource. There is higher value of land whereas there is no land in the hand of the ULB. So, municipality has taken decision to start Beneficiary-led individual house construction or enhancement.

2. Assessment of Existing and likely Future Housing Shortage

2.1. Existing Housing Shortage (Non Slums)

The existing housing shortage is 661 nos. for urban poor in non-slum areas. These housing shortages have been found in ward no. 1, 2, 8, 12, 13, 14, 15, 16, 18, 19 & 20.

2.2. Likely future Housing Shortage

As per the Census, 2011 the no. of household of New Barrackpore is 19307. Likely future housing shortage is 1038 up to 2021-20. These housing shortages are divided equally in the last 5 financial years of HFAPoA.

3. Identification of four Options available under Mission

(Use table I and II of Guidelines)

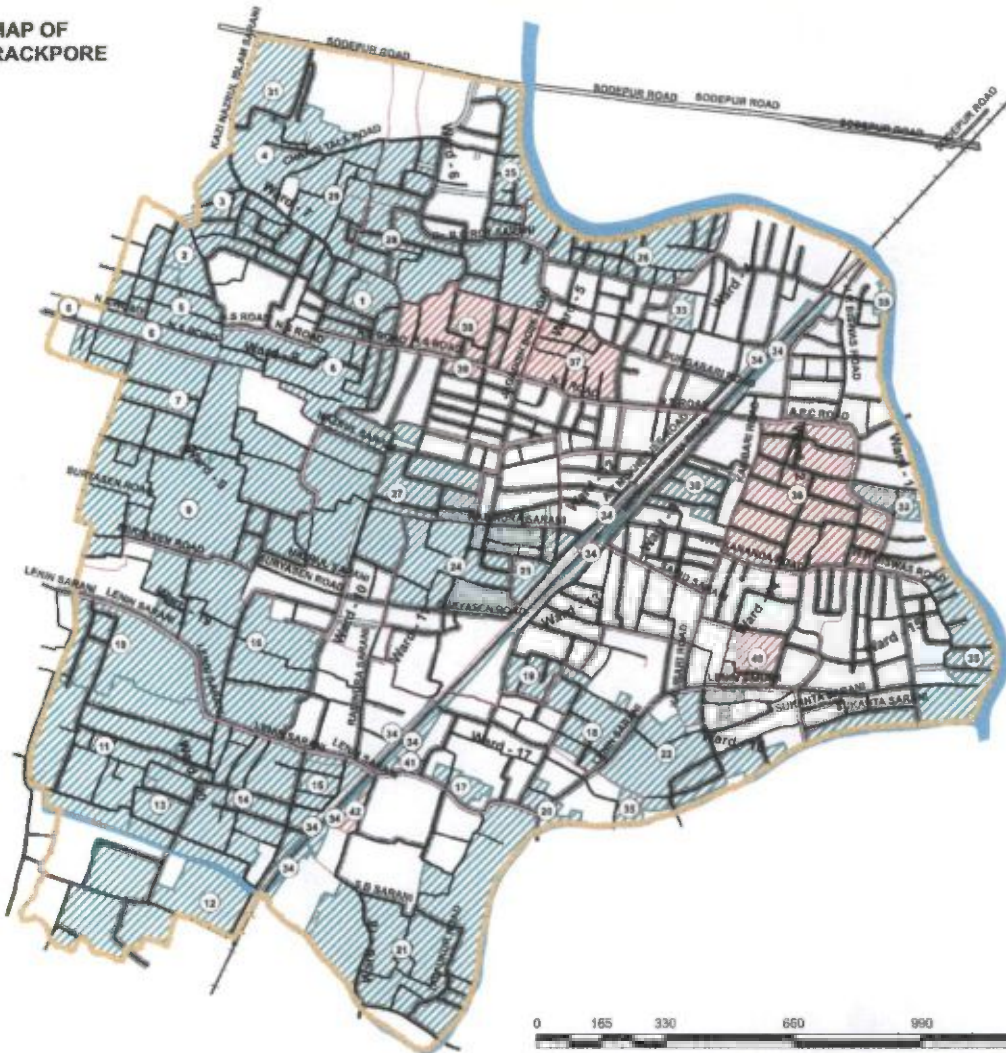
- "In-situ" Slum Redevelopment using land as Resource(include viability analysis): In the demand survey, no beneficiary has been identified, to avail the facility under this scheme.
- Credit-Linked Subsidy Scheme (CLSS) : In the demand survey, there is no beneficiaries who have expressed interest to avail the facility under this scheme.
- Affordable Housing in Partnership (AHP): In the demand survey, there is no beneficiaries who have expressed interest to avail the facility under this scheme.
- Beneficiary-led individual house construction or enhancement : The ULB has validate the information given by the beneficiaries and ensured that all the beneficiaries have ownership of land and their economic status. The beneficiaries of slum and non-slum areas having kutcha or semi-pucca houses will avail this assistance under this scheme.

4. Intervention Plan and Central assistance.

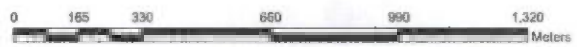

All the slums will be developed will equal distribution of the identified household on each year. Although the ULB will complete 20% of the total household on 1st financial year i.e 2015-16. Then the 70% work will be completed on 2nd and 3rd financial year. Rest of the houses will be constructed on the remaining 3 financial years. But the future stock of houses is planned to be developed equally on each financial year. Table III-V in HFAPoA guidelines has been attached.



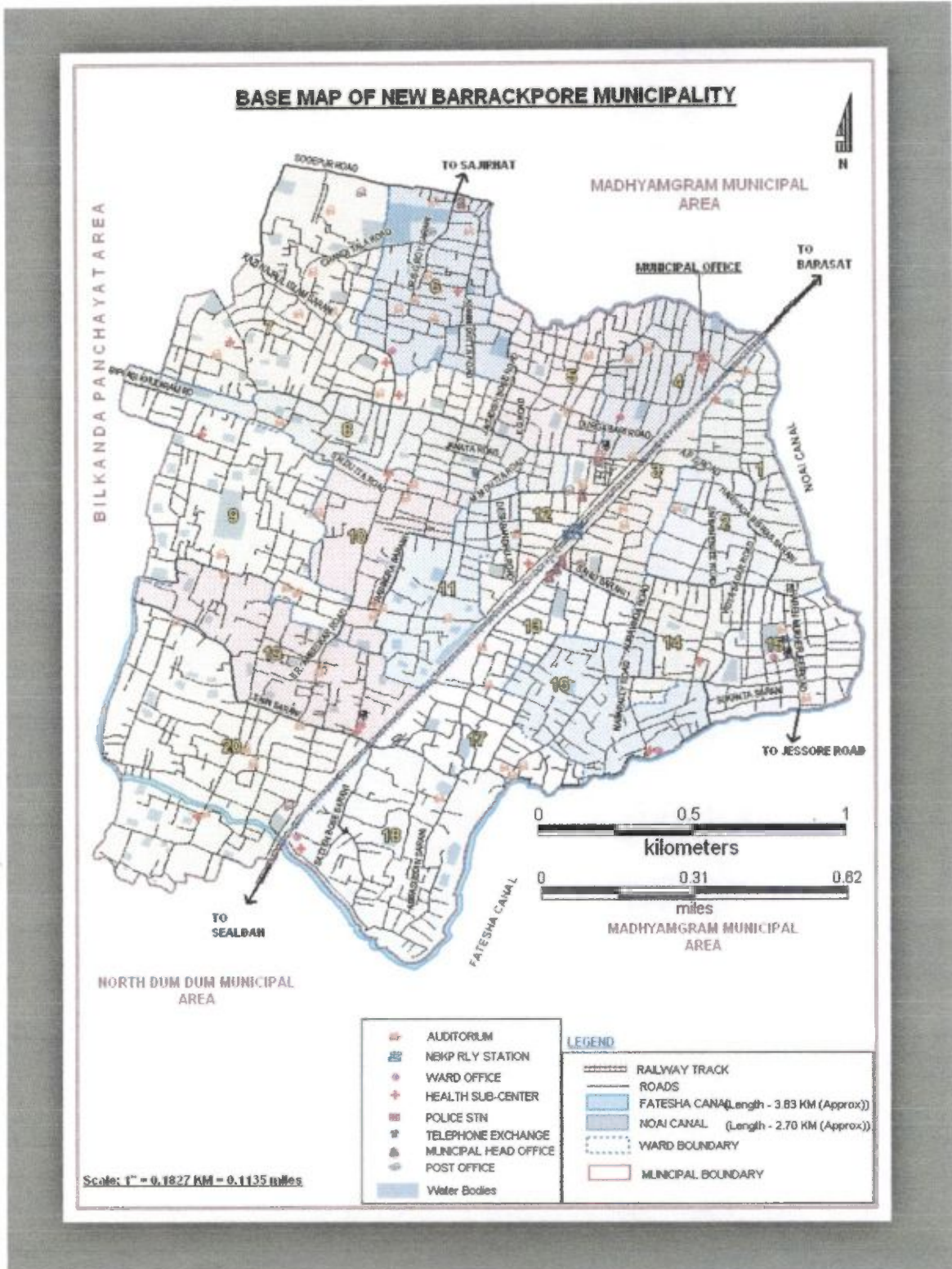

HFAPoA and Pradhan Mantri Awas Yojana (Housing for All)

To give pucca house for every family is currently on the global agenda. One of the Millennium Development Goals (MDGs) is to 'achieve significant improvement in the lives of slum dwellers, by 2022'. Similar goals are set forth by Pradhan Mantri Awas Yojana within year 2022, to create pucca house for every family.

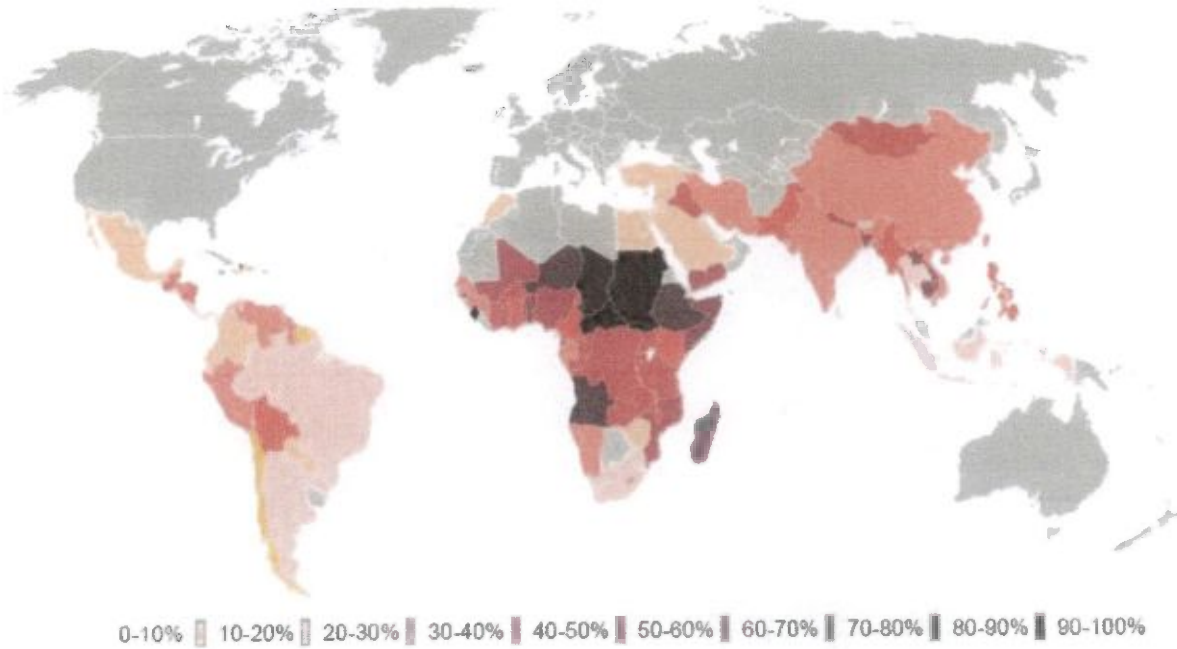
ULB undertake a demand survey through suitable means for assessing the actual demand of housing. While validating demand survey, Cities consider possible temporary migration from rural areas to the city just to take advantage of housing scheme and exclude such migrants from list of beneficiaries. On the basis of demand survey and other available data, cities prepare Housing for All Plan of Action (HFAPoA). HFAPoA contain the demand of housing by eligible beneficiaries in the city along with the interventions selected out of four verticals. The information regarding beneficiaries is collected by ULB in suitable. While preparing HFAPoA, ULB and Implementing Agencies also consider the affordable housing stock already available in the city as Census data suggests that large number of houses are vacant.

Bank account number and Aadhaar number/Voter ID card/any other unique identification details of intended beneficiaries or a certificate of house ownership from Revenue Authority of beneficiary's native district integrate in the data base of HFAPoA for avoiding duplication of benefit to one individual family. Beneficiaries is validated by ULBs thereby ensuring their eligibility at the time of preparation of the projects and approval of projects.

On the basis of HFAPoA, States/Cities subsequently prepare the Annual Implementation Plans (AIPs) dividing the task upto 2022 in view of the availability of resources and priority. For larger cities, HFAPoA and AIPs is prepared at sub-city (ward/zone etc.) level with the approval of concerned State/UT Government. The result of demand survey, draft HFAPoA and draft AIP is discussed with the local representatives including MLAs and MPs of that area so that their views are adequately factored in while finalising the plans and beneficiary list.

Cities which have already prepared Slum Free City Plan of Action (SFCPoA) or any other housing plan with data on housing, utilise the existing plan and data for preparing "Housing for All Plan of Action" (HFAPoA). Houses constructed under various schemes should be accounted for while preparing HFAPoA

The preparation of HFAPoA broadly involve Slum Development/Rehabilitation Plans based on

- a. Survey of all slums – notified and non-notified;
- b. Mapping of slums using the state-of-art technology;
- c. Integration of geo-spatial and socio-economic data; and
- d. Identification of development model proposed for each slum.

1. Base maps to an appropriate scale would be a pre-requisite for the preparation of Slum Development Plan/Slum-free City Plan. States/UTs may need to proceed in the following steps for the preparation of Slum-free City Plans.
2. Securing CARTOSAT II/latest satellite images from NRSC/ISRO and preparation of base maps for the whole city and its fringes using the images;
3. Identification and inventory of all slum clusters of all descriptions in the urban agglomeration with the help of satellite image and other available data;
4. Inventory of all possible vacant lands in each zone of the urban agglomeration that could be used for slum development/ rehabilitation development purposes;
5. Development of Slum Map of every slum within the city and its fringes using GIS with CARTOSAT II images, ground level spatial data collected through total station survey, collating spatial information with respect to plot boundaries, network of basic infrastructure like roads, sewerage, storm drainage and water lines, etc and superimposing this on the satellite image and importing them into GIS platform as the first step towards the preparation of Slum Development Plans and Slum Free City Plan.
6. This may be undertaken with the help of technical partners of NRSC/ ISRO/other technical institutions.
7. Identification and engagement of Lead NGO/CBO to guide and anchor community mobilization for the purpose of slum survey, (May be more than one NGO/CBO in different slum zones) of the city. These Lead NGOs/CBOs should also be associated in slum survey operations and dialogues for preparation of slum level development plans;
8. Conduct of Slum Survey based on the detailed formats (with or without changes)

prepared by the Ministry of Housing & Urban Poverty Alleviation with the help of National Buildings Organization (NBO) - after due training of trainers, training of survey personnel /cavassers and canvassing. It would be helpful for community mobilization to pick as many cavassers from the sourced slum or nearby slum pockets;

9. Collection of bio-metric identification data of slum dwellers based on the above survey (subject to guidelines issued by Unique Identity Authority of India (UIDAI));

10. Entry of data from Slum Surveys in the web-enabled MIS application (to be provided by Ministry of HUPA), compilation and collation of data, preparation of Slum-wise, City and State Slum Survey Database and Baseline Reports. The MIS will assist in developing a robust Slum and Slum Households Information System. (Guidelines and software for development of the MIS will be issued by the Ministry of HUPA);

11. Integration of Slum MIS with GIS Maps to enable the preparation of GIS-enabled

Slum Information System that is to be used for the preparation of meaningful Slum Development Plans and Slum-free City Plan using a city-wide/zone-based approach.(Guidelines and software for development of GIS platform and its integration with the MIS will be issued by the Ministry of HUPA);

Introduction to Pradhan Mantri Awas Yojana (PMAY)

Pradhan Mantri Awas Yojana (PMAY), a path breaking scheme for the slum dwellers and urban poor envisages a 'Pucca house to every family' through encouraging States to tackle the problem of slums in a holistic manner. It calls for a multi-pronged approach focusing on:

- Bringing existing slums within the formal system and enabling them to avail of the same level of basic amenities as the rest of the town.
- Redressing the failures of the formal system that lie behind the creation of slums.

- Tackling the shortages of urban land and housing that keep shelter out of reach of the urban poor and force them to resort to extra-legal solutions in a bid to retain their sources of livelihood and employment.

- Enactment of a set of reforms at the state and city level related to inclusive planning, regulation and financing, which would ensure that adequate fresh housing stock and services get created on an ongoing basis to address both current and future needs of cities.

- An integrated approach covering shelter, services and livelihoods for poor slum communities.

The duration of Pradhan Mantri Awas Yojana [PMAY]

2015 TO 2022

Eligible Components of the PMAY:

Allotment of Houses

Allotment of dwelling units will be in the name of the female member of the . Alternatively, it can be allotted in the name of husband and wife jointly. Ownership of land required for every Beneficiary.

A EWS beneficiary family will comprise husband, wife and unmarried children. The beneficiary family should not own a pucca house (an all weather dwelling unit) either in his/her name or in the name of any member of his/her family in any part of India to be eligible to receive central assistance under the mission. EWS households are defined as households having an annual income up to Rs.3,00,000 (Rupees Three Lakhs). States/UTs shall have the flexibility to redefine the annual income criteria as per local conditions in consultation with the Centre.

Following infrastructure will be considered for support under PMAY:

1. Water connection
2. Toilet facilities
3. 24 x 7 Electric facilities
4. Roads

The project has been designed keeping in mind the following objectives.

- Integrated development of all existing slums, notified or non-notified, i.e., development of infrastructure and housing in the slums/rehabilitation colonies for the slum dwellers/urban poor, including rental housing.
- Development/improvement/maintenance of basic services to the urban poor, including water supply, sewerage, drainage, solid waste management, approach and internal road, street lighting.
- The Creation of affordable housing stock, including rental housing with the provision of civic infrastructure and services, on ownership.
- Encouraging Public Private Partnership by having pay and use toilets and educate the slum dwellers for keeping the environment clean and hygienic.

State PMAY Mission Director

The Nodal Ministry and National Mission Directorate is Ministry of Housing & Urban Poverty Alleviation, Government of India.

The Nodal Department for West Bengal is Municipal Affairs Dept. (M.A. Department), Government of West Bengal. The state level Nodal Agency is State Urban Development Agency (SUDA) under M.A. Department. State Urban Development Agency was set up in 1991 with a view to ensuring proper implementation and monitoring of the centrally assisted programmes for generating employment opportunities and alleviation of poverty throughout the State. SUDA is a Society registered under the West Bengal Societies Registration Act, 1961.

Funding Pattern of PMAY

Need for Projects

This development project models will give benefits in the city . One of the key objectives of developing the Projects is to incentivize innovation and encourage new approaches and solutions that can demonstrably improve the quality and quantity of shelter and services for the poor.

Such innovation could encompass:

- Projects with strong community participation i.e. Slum upgradation/ redevelopment projects initiated/spearheaded by the community; or with their demonstrable involvement and participation in design, planning and implementation
- New models of public-private partnerships whereby the private sector can be encouraged to take up affordable housing for the EWS/LIG.
- Innovations in planning, demonstrating integrated livelihoods, shelter and services; or convergence.
- Innovative or cost effective and green building design and technologies.
- Financial innovations in delivering the city/state wide programme.

Aims and Objectives

The mission seeks to address the housing requirement of urban poor including slum dwellers through following programme verticals:

- Slum rehabilitation of Slum Dwellers with participation of private developers using land as a resource
- Promotion of Affordable Housing for weaker section through credit linked subsidy
- Affordable Housing in Partnership with Public & Private sectors
- Subsidy for beneficiary-led individual house construction

Definition of Slum for Housing

Different definitions of a slum exist in different statutes and in urban poverty literature. For the purpose of HOUSING SCHEME, it is proposed to adopt the definition given in the 2001 Census, which is as follows:

- a. All areas notified as 'Slum' by State/Local Government and UT Administration under any Act;
- b. All areas recognized as 'Slum' by State/Local Government and UT Administration, which have not been formally notified as slum under any Act;

'Slum' or 'Slum Area'– is a compact settlement of at least 20 households (For NE & Special Category States it is 10-15 households) with a collection of poorly built tenements, mostly of temporary nature, crowded together usually with inadequate sanitary and drinking water facilities in unhygienic conditions.

Situation Appraisal

The people living in the slums mostly have kutcha (10) and semi-pucca (186) housing. In certain cases where pucca housing is available, they are usually in dilapidated condition. The kutcha

houses are in very poor condition and require extensive repairs. Most of the houses have tiles on roof. While during the survey some of the houses have been noted to be in average condition, the quality of these houses is also speedily deteriorating.

Proposed Intervention

In line with the vision to 'housing for all', an integrated housing programme is proposed to be implemented. The target will be all the slum /Non Slum dwellers in the pocket.

Building Plan

The buildings are proposed to cover an area of approximate 32 Sq.mt along with provision of 2 rooms, kitchen and sanitation facility. The layout, size and type design of housing dwelling units depends on the local conditions and the preferences of the beneficiary. The houses, has been designed in accordance with the desire of the beneficiaries, keeping in view the climatic conditions and the need to provide ample space, kitchen, ventilation, sanitary facilities, etc. and the community perceptions, preferences and cultural attitudes.

In line with the scheme, carpet area of the house will be not less than 25 sq. mts and preferably two room accommodation plus kitchen and toilet should be constructed.

Compliance with Municipal Bye laws

All designs & drawings are created keeping in line with the municipal bye laws.

- PCC (1:3:6) for foundation
- RCC M-20 for substructure & superstructure (Column, Beam, Slab)
- HYSD Steel
- 1st class Brick Masonry

Structural Design

- Following are the general considerations in the analysis/design.
- For all structural elements, M20 grade concrete and Fe 415 grade of steel is used.
- Plinth beams passing through columns are provided as tie beams.
- Pedestals are proposed up to ground level.
- Beam Centre-line dimensions are followed for analysis and design.
