Proposal for release of funds to 17 ULBs sanctioned in 2015-2016 under PMAY-HFA(U) : It is worthwhile to mention here that, Fund has already been released to 83 ULBs Sanctioned in 2015-16 & 4 ULBs Sanctioned in 2016-17 for a total amount of Rs. 300.85 Crore on the basis of the performance of the ULBs on Online Data Entry, Geo-tagging and construction of Dwelling Units. Meanwhile, proposal for release of fund for 17 ULBs as mentioned at Annexure "A" sanctioned in 2015-16 may kindly be perused. Incidentally it may be mentioned here that, for some of the ULBs namely, Kalyani, Rajpur Sonarpur, Kancrapara, Jhargram, Srerampur and Budge Budge have submitted their fund utilization with respect to total fund received from SUDA is less than 50% and Geo-tagging process yet to be initiated by Kalyani, Rajpur Sonarpur and Diamond Harbour. It is worthwhile to mention here that, Fund has already been released from SUDA to 83 ULBs Sanctioned in 2015-16 & 4 ULBs Sanctioned in 2016-17 for a total amount of Rs. 300.85 Crore on the basis of the performance of the ULBs on Online Data Entry, Geo-tagging and construction of Dwelling Units and Percentage of Utilisation of receipt fund from SUDA by the ULBs.

Financial Status as on 26.08.2017:

- **Fund received by SUDA: 2073.13 Crore**
- **Fund released to ULBs : 1575.87 Crore**
- **Balance Fund available with SUDA : 497.26 Crore**

Since the monsoon is in full swing and huge number of houses are in Foundation, Lintel & Roof stage , it is felt necessary to release fund to the ULBs on priority basis to achieve a target to complete maximum number of Dwelling Units to be occupied by the beneficiaries. 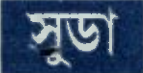
