



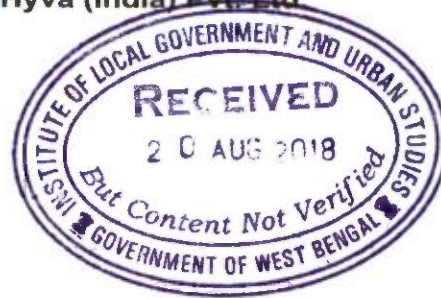

Dear Sir,

We understand from various municipalities that now "Fitness Certificate" is required for the Moveable Compactor and Hook Loader as per the rule of Motor Vehicle since many compactors have crossed two year period.

Kindly note that as per the MV act for Commercial vehicles the fitness certificates is valid for 2 years in case of a new vehicle and subsequently it is renewed for one year.

As most of the cases two years have crossed the "Fitness Certificate" has become necessary to adhere the MV Act.

Therefore, many officials of municipalities are approaching us for doing "Fitness Certificate" activity also. In this regard kindly note that as per the above work orders we have not been given the above activity hence, we have politely declined to do so. However, we have been requesting Municipal authority to carry out the above by them.

We also understand from municipalities that there is no directive from SUDA for doing the above activity by ULBs as the compactors/hook loaders are received by them through SUDA.

Therefore, to bring the clarity we request you to kindly inform to all the municipalities to complete the formality of "Fitness Certificate" within the schedule time frame so that each vehicle adheres the MV Act.

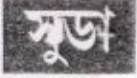
