

Sub: Supply of 8.0 Cum capacity Movable Compactors earmarked for Kalimpong, Kurseong Municipalities and Mirik N.A.A. to selected ULBs in North and South 24 Parganas Districts

It may kindly be recalled that out of 186 Movable Compactors for which supply orders were issued to M/S HYVA India Pvt. Ltd., six 8.0 cum capacity Compactors were meant for Kalimpong (2 nos.), Kurseong (1 no.) and Mirik (1 no.).

ULBs in the hills including the above three have declined to take these Compactors presumable for reasons of easy movement in the hills. On the other hand representations have been received from some ULBs in North and South 24 Parganas Districts requesting for an additional 8.0 cum Compactor in addition to the 14.0 cum once already supplied to them.

Now, as per decision taken one 8.0 cum Compactor each may be supplied to Baranagar, South Dum Dum, North Dum Dum and Baruipur Municipalities by diverting the supply to Kalimpong, Kurseong and Mirik Municipalities.

If approved, M/S HYVA India Pvt. Ltd. may be requested accordingly as per draft placed in file.

SUDA-161/2016/1389 dt.26.08.2016.

There has since been further request from Dum Dum Municipality for one small Compactor and from Baranagar Municipality for another small Compactor. The matter was discussed in the office Chamber of Secretary on 02.09.2016.

In reference to the above it is hereby informed you that as per memo no:-SUDA-161/2016/1589 Dt. 16.09.2016, 6 nos 8 cum capacity Movable Compactors were redistributed in Baranagar(2 nos), North Dum Dum(1no), South Dum Dum(1 no), Dum Dum(1 no), & Baruipur(1 no) Municipalities i.e. In Zone-I in place of Darjeeling(2 nos), Kalimpong(2 nos), Kurseong(1no), & Mirik(1 no) i.e. In Zone-III.

Now the unit O&M cost of 14 cum capacity Movable Compactor in Zone-I is Rs,16,06,986.00 where as the unit O&M cost of 8 cum capacity Movable Compactor in Zone-III is Rs,29,30,498.00. As the 8 cum capacity Movable Compactor supplied in Zone:-I in place of Zone:-III, therefore the unit O & M cost of 8cum movable Compactor may be considered as proportionate of Zone -I of 14 cum Capacity Movable Compactor.

As approved in NSP-4 and NSP-5 where, as per memo no:-SUDA-161/2016/1589 Dt. 16.09.2016, 6 nos 8 cum capacity Movable Compactors were redistributed in Baranagar(2 no's), North Dum Dum(1no), South Dum Dum(1 no), Dum Dum(1 no), & Baruipur(1 no) Municipalities i.e. In Zone-I in place of Darjeeling(2 nos), Kalimpong(2 no's), Kurseong(1no), & Mirik(1 no) i.e. In Zone-III.

Now the three years O&M cost of 14 cum capacity for one no Movable Compactor in Zone-I is Rs, 16, 06,986.00 where as the three years O&M cost of 8 cum capacity for one no Movable Compactor in Zone-III is Rs, 29, 30,498.00. As the 8 cum capacity Movable Compactor have supplied in Zone:-I in place of Zone:- III, therefore the cost of three years O & M of 8cum capacity of one no movable Compactor have considered as Zone -I of 14 cum Capacity Movable Compactor i.e. Rs, 16, 06,986.00.

- As per Acceptance Cum Work Order No:- SUDA-217/2015/98 Dt.18.01.2016 and SUDA-217/2015/1836 Dt.30.12.2016 the HYVA had supplied 180 no's Movable Garbage Compactor of 14 cum, 6no's Movable Garbage Compactor of 8 cum and 17 no's Hook Loader mounted Truck Chassis to different ULBs.
- As per memo no:-SUDA-161/2016/1589 Dt. 16.09.2016, 6 nos 8 cum capacity Movable Compactors were redistributed to Baranagar(2 nos), North Dum Dum(1no), South Dum Dum(1 no), Dum Dum(1 no), & Baruipur(1 no) Municipalities i.e. In Zone-I in place of Darjeeling(2 nos), Kalimpong(2 nos), Kurseong(1no), & Mirik(1 no) i.e. In Zone-III.
- But the Fund of Central Share and matching State Share have been released to Kalimpong Municipality and Kurseong Municipality of Rs.12,77,664.00 out of Rs. 47,91,242.00 and Rs. 6,38,832.00 out of Rs. 23,95,621.00 respectively.
- As the Movable Compactors have not supplied in Kalimpong and Kurseong Municipalities therefore those Municipalities have to return back the above fund to SUDA.
