**Sub: Proposed Model Cities/Towns for West Bengal on SWM**

For compliance of the direction of the Hon'ble National Green Tribunal vide O.A. No. 606/2018 dated 16.01.2019 [placed at **Flag-A**], it is very much essential to develop some model cities /towns on Solid Waste management so that it can be replicated to other cities/towns of West Bengal.

In this connection, it is being proposed that following cities/towns may be identified to be developed as model cities/towns with regard to effective management and disposal of solid waste. Details of population, wards and Solid Waste Management activities alongwith status of waste processing are placed in the below table for kind perusal.

May kindly recalled N.S.P. -1&2 regarding approval of 11 model cities/ towns of West Bengal on Solid Waste Management

As per direction of Hon'ble National Green Tribunal (NGT), the Chief Secretary to Government of West Bengal appeared before the Hon'ble NGT on 02.04.2019 and subsequently the Hon'ble NGT vide O.A. No.606/2018 dated 02.04.2019 at Clause No. IV (39.II.) Page No. 22 & 23 (Placed in the file), directed that "Atleast three major cities and as many major towns as possible in the State and atleast three Panchayats in every District may be notified on the website within two weeks from today as model/ cities/ towns/ villages which will be made fully complaint within next six months".

It is learnt that the Hon'ble NGT accepted Durgapur MC as a Major city which is having above 5 lakh population and requested to take up another two major cities having above 5 lakh population.

In this connection the details of the remaining five (5) major cities are being placed below for providing necessary direction to select two major cities as model city for SWM:

May kindly recall that the Hon'ble NGT vide O.A. No.606/2018 dated 02.04.2019 at Clause No. IV (39.II.) Page No. 22 & 23 (Placed in the file), directed that "Atleast three major cities and as many major towns as possible in the State and atleast three Panchayats in every District may be notified on the website within two weeks from today as model/ cities/ towns/ villages which will be made fully compliant within next six months".

In this connection, the State Government has already selected Durgapur Municipal Corporation as one of the major cities and ten towns i.e. Rajpur Sonarpur, Haldia, Serampore, Uttarpara-Kotrung, Krishnagar, Rishra, Baidyabati, Jalpaiguri, Kalyani & Baruipur, as major towns to be taken up as model cities/ towns (**approval and details of the towns and cities placed at NSP- 1&2** ).

Now, as per direction of Hon'ble NGT another two major cities need to be selected among Kolkata MC, Howrah MC, Asansol MC, Bidhannagar MC and Siliguri MC (**details may be seen at NSP-3**).

As it would be difficult task to ensure compliance of Solid Waste Management Rules, 2016 in Kolkata MC and Howrah MC within 6 months, hence it is being proposed that rest of the remaining major cities i.e. Asansol MC, Bidhannagar MC and Siliguri MC, may be proposed for model cities alongwith Durgapur Municipal Corporation.
