Subject: Providing primary / secondary collection equipments and vehicles for the use of Rishra and other Municipalities under JAICA.

It may kindly be recalled that the Chairman of Rishra Municipality submitted a letter vide no. 214/VIII Dt.15.05.2019 (Flag-A) to the honorable MIC and requested to provide the additional SWM equipments or to provide funds for the equipments. The honorable MIC has also requested to take a list of additional requirement of SWM equipments of all the municipalities under JAICA.

Accordingly a list is prepared enclosed (Flag-B) herewith for additional requirement of SWM equipments of all the ULBs under JAICA as received from the ULBs.

In this regard this is to mention here that the Rishra, Baidyabati and Uttarpara-Kotrang Municipality has been notified as Model Town by the UD & MA Dept. and all the six Municipalities have already been included in the cluster project and introduced segregation house hold waste at source level in the different wards under this ULB.

Now, for the above noted additional required SWM equipments of Rishra and other five Municipalities, a budgetary estimate or a Quotation is required to submit to assess the amount of each item and in total or the above items are needed to be procured through GEM with suitable specification.

It is also mentioned here that from the above items, House Hold Bins of 54000 nos. for Rishra, 30000 nos. for Baidyabati are under process of procurement by the SUDA.

The above note of the concerned AE may kindly be seen. All the six municipalities, including Rishra, that had been selected for Kolkata Solid Waste Management Improvement Project (KSNMIP) under JICA assistance, in collaboration with Govt. of India, had submitted further their requirement of bins & vehicles for proper management of its municipal solid waste.

It is further to mention that before initialization of the KSNMIP project, a broad assessment was made for all these six municipalities & provided all such vehicles & equipments according to their need five to six year back.

Now, as per present scenario, all these ULBs have submitted their additional requirement of equipment & vehicles for proper management of SWM within their city.

Justification of their claim may be requested from them in near future. But as it is very urgent, especially for the model towns, viz. Uttarpara-Kotnang, Rishra & Baidyabati, we may procure the same, 20% of the total quantity as requested by them in 1st phase, if it is at all needed.
