Sub: Request for extension of time for submission of State Policy and Action Plan on re-use of treated waste water

Sri Prashant Gargava, Member Secretary, Central Pollution Control Board vide file No. A-14011/1/2015-Mon/ UPC-1/876 dated 12.04.2019 (Flag 'A') inform that Action Plan for utilization for treated sewage to be prepared by the all the States and Union Territories to be forwarded to CPCB before 26.02.2019 is still awaited from State of West Bengal, in this regard CPCB will file consolidated reply to Hon'ble NGT before 30.04.2019. And he has requested to submit the same by 20th April, 2019.

In this connection, it is to be mentioned that the State Government in UD&MA Department has constituted a Committee vide Notification No. 37-JS(SM)/UD&MA/2019 dated 16.04.2019 (Flag 'B') for formulation of a draft comprehensive policy for re-use of treated waste water. The first meeting of the committee was held on 17.04.2019, where it was discussed that a sizeable volume of works needs to be done before preparation of the policy and for this several responsibilities have been entrusted amongst the members to collect the documents. It was decided that the 1st draft may be placed before the committee after 6 weeks (29th May, 2019) and for reviewing the progress of work an internal review meeting of this committee will be held on 14th May, 2019. The proceeding of the meeting is placed at Flag 'C' as ready reference.

As collecting all the information, preparation of the policy and the action plan requires minimum two months, hence, it is being proposed that the Additional Chief Secretary, Environment Department, Government of West Bengal may be requested to take up the issue with appropriate authority for providing extension of the time period for submission of the policy and action plan up to 30th June, 2019.
