- Making Bore-Holes of 150 mm to 250 mm dia. by any standard method to any depth below ground level / bed level in all kinds of soil like clay, , silt, sand, stiff clay, mixed soils etc. except rocks (for the purpose of collecting Disturbed & Un disturbed soil samples, conducting Standard Penetration Test at suitable intervals etc.) including preparation and submission of bore-log as per IRC : 75 and 78 and Clause 2400 of Specifications for Road & Bridge Works (5th Revision), Published by IRC
- Laboratory Investigation i) Liquid Limit as per IS 2720 (Part V). ii) Plastic Limit as per IS 2720 (Part V)iii) Grain size analysis by Sieving as per IS 2720 iv) Grain size analysis by Hydrometer Method as per IS 2720 (Part IV).v) Determination of Water Content as per IS 2720 (Part II).vi) Determination of Specific Gravity as per IS 2720 (Part III).ix) Determination of Sand Content as per IS 2720 (Part IV) xiv) Determination of Consolidation Properties as per IS 2720 (Part XIV).xvi) Tri-Axial Shear Test.
