NOTIFICATION

WHEREAS, the State Government in the Department of Urban Development and Municipal Affairs intends to provide new Dwelling Units to the Urban Poor not on individual basis but on cluster approach considering the limitation of availability land by constructing multi-storied Flats and formulated a new scheme named as "Banglar Bari".

WHEREAS, the Operational Guidelines of the scheme has been issued by this Department vide No. 986(125)/MA/C-10/3S-4/2009 (Pt – II) dated 06.11.2017 with concurrence of Finance Department vide their U.O. No. Group R/2017-2018/0158 dated, 08.09.2017 and with the approval of State Cabinet in the 33rd meeting held on 30.10.2017.

AND WHEREAS, State Urban Development Agency (SUDA) has been designated as State Level Nodal Agency (SLNA) for implementation of 'Banglar Bari' in the State.

NOW, THEREFORE, for proper monitoring & implementation of the projects under "Banglar Bari", a committee is hereby constituted called 'Programme Monitoring and Implementation Committee' (PMIC) at the level of SUDA comprising of the following officials:

1. Director, State Urban Development Agency – Chairman & Mission Director
2. Joint Secretary & Additional Mission Director – Member
3. Chief Engineer, Municipal Engineering Directorate - Member
4. Chief Engineer (Housing), Kolkata Metropolitan Development Authority – Member
5. Executive Engineer, Municipal Engineering Directorate (on deputation to SUDA) - Member
6. Deputy Director, State Urban Development Agency as Member Secretary.

The committee will hold review meeting periodically and the progress report will be submitted by SUDA to this Department on regular basis. Necessary action shall be taken up by SUDA for placement of vetted DPRs in the meeting of SLAC of Housing for All as per decision of Department and thereafter placement in the meeting of SLSMC of HFA for consideration and approval as Affordable Housing component under HFA.

This Order will take immediate effect.
