NOTIFICATION

No.3054-ICA-Dated, Kolkata, 24th July, 2001 — In exercise of the power conferred by sub-section (1) of section 3 of the West Bengal Heritage Commission Act, 2001 (West Ben. Act IX of 2001), the Governor is pleased hereby to establish, with effect from the 1st day of August, 2001, a Commission by the name of the West Bengal Heritage Commission (hereinafter referred to as the said Commission) for the purpose of identifying heritage buildings, monuments, precincts and Sites and for measures for their restoration and preservation.
