Sub: Submission of Urban Legacy Data of National Social Assistance Programme (NSAP)

Sir/Madam,

Reference may kindly be made to our memo. No. SUDA-414/2008(Part-IV)/1441 & 1868 dated 19.08.2013 & 22.11.2013 respectively wherein you were requested to submit Urban Legacy Data in soft copy of all the eligible beneficiaries with Bank/Post Office Account Details after proper verification ( by deleting names of the ineligible beneficiaries due to change of status, death, migrated, double entry) to SUDA for the pension schemes under NSAP strictly adhering to the Guidelines on verification. But inspite of repeated request no such soft copy from your municipality has reached this office till date. Since the target group of the scheme is urban poor, you will surely appreciate that they would not get benefit of the scheme until and unless the soft copy is submitted to SUDA from your end and sent to the Panchayat and Rural Development Department. Incidentally it is reiterated that Panchayat and Rural Development Department, Govt. of West Bengal, the Nodal Department of the State for this programme may not be in a position to allocate fund in favour of your ULB until such soft copy is not submitted immediately.

In view of the above you are requested to submit the Legacy Data of eligible beneficiaries as per desired template, a copy of supporting resolution of BOC mentioning number of eligible beneficiaries for each scheme, Universal Coverage Certificate, Certificate of Verification under NSAP to SUDA **latest by 31<sup>st</sup> January, 2014 ( Friday) positively** for onward transmission to P&RD Department.

This may kindly be noted that, under any circumstances whatsoever, the date as fixed in the aforesaid Para for submission of Legacy Data would not be extended further.
