ORDER

Sub: Administrative approval for implementation of various schemes under Development of Municipal Areas(DMA) in respect of Coopers' Camp Notified Area Authority

Necessary fund for the said project as 1st instalment will be released in due course as per availability of fund under Development of Municipal Areas (DMA) under the Head of Account, "2217-05-193-006-35-00-V" subject to submission of requisite documents i.e. E-tender documents, work orders, copy of Comparative Statement downloaded from e-portal , E-tender Certificate etc. by the ULB.
