ORDER

Sub: Administrative approval for implementation of scheme under Development of Municipal Areas(DMA) in respect of Gayeshpur Municipality

The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord administrative approval in respect of 1(One) no. of scheme viz. "Supply, Erection, fitting and fixing of 8 mtr. Octagonal Pole(double arm) & Trident Pole with LED street light and LED Chain light from Gayeshpur Check Post to Manikpir More for beautification work within Gayeshpur Municipality" at an estimated cost of Rs. 3,29,06,000/- (Rupees Three crore twenty nine lakhs six thousand) only in favour of Gayeshpur Municipality under Development of Municipal Areas subject to:-

- a) Strict observation of all relevant Financial Rules and Regulations including E-tender Rules vide Finance Department memo. No. 6932-F(Y) dt. 29.08.2013;
- b) Timely completion of work to avoid escalation of cost;
- c) Non-deviation of allotted fund from approved scheme;
- d) Submission of Utilization Certificate of the fund allotted in due course.

2. Necessary fund for the said project will be released out of Budget Provision of 2018-2019 in due course as per availability of fund under Development of Municipal Areas (DMA) under the Head of Account, "4217-60-051-018-53-00-V" & "4217-60-789-004-53-00-V" subject to submission of requisite documents i.e. E-tender documents, work orders, copy of Comparative Statement etc. by the ULB.

3. This order issues with the approval of the Secretary and with the concurrence of the Financial Advisor of this Department vide U.O. No. 648/UD & MA dt. 28.02.2018.
