Sub: Administrative approval for implementation of scheme under Development of Municipal Areas (DMA) for Beautification & Landscaping work of M.R. Bangur Hospital

Necessary fund as 1st instalment for the said project will be released under Development of Municipal Areas(DMA) under the Head of Account, "4217-60-051-SP-018-53-00-V" within the financial year 2017-2018. 2nd/subsequent instalment will be released subject to submission of requisite documents i.e. E-tender documents, work orders, copy of Comparative Statement etc. by the ULB.
