**ORDER**

**Sub : Administrative Approval for construction of 1<sup>st</sup> floor of Municipal Building of Kandi Municipality.**

The Governor is hereby pleased to accord Administrative Approval for "Construction of 1<sup>st</sup> Floor of Municipal Building of Kandi Municipality" (vide Memo. No. 679/KM/18 dtd. 18.09.2018) at an estimated cost of **Rs. 44,76,000/- (Rupees forty four lakh seventy six thousand) only** under the scheme Construction of Municipal Office Building subject to the following conditions :

- i. Strict observation of all relevant financial Rules and Regulations including E-tender rules vide Finance Department Memo. No. 6932-F(Y) dtd. 29.08.2013.
  - ii. Timely completion of work to avoid escalation of cost and
  - iii. Adherence to the online EMD receipt / refund s per FD Memo. No. 3975-F(Y) dated 28.07.16 read with Memo. No. 2365-F(Y) dated 12.04.18.
3. Necessary fund for the said project will be released in due course under relevant Head of Account as per availability of fund under the scheme Construction of Municipal Office Building subject to submission of requisite documents, i.e., e-tender documents, work order, copy of comparative statement etc. by the ULB. 25% of the total cost in this regard is to be borne by the Municipality from its own fund.
4. This order is issued with the approval of Finance Department, Group 'R' vide U.O.No. Group R/2018-2019/0198 dtd. 10.01.2019.
