**ORDER**

**Sub: Administrative approval for execution of various schemes in connection with Frontage Beautification & Landscaping works in respect of different hospitals within jurisdiction of Urban Local Bodies under Development of Municipal Areas (DMA)**

  - e) Adherence to the online EMD receipt/refund as per FD Memo No. 3975-F(Y) dt. 28.07.16 & No. 2365-F(Y) dt. 12.04.18.

Necessary fund for the said project will be released in due course as per availability of fund under Development of Municipal Areas(DMA) under the Head of Account, "4217-60-191-002-53-00-V" & "4217-60-051-018-53-00-V" subject to submission of requisite documents i.e. E-tender documents, work orders, copy of Comparative Statement downloaded from e-portal, e-tender certificate etc. by the ULB.
