ORDER

Sub:-Administrative approval for Construction of extension of office building at Ward No. 04 of Murshidabad Municipality.

The undersigned is directed by order of the Governor to say that the Governor has been pleased to accord administrative approval for **Construction of extension of office building at ward no. 04. of Murshidabad Municipality.** (Memo No. 558 / MM dt. 18.04.2018) at an estimated cost of Rs. 44,86,925/- (Rupees Forty four lakh eighty six thousand nine hundred twenty five) only under the scheme Construction of Municipal office building subject to the following conditions :

- (a) Strict observation of all relevant Financial Rules and Regulations including e-tender Rules vide Finance Department's Memo No. 6932-F(Y) dt. 29.08.2013.
- (b) Timely completion of work to avoid escalation of cost.
- (c) Non-deviation of allotted fund from approved scheme.
- (d) Submission of Utilization Certificate of the fund allotted in due course.
- (e) Adherence to the online EMD receipt/refund as per FD Memo No. 3975-F(Y) dtd. 28.07.16 read with Memo No. 2365-F(Y) dtd. 12.04.18.

2. Necessary fund for the said project will be released in due course under the Head of Account " 2217-80-001-013-35" as per availability of fund under the scheme Construction of Municipal office building subject to submission of requisite documents i.e e-tender documents, work order, copy of system generated Comparative Statement etc. by the ULB. 25% of the total project cost should be borne by the concerned ULB.

3. This order issues with the approval of the Principal Secretary and concurrence of the Financial Advisor, UD&MA Department vide U.O No.123/UD&MA dt.24.07.2018.
