The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment to the ULBs as noted in the margin a sum of Rs.33,60,000/- (Rupees Thirty three lakh sixty thousand) only as Fixed Grant(1st Installment) for the month of April, 2009 during the year 2009-2010.

Account to utilise this fund to meet up salary obligation of the employees of the ULBs against sanctioned strength from his end in addition to grants for salary and D.A. After meeting the salary obligation, emphasis may be given for particular purposes of liquidation after reconciliation of outstanding Electricity dues on C.E.S.C./W.B.S.E.B., if any.

The charge is debitible to the head, "3604-Compensation and Assignments to Local Bodies and Panchayati Raj Institutions-00-200-Other Miscellaneous Compensation & Assignments-NP-Non-Plan-034-Fixed Grants to the Municipal Corporation and Other Urban Local Bodies-31-Grants-in-Aid-02-Other Grants-V" under Demand No.39/MA in the current year's vote-on-account budget i.e. 2009-2010.

4. The Grant-in-aid sanctioned in para-1 above is for general purpose (Salary or Non-Salary) grant, Utilisation Certificate is to be furnished by ULBs in terms of Note 2 below SR 330A of the Treasury Rules, West Bengal, Volume I. Submission of Utilisation Certificate up to March, 2009 is required for further release of fund.
