Subject: Release of 50% of fund as 2<sup>nd</sup> instalment of Third SFC in favour of Urban Local Bodies for execution of development schemes with grant-in-aid made available as Annual Provision under Third State Finance Commission's Grant for the financial year 2010-2011.

## MEMO

The undersigned is directed, by order of the Governor, to say that the Governor is pleased to sanction payment of a sum of Rs. 10,86,06,000/- (Rupees Ten crore eighty six lakh six thousand) only to the Urban Local Bodies as detailed in the enclosed statement for execution of development schemes as per the Third State Finance Commission's Grant for the financial year 2010-2011.

2. The fund will be utilized by the Urban Local Bodies as per Para 2 of the order issued by the Department vide no. 153(19)/MA/C-10/1G-1/2010 (FS) dated 24.09.2010 read with 165/MA/C-10/1G-1/2010 (FS) dated 30.09.2010 at the time of release of the 1<sup>st</sup> instalment.

3. The District Magistrates concerned are hereby authorized to draw the amount sanctioned herein in T.R. Form No.31 and disburse the same to the concerned Urban Local Bodies by transfer credit to their local fund accounts with the Treasuries concerned.
