Sub : Payment of Grant to the Municipal Corporation and other Urban Local Bodies for Dearness Allowance @ 35% to their employees for the month of July, 2008, with arrear, if any.

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release a sum of Rs.4,64,84,054/- (Rupees Four Crore sixty four lakh eighty four thousand and fifty four) only to the Urban Local Bodies as stated against each in the enclosed statement as grants for payment of Dearness Allowance @ 35% to their employees for the month of July, 2008.

2. The Grants-in-aid sanctioned herein above will be drawn by the concerned District Magistrate who will disburse the same to the Urban Local Bodies in his jurisdiction by transfer credit through Local Fund Account to the concerned Urban Local Bodies.

3. The charge is debitible to the head, "2217-Urban Development-05-Other Urban Development Schemes-191-Assistance to Municipal Corporations-NP-Non-Plan-020-Dearness Concession to the Employees of Municipal Corporation and Other Urban Local Bodies in K.M.D.A. & Non-K.M.D.A., Area-31-Grants-in-aid-01-Salary Grants-V" under Demand No.39/MA" in the current year's Budget (2008-2009).

4. The Utilisation Certificate in respect of the grants to be drawn by the Municipal Corporation and other Urban Local Bodies should be furnished in the prescribed form direct to the Principal Accountant General (A&E), West Bengal, with a copy to this Department as soon as the amount is drawn and utilised, submission of Utilisation Certificate up to June, 2008 must be necessary for release of further fund.

5. The Principal Accountant General (A&E), West Bengal and others concerned are being informed.

6. This order issues in exercise of the powers delegated under Finance Department Memo.No.850-FB dated 31.07.2008.
