**ORDER**

In partial modification of this Department's G.O. No. 246(Sanction)/MA/P/C-10/3S-26/2012 dated 05.11.2012, the undersigned is directed by order of the Governor to say that the Governor has been pleased to substitute the followings:-

1. The amount mentioned against the head of account "2217-Urban Development-05-Other Urban Development Schemes-796-Tribal Areas Sub Plan-SP-State Plan (Annual Plan and XI/XIIth Plan)-013- West Bengal Urban Employment Scheme – 31 - Grants-in-aid – GENERAL – 02 -Other Grants – V – Voted" at para (iii) of Column 2 under Sl. No. 13 of the aforesaid G.O. shall be read as Rs. 37,36,000/- instead of Rs. 37,36,500/-.
2. The amount stated against Head of Account Code "2217-05-796-SP-013-31-02-V" at column 2 under Sl. No. 14 shall be read as Rs. 37,36,000/- instead of Rs. 37.36000/-.
3. Name of the Treasury stated at Column 4 under Sl. No. 10 of the enclosed STATEMENT of the aforesaid G.O. against Dum Dum, PO-Dum Dum, Dt-North 24 Pgs shall be read as Barrackpore instead of Barasat.
4. In the table of the first endorsement of the aforesaid G.O., "Appropriation under the head involved in the sanction" as stated in column 2 of the table and "Balance" as mentioned in column 4 of the table under Head of Account 2217-05-192-SP-016-31-02-V shall be read as 90,11,00,000 and 55,57,23,000 respectively instead of 95,01,38,000 and 60,47,61,000. Similarly, in the table of the first endorsement of the aforesaid G.O., "Progressive total of expenditure during the year under the said head including the expenditure now sanctioned" as stated in column 3 of the table and "Balance" as mentioned in column 4 of the table under Head of Account "2217-05-789-SP-025-31-02-V" shall be read as 15,87,61,500 and 28,12,38,500 respectively instead of 14,87,61,500 and 29,12,38,500. The total figure in column 1, 2 and 3 of the aforesaid table shall be read as 146,11,00,000, 54,74,37,000 & 91,36,63,000 respectively instead of 1,51,01,38,000, 53,74,37,000 and 97,27,01,000.
