Sub: Release of Grant on account of Taxes on Vehicles to Howrah Municipal Corporation for the year 2011-12 for emergent Road repairs (1st Instalment).

The undersigned is directed by order of the Governor to say that the Governor is hereby pleased to sanction and release for payment of a sum of Rs. 57,60,000/- (Rupees Fifty seven lakhs sixty thousand) only as grant on account of Taxes on Vehicles for emergent Road repairs/ maintenance to the Howrah Municipal Corporation during the year 2011-2012 (1st instalment).

2. The grant sanctioned above will be drawn by the Commissioner, Howrah Municipal Corporation in T.R. Form No. 31 after it is duly countersigned by the District Magistrate, Howrah.

3. The charge is debitible to the head, "3604-Compensation & Assignment to Local Bodies and Panchayati Raj-Institutions-00-106-Taxes on Vehicles-NP-Non-Plan-002-Grants-in-aid to Municipalities (MA)-31-Grants-in-aid-GENERAL-02-Other Grants-V" under Demand No.39/MA in the current year's vote-on-account budget. i.e. 2011-2012.

4. The Grants-in-Aid sanctioned in para 1 above is a general purpose grant which is released to the Howrah Municipal Corporation for taking up of various maintenance works like repair of roads, riverfront beautification, improvement of footpath, illumination of important places, works for parks and squares etc.

5. Utilisation Certificate is to be furnished by Howrah Municipal Corporation in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal, to the Principal Accountant General (A&E), West Bengal as soon as the grant is drawn and utilised.

6. This order issues in exercise of the powers delegated under Finance Department Memo No. 1530-FB dated 29.07.2011 along with Memo No. 700-FB dated 31.03.2011.

7. The Principal Accountant (A&E), West Bengal and other are being informed.


