**Sub: Payment of Grant on account of Taxes on Vehicles to the Municipal Corporations and other Urban Local Bodies during the year 2011-12 for emergent Road repairs (1<sup>st</sup> instalment).**

The undersigned is directed by order of the Governor to say that the Governor is pleased to sanction and release for payment on Adhoc basis to the Municipal Corporations and other Urban Local Bodies a sum of Rs. 7,99,14,000/- (Rupees Seven Crore ninety lakhs fourteen thousand) only as per enclosed statement as grant during the year 2011-2012 on account of Taxes on Vehicles as 1<sup>st</sup> instalment for emergent Road repairs / maintenance.

2. The District magistrate is hereby authorised to draw the amount sanctioned above and disburse the same by transfer credit through L.F. A/C of the concerned Urban Local Bodies.
3. The charge is debitible to the head, "3604-Compensation & Assignment to Local Bodies and Panchayati Raj-Institutions-00-106-Taxes on Vehicles-NP-Non-Plan-002-Grants-in-aid to the Municipalities (MA)-31-Grants-in-aid-GENERAL-02-Other Grants-V" under demand No.39/MA in the current years vote-on-account budget. i.e. 2011-2012.
4. The Grants-in-Aid sanctioned above is a general purpose grant which is released to the ULBs for taking up of various maintenance works like repair of roads, riverfront beautification, improvement of footpath, illumination of important places, works for parks and square etc.
5. Utilisation Certificate is to be furnished by Municipalities and the Urban Local Bodies in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal, Volume-I, to The Principal Accountant General (A&E), West Bengal with a copy to this Department as soon as the grant is drawn and utilised.
6. This order issues in exercise of the powers delegated under Finance Department Memo No. 1530-FB dated 29.07.2011 along with Memo No. 700-FB dated 31.03.2011.
7. The Principal Accountant General (A&E), West Bengal and all other concerned are being informed.
