The undersigned is directed by order of the Governor to say that the Governor is hereby pleased to sanction and release for payment of a sum of Rs. 2,40,00,000/- (Rupees two crore forty lakh) only to the D.D.O. Kolkata Municipal Corporation as grant in lieu of taxes realised on Trades, professions and callings to the Kolkata Municipal Corporation for the year of 2011 - 12 (1st instalment).

2. The fund sanctioned above will be drawn by the Municipal Commissioner, Kolkata Municipal Corporation in T.R. Form No. 31 and he will deposit it by transfer credit to the Local Fund Account of Kolkata Municipal Corporation under the "8448-00-102-001-Deposit to Local Fund Account" of Kolkata Municipal Corporation. The Municipal Commissioner will also act as DDO for drawal of Grants-in Aid Bills including transfer credit bills in respect of Local Fund Account and the Controller of Municipal Finance and Accounts (C.M.F.A.) will act as the operator of Local Fund Account for signing L.F Cheques from Kolkata Pay & Accounts Office II.

3. The charge is debit to the head, "3604-Compensation & Assignment to Local Bodies and Panchayati Raj-Institutions-00-200-Other Miscellaneous Compensation & Assignment-NP-Non-Plan-021-Grants-in-Aid to Kolkata Municipal Corporation in lieu of taxes realised on Trades, professions and callings-31-Grants-in-Aid-GENERAL-02-other grants-V" under Demand No.39/MA is the current year's vote-on-account budget i.e. 2011-2012.

4. The Grants-in-Aid sanction in para 1 above in a general purpose grant which is released to the Kolkata Municipal Corporation for taking up various maintenance works like repair of roads, riverfront beautification, improvement of footpath, illumination of important places, works for parks and squares etc.

5. Utilisation Certificate is to be furnished by Kolkata Municipal Corporation in terms of Note-2 below SR 330A of the Treasury Rules, West Bengal to the Principal AG (A&E), West Bengal.

6. This order issues in exercise of the powers delegated under Finance Department Memo No. 1530-FB dated 29.07.2011 along with Memo No. 700-FB dated 31.03.2011.
